



#### Who Are the Jaycees?

President Nixon said recently of the Jaycees, "You have a proud history of developing new generations of young leaders in every part of the nation by channeling the energy and enthusiasm of young people into community service." The United States Jaycees is a result of the expansion of a very fundamental, yet valid, idea that young men can become involved in public service. Since its founding in St. Louis, Missouri, in 1920, the Jaycees' growth has been rapid, progressing from a base of 12 chapters and 4,000 members in its first year to over 6,4000 chapters and 300,000 members today.

The history of the organization's first 50 years is a combination of man's interaction with his fellow man, his family, and his community, and his ability to react to his environment as a leader. A past president of the organization has aptly stated, "the Jaycees is an action organization with the purpose and object of building leadership through community development. We do not try to build communities. We build men, and men build communities, states and the nation."

The growth of the United States Jaycees has paralleled the progress of America toward the elevation of mankind. Always striving for relevance, the Jaycee movement personified man's service to his fellow man. With growth came confidence and responsibility. Now the concepts which founded the organization have become reality. The following examples are indicative of their accomplishments during the past five years:

- Generated \$100,000,000 in housing, employment, education, and food programs for the underpriviledged.
- Directed the equivalent of \$47,000,000 to the area of Mental Health / Mental Retardation.
- Organized mass immunization clinics and amblyopia screening reaching over 20,000,000 children.
- Invested over \$700,000 to upgrade local emergency medical services.
- Mobilized over half a million volunteers to serve the needs of their communities.
- 6. Reached more than 5,000,000 youths aged 8 to 18 through recreation and sports programs.

 Chartered 125 institutional chapters in state and federal penitentiaries.

Jaycees offer leadership training through community development for young men. The Jaycees is designed specifically to meet the needs of the young man seeking to make his place in his community.

In working toward these goals, every young man's offered the opportunities of a voice in community affairs, a practical leadership development course, the chance to try new ideas and improve old ones, and social contact with other young men.

Here are the main reasons why young men join the Jaycees. The desire for selfimprovement - to learn how to accept responsibility, to make decisions, become effective speakers, learn management techniques, to be better employers, emplovees and citizens. The desire for community improvement - to have a hand in searching out community ills and then to plan and execute constructive action projects to remedy them. The desire for fellowship - to meet progressive young people in their own age bracket, with similar interests - similar goals. The friendships made are not confined solely to the local community, but extend nationally and internationally as well.


Born on a farm in Ottawa County, hio, Brother Markley graduated from liami University, Oxford, Ohio, in 1938, nd was the winner of the Delta Sigma i Scholarship Key. Shortly after raduation, he joined the Timken Comany as an accountant trainee. Two ears later, he was promoted to ssistant Chief Cost Accountant and ontinued in that position until entering he Army in 1943 to serve for over two ears in the Military Intelligence Service the European Theater.

Upon return to the Company in 1946, fter military service, he served as Executive Assistant in charge of legal affairs. He was elected Assistant Secretary in 1947, and Secretary in 1953. He was then successively named Assistant to the President, Vice President, Executive Vice President, a Director, and President of the Timken Company.


A member of the Bar of Ohio, he studied at the William McKinley School of Law. He attended the University of Akron and also took courses at Ohio University. He completed the Advanced Management Programs at Harvard University Graduate School of Business Administration and the University of Pennsylvania. He graduated from Miami University in 1938. He was initiated into Delta Sigma Pi in 1937 while at Miami.

The "Deltasig of the Year" award was established in 1947; however, the first award was not made until 1952. The award recognizes the outstanding achievement of a member of the fraternity in his particular field of endeavor, be it business, education or government.

Some of the recent recipients have included Harold S. Hook, president of the United States Life Insurance Company; Daniel J. Haughton, chairman of the Board of Lockheed Aircraft Corporation; Reynold E. Carlson, United States Ambassador to Colombia; Adolph F. Rupp, head basketball coach at the University of Kentucky; Curtis N. Painter, executive vice president of Armstrong Cork Company; and the late Gerald L. Phillipe, chairman of the board of General Electric Company. In all, there have been 20 members of the fraternity who have received this award.


ALPHA MU CHAPTER at the University of North Dakota is busily preparing for the spring banquet and picnic. This should be another huge success.

#### MANKATO STATE




#### PHOENIX

We must also keep in mind that societies normally survive crises because in one way or another proper solutions are found. We should observe that a solution may affect individuals in that society in different ways. We should also observe that every rule has exceptions, and civilizations have come to an end. They have not always survived, and it can happen again, I suppose.

Today, however, I want to talk about a development which may be a crisis. Some people think it is. I prefer to believe it is no more than a very serious problem which we can solve. That problem is the failure of the economic machine in this country to improve its productivity at a rate sufficiently good to be competitive in the world.

As usual, when we face adversity we see evidences of panic. This isn't new. History records some real cliff hangers because everyone tries to treat the symptoms rather than the cause. So today, because we have some economic downturn, there are those who blame it on our failure to treat our ecology with respect. Others say we are too materialistic. Others blame the younger generation, or the older generation, or poverty, or our give-away programs, or the absence of them. Still others blame discrimination or too little education, or too much. Take your choice. Do your own thing. However, there is one thing people agree on and that is business is to blame. Except businessmen, that is. Critics have even said business has to go. These are the folks on whom the Wall Street Journal had a report a few months ago. These people acquired a patch of ground in New England, grow their own food, make the simple clothes they want, gave up cars, electricity, and society. This is fine, of course, because we live in a society which allows this; but can you imagine 200-million people living this way today in the United States, each with his own patch of ground, his own sheep, his own cow, his own mule, his own outhouse.

The world is not going to stop so we can get off. Business and industry are here—they are going to stay. But to survive as free enterprise, we must improve our productivity.

### **Challenge** Ahead


Herbert E. Markley Alpha Upsilon Chapter, Miami University

The following is the text of an address delivered by Brother Herbert Markley, president of the Timken Company, on being honored as the "Deltasig of the Year 1971." The presentation was made at a luncheon in his honor at the Heritage Room of the University Center at Miami University, Oxford, Ohio, on January 22, 1972.

Let's examine a few basics. First, if we leave agriculture out of this discussion as a special case, we have producing industries and service industries. Before I go on, I don't want to offend my farmer friends. They have increased their productivity at a rate which puts everyone else to shame. But let's go on. Producing industries are manufacturing, construction, and mining. All other activities are part of the service industries.

Second, let us remember that twothirds of all employment today is in the service industries. And that by the end of the decade, it is estimated that threefourths of all employed people will be in service industries. Think about that a little. Can we operate an economy in which only twenty-five per cent of our people are producing? Third, our growth in productivity in the producing industries is pretty sad, about two per cent per year in the past three or four years. And our service industries, to the extent we can measure them, have shown negative growth. Result: since the 1950's, 20 other countries—led by Japan at 14.2 per cent annually—have surpassed the United States in average growth rate.

Fourth, we need to recognize that productivity is vital to survival; that increases in the rate of output per manhour lower the unit cost of production—be it a unit of service or a unit of goods; that lower unit costs make us more competitive; that the more competitive we are the more goods we can sell and the better we can meet the social needs of our society.

It seems appropriate that Delta Sigma Pi, a fraternity for business students—a fraternity counting among its members leaders in industry—should lead in making clear to the public how absolutely necessary business is. Its members should also be the leaders in fixing whatever is wrong with business.

Perhaps we should reaffirm the purpose of our fraternity, which is to foster the study of business in universities; to encourage scholarship, social activity and the association of students for their mutual advancement by research and practice; to promote closer affiliation between the commercial world and students of commerce; and to further a high standard of commercial ethics and culture and the civic and commercial welfare of the community.

As you graduate from this institution, or our Delta Sigma Pi brothers graduate from other institutions across this land, they will be taking places in industry and business. They have indicated some interest in this part of our society, or they wouldn't be studying business. They will be in excellent positions to influence in some way—some of them in substantial ways—the impact and image that business has on this society.

Let's start with a superficial examination of what is wrong today. First, we have lived since World War II in a period of affluence. For most Americans, the basic needs of life have been met, and there is a surplus. Even those who are said statistically to be at the poverty level-compared to pre-World War II-are living well. This is not to say they shouldn't live better. I am merely stating a reality. With this affluence comes a capacity to learn how to enjoy even more of it. This developed an appetite which became larger than the system could support. Some politicians, some people who like to make trouble simply to have trouble, and sincere folks who thought there can be a better life than that represented by two 400horsepower automobiles in the driveway began to preach dissatisfaction. These shakers, as I call them, built dreams in the minds of people which gave rise to levels of expectation which are not easily achieved. They can be, though, but not by the shakers. The shakers promise only on the basis that someone else will pay for it. Who? Well, business.

The few people who operate business are not important when counting votes, so politicians pointed the way. Blame business for what you don't get. Try to get business to pay for it.

So now we need the movers. The shakers are not enough. It takes people who can act; people who can implement whatever is good in some of the ideas that are put forth. This is where you come into the scheme because you have the intelligence and will have the experience to sift the good from the impractical and make it work.

In my view, there are several things that should be done to promote the image of business. What are they?

1. We must be sure that everyone understands that no one can even exist unless there is production, and production means there must be industry and business. This is a truth which is so simple that even a child should be able to understand it. Yet I am appalled that a thought so basic doesn't seem to be in the minds of our intellectuals who decry the place which business occupies in our society.

2. We must spell out the realities of business in ways that the public can understand. Even those who work in industry don't understand it. For instance, there is a the myth that huge profits are made by industry when we know, in fact, that this isn't so. Just recently, the Opinion Research organization asked people this question: "Just as a rough guess, what per cent profit on each dollar of sales do you think the average manufacturer makes after taxes?" The median percentage estimate given by the people covered in the survey was 28 per cent. I am sure you know that the correct answer is about 4 per cent of sales in 1970, and it has never been as high as 6 per cent since 1950. Is it any wonder that people find it easy to blame business when they don't understand even so basic a thing about it?

Well, part of it is because there are four broad groups of people in the world. They are business people, union leaders, educators, and politicians. I am sure you will agree that union leaders, educators, and politicians are all articulate. Business leaders are not. To be a leader in three of these groups, the ability to speak clearly and forcefully is an absolute requirement. It is an inherent part of the job description. A business leader, on the other hand, is not chosen for this quality. He is chosen because he can get things done. He can make things. He can run a business. Yet, somehow, someway, we must be able to explain the realities of business.

3. We must explain that profit is essential to our economic system. We know there are other societies where profit is not required, nor does it exist; but none of these societies has provided the kind of lives that our society has in any respect—in culture, in education, in freedom, in material things.

4. We must stop taking a defensive attitude. Why do we apologize? Why are we timid? Why do we allow our detractors to blame business for everything bad or alleged to be so and not offer a rebuttal?

5. We must lead. Let's not wait until we are forced by the will of the people working through government to do what we should have been doing on our own. I was at the Harvard Business School for a few months 20 years ago. We had a professor who taught a course called "Business and Society." The first couple of lectures, I think most of us came to the conclusion that we had an ultraliberal professor. We ended the course believing he was the greatest teacher we had ever known. He was not advocating that government do all of the things in our communities that it is, in fact, now doing. He was merely saying these things would be done and that we, as businessmen, would provide the needs of society or, failing to do so, government would. He was 100 per cent right.

For that reason, I think one might foresee that 20 years from now government will be doing everything. I am surprised, for instance, that in the last 12 months elements of a police state are coming through so loud and clear. I am wondering where current developments will lead unless business is able to project itself more affirmatively.

If I might digress just a minute, I would remind you that business today is being required to furnish data which allows any person with an anti-attitude toward business to virtually cripple that business. I would remind you that the new safety law, for one, enables an inspector to close down a plant without necessarily having anything more to go on than a violation of one of the thousands of regulations which, at least today, cannot be met no matter how much we might try. I think, had we taken the initiative in industrial safety. we could have prevented any legislation of this type being passed at all.

I don't believe that Ralph Nader is the darling of industry, and there is no question that he is using his prominence in the public eye to castigate business in every way he can. I do think, however, we would be less than honest if we didn't admit that there is some truth in what he has put forth. Again, we might have prevented the popularity of Nader and his ideas had we been leading rather than waiting to be pushed into a position by outside forces.

6. I think we need to take an active part in our communities. Young people are asking for challenges, asking for opportunities to serve in their local communities in order to solve social problems. I don't know of any company which doesn't give support to its employees who wish to participate in such activities. I know certainly we do and have done so for many years. Not only do we support, but we encourage. At times, our people are almost ordered to participate in working on social problems. So I would say you have wonderful opportunities from within business to work on social problems and to do a great deal toward accomplishing the results that apparently everyone wants.

7. We must learn more about productivity. Just a few days ago, Dr. Gordon Bloom from MIT was visiting with me in my office. He is an authority on productivity. He is leading an effort at MIT to make it the foremost educational institution in the United States on productivity, and one thing becomes apparent. We know very little about it. We all say that it means an increase in the amount of goods produced per man-hour. This is, of course, true. But we need to know how to accomplish this, how to measure it, and how to determine just where the productivity gets its start because one can observe that the efforts put forth in one department of a company, for instance, show up as the benefits in another or that efforts made by one company show up in benefits of another. So, if one is only looking at results, the causes are not very carefully delineated.

8. I think we need to examine all of the problems that exist and in which business must, of necessity, be involved and solve those problems as quickly as we can so that we can begin working on the problems of tomorrow and not those of yesterday. Within the last year, we came to the conclusion in some parts of our operations that we were spending too much energy and time solving the problems that occurred yesterday and not enough on dealing with the ones that were coming along tomorrow and dealing with them in a way to provide solutions before they are needed.

9. It is my understanding that Delta Sigma Pi and the National Association of Manufacturers are moving toward a working relationship which can improve the understanding of business in our land. The opportunity to bring to the NAM the young and brilliant aggressiveness of Delta Sigma Pi members and the opportunity for NAM to share the experience and wisdom of its members with you should and will produce results that are tremendous. I couldn't be happier.

our society. This is where I think young people in business-members of Delta Sigma Pi-can do so much in this society to make it better. In business, you will get at least two rewards. The first is material. It will be as great as you want to make it. If you are persuaded by material rewards, you will certainly enjoy the satisfaction of approaching a challenge and successfully meeting it. If I in any way read correctly the attitude today, it is that we are working more and more for satisfactions, and I can assure you that participating in business and putting it on a respectable pedestal will, indeed, provide that satisfaction.
