AUGUST, 1981. PATCO strike, recession, re-elected Grand President. Grand Chapter Congress is smoothest ever. Biggest challenge facing the fraternity: mental hazing.

NOVEMBER, 1981. Our 200th chapter installed in Springfield, Missouri. Rapidly running out of Greek letters. Also starting to run out of steam. First noticed gray hair in my beard.

FEBRUARY, 1982. Executive Committee recommends that 19 chapters be placed on

probation; Grand President regretfully accepts recommendation, immediately books flight for the Falkland Islands.

JUNE, 1982. The DELTA-SIG wins top honors at annual meeting of College Fraternity Editors Association.

JUNE, 1982. Computer system installed at The Central Office. Loss of CEI points can now be blamed on a machine.

NOVEMBER, 1982. Diamond Anniversary celebrated by 300 in Cincinnati and Oxford. Our Four Founders would have been proud. We've come a long way, baby!

JANUARY, 1983. Grand President discovers birth certificate. Finds out he is really 83 years old, should be in a rest home. Goes back to bed.

APRIL, 1983. Multi-million dollar fund raising campaign launched by fraternity and Educational Foundation. More grants, scholarships, leadership seminars planned for the future.

MAY, 1983. My last article. Biggest challenge facing the fraternity: finances. This is where I came in. Thanks for the opportunity—and thanks for the memories.



For the 34th time in its history of over 75 years, the fraternal family of Delta Sigma Pi will gather during August 14-18, 1983 for the Grand Chapter Congress. This 34th edition of the meeting of The Grand Chapter of the fraternity promises to be one of its best with an offering of a dozen collegiate leadership seminars, several interesting and exciting tour options and the election of national leaders of the fraternity including Provincial Vice Presidents, four newly created positions on the Board of Directors.

For the first time since 1953, the picturesque city of Denver will serve as convention site. The Den-

This 34th edition of the meeting of The Grand Chapter of the fraternity promises to be one over Marriott Hotel Southeast, 15 miles southeast of downtown Denver will be the location of the event of the biennium. In this issue are a summary of the convention program, an advance registration form and information on costs.

As conventioneers arrive on Sunday, August 14, 1983, they will check into the quad-towered Marriott. With its Western motiff, the Marriott is a relaxing, casual hotel with the Rockies serving as a backdrop on the West side. Neatly appointed rooms, attentive service, free parking and outdoor and indoor pools are features of the hotel making it an enjoyable and reasonably

priced convention center.

Within the Marriott, several food and entertainment options can be found. The Chaparral Restaurant offers candlelight dining in a casual atmosphere and serves a variety of beef and seafood specialities. On the more informal side, the Fairfield Innoffers breakfast, lunch and dinner. For quiet cocktails with a spectacular view of the Rockies is the Lobby Tavern and, for after-dinner dancing, there's the King's Wharf Lounge. Nearby the hotel are a variety of dining and entertainment facilities.

CONVENTION PROGRAM

A summary of the Official Convention Program appears in this issue. The 34th Grand Chapter Congress officially opens on August 14 with Registration opening at 10:00 A.M. and continuing until 5:00 P.M. Convention attendees will want to arrive during this time period in order to pick up convention registration materials, relax before the evening events and check into their hotel rooms after 3:00 P.M. At 6:00 P.M., the Grand President's Reception will give everyone the chance to meet the members of the Board of Directors, The Central Office Staff and other convention attendees. The Dance at 9:00 P.M. in the Grand Ballroom will provide a very entertaining evening of live entertain-

The business of the convention begins on Monday at 9:00 A.M. with the Opening Business Session. Setting the tone for the convention will be the Keynote Address presented by Joe Batten, renowned motivational speaker and an honorary member of Delta Sigma Pi. The Opening Business Session will also include a State of the Fraternity Address by the Grand President, the report of the Committee on Nominations and other reports and opening business. At noon, the Awards Luncheon will recognize the Honor Roll Chapters, the Most Outstanding Chapter, the Most Improved Chapter, the collegiate and alumni chapters with the most outstanding program of community service and will include other special awards and recognitions.

Central City

Educational Seminars will be conducted for both collegiate and alumni members and for national officers on both Monday and Tuesday, August 15 and 16. A wide variety of seminars will be available. Early registrants will have the best selection of seminar options and will be pre-registered for their seminars on The Central Office computer system. While collegiate members and national officers meet, Tuesday afternoon will be free for alumni after the conclusion of the Delta Sigma Pi **Educational Foundation Meeting** and the alumni seminar on Tuesday morning. Alumni members may choose to participate in a bus trip to Colorado Springs and the Flying W-Ranch. Tuesday evening is free for all participants to enjoy Denver; however, an optional Deltasig bus trip to the Flying W Ranch near Colorado Springs for a Chuckwagon Dinner and an evening of Western entertainment is available.

On Wednesday, August 17, the. Legislative Business Session will be held and, after lunch, will be followed by the Meet the Candidates Forum for meeting the nominees for all of the positions on the Board of Directors to be elected. The inspirational and moving initiation of the National Honorary Member will be held later on Wednesday afternoon. On Wednesday evening, the Grand Ballroom will be the site of the high-. light of the convention, the elegant Grand Chapter Congress Banquet with an address by the newly-initiated National Honorary Member.

The Election Session of the convention will commence on the morning of Thursday, August 18. National Officers for the 1983-85 biennium including the Grand President, the Director of Alumni Activities, the Provincial Vice Presidents and the Regional Directors will be elected. The new Board of Directors will be installed and the newly elected Grand President will conclude the business of the 34th Grand Chapter Congress.






