This 34th meeting of the Grand Chapter of Delta Sigma Pi was officially called to order on August 15, but the convention activities actually began on Sunday, August 14, with Registration. Beginning at 10:00 A.M. and continuing throughout the day, Deltasigs and their families and friends arrived at the Marriott and were greeted by members of the Board of Directors.

All convention participants had the opportunity to meet the National Officers and each other during the Grand President's Reception on Sunday evening. After dinner, the Grand Chapter Congress Dance was held and the Yellow Dog and Pink Poodle initiations were held.

On the morning of August 15, the Opening Business Session of the 34th Grand Chapter Congress commenced with the Invocation delivered by Past Grand President Kenneth B. White. Grand President Michael R. Mallonee then welcomed the attendees to Denver and to the convention and called North Central Regional Director Marc P. Franson



to the podium, who introduced Keynote Speaker Joe Batten, internationally recognized author and speaker in the field of management and an Honorary Member of Alpha Iota Chapter at Drake University.

Chapter Congress

Following the Keynote Address, Grand President Mallonee introduced the Board of Directors, members of the Golden Council (Past National Officers and Central Office staff members), members of the Order of the Golden Helmet and the District Directors. Special convention guests also recognized were Bob and Ina Mallonee, the parents of Mike Mallonee, and representatives of Alpha Beta Delta Colony at Bellarmine College in Louisville, Kentucky, Tau Delta Gamma Colony at North Central College in Naperville, Illinois, and Alpha Beta Pi Colony at Purdue University in West Lafayette, Indiana.

Executive Director Mike Mazur introduced the members of The Central Office Executive Staff, including Assistant Executive Director Michael T. Walsh, Director of Chap-

ter Operations Mark A. Roberts and Chapter Consultants John W. Belke II and Richard M. Garber.

Intermountain Regional Director Bill Leonard served as Constitution and Bylaws Parliamentarian. District Director Mike Moegenburg served as Chancellor and Golden Council member Frank Busch served as Resolution Counselor. Executive Director Mike Mazur and Assistant Executive Director Mike Walsh served as secretaries and recorders for the convention. Mike Mazur called the Roll of the Grand Chapter and, when completed, there were 159 delegates representing 122 collegiate chapters and 37 Alumni chapters.

The National Awards Luncheon was held on Monday afternoon. Chapter Efficiency Index Honor Roll Certificates were presented to 26 collegiate chapters by Director of Chapter Operations Mark A. Roberts and Assistant Executive Director Mike Walsh. The presentation to Gamma Omega Chapter at Arizona State University and to Alpha Beta Chapter at Missouri-Columbia were most significant as these chapters had received 100,000 points in the Chapter Efficiency Index for 27 and 43 consecutive years, respectively. Central Regional Director John V. Henik was presented with a special award for having the region with the highest average in the 1982-83 Chapter Efficiency Index. John's 10 chapters achieved an average of 89,675 points.


Executive Director Mazur then was called to the podium to present the National Chapter Advisor of the Year Award to Dr. Paul F. Petersen, Advisor of Kappa Tau Chapter at Clemson University. Alan Lane, delegate of Kappa Tau Chapter, accepted this award for Dr. Petersen and described the outstanding work which he has done with the chapter as their advisor. Following these remarks, Southeastern Regional Director Dean Ferguson presented to Stephen Jones, the District Director of the Year Award in recognition of Stephen's exemplary service as a District Director during the 1982-83 year.

The Most Improved Chapter Award was presented by Mideastern Regional Director Mickey Johnson to Mu Chapter at Georgetown University. In making the presentation, Mickey noted the members of Mu Chapter reversed an almost impossible situation in the course of the past year; had achieved nearly a 600% increase in new initiates and achieved 100,000 points in the Chapter Efficiency Index.

Director of Alumni Activities Dick Parnitzke presented the Alum-

ni Chapter National Community Service Award to the Tucson-Old Pueblo Alumni Chapter and the Most Outstanding Alumni Chapter Award to the New Orleans-Crescent City Alumni Chapter. The Collegiate Chapter National Community Service Award was enthusiastically presented to Theta Kappa Chapter at the University of Akron by East Central Regional Director Jeff Nelson.

The highlight of the national awards for collegiate chapters was the presentation of the Most Outstanding Chapter Award to Iota Pi Chapter at San Diego State University. Western Regional Director Skip Loomis presented this award to the chapter and outlined their numerous accomplishments. Undergraduate of the Year-1983 Linda S. Alcheh of Zeta Psi Chapter at the State University of New York-Albany addressed the members assembled after presentation, by Mike Mallonee, of a plaque in recognition of her selection as Undergraduate of the Year-1983. Linda expressed her thanks on her selection and pledged to serve Delta Sigma Pi at her best as a member of the Board of Directors and the National Executive Committee.

During the day on Monday, spouses, guests and several alumni members toured the mountain communities of Central City and Georgetown and enjoyed lunch at the Silver Queen Restaurant and Wine Celler in Georgetown.

After lunch, the Opening Business Session continued with the Report of the Grand President delivered by Grand President Mallonee. In this report he highlighted the 11 goals which had been established by the 1981-83 Board of Directors at their meeting after the 33rd Grand Chapter Congress. Mike indicated that nearly all of these goals had been reached through the dedicated efforts of volunteers and staff members. Chancellor Moegenburg then called on Past Grand President Tom Mocella to deliver the report of the




The 34th Grand Chapter Congress offered members the opportunity to attend more leadership seminars than ever before.

Through computer assisted seminar assignments, all appeared to go smoothly. NATIONAL HONORARY MEMBER KARL FLEMKE

President and Chief Executive Officer of Junior Achievement becomes the fraternity's 20th National Honorary Member

At nearly each Grand Chapter Congress since 1939, one of the highlights has been the Ritualistic initiation of the National Honorary Member. The membership classification of National Honorary Member was created as a means of nationally recognizing outstanding leaders in the business community who are not members of the fraternity.

The 20th National Honorary Member of Delta Sigma Pi is Karl Flemke, President and Chief Executive Officer of Junior Achievement, Inc., headquartered in Stamford, Connecticut.

Born in Wethersfield, Connecticut, in 1931, Mr. Flemke graduated from the University of Pittsburgh. He began his JA career in 1958 as Executive Director of the JA program in New Bedford, Massachusetts. During his tenure in New Bedford, Mr. Flemke expanded the JA program in that community until it ranked number one nationally in the number of Achievers per thousand population. The New Bedford Junior Chamber of Commerce voted Mr. Flemke "Outstanding Young Man of the Year" in 1960.

In 1962, he was promoted to head Junior Achievement operations in Pittsburgh and, in 1973, he was promoted to the position of Executive Vice President of JA operations in Los Angeles. Twice during his career, Mr. Flemke received the Charles R. Hook Memorial Award, the highest professional honor bestowed upon a Junior Achievement executive. In 1980, he was promoted to Executive Vice President of the International Junior Achievement organization headquartered in Stamford and, in July, 1982, was named President and Chief Executive Officer of Junior Achievement, Inc.

It is particularly fitting that Karl Flemke was initiated as National Honorary Member at ceremonies on August 17, 1983, at the Denver Marriott Hotel Southeast, as Junior Achievement has been adopted as the National Community Service Project of Delta Sigma Pi. As this article is being written, Grand President Parnitzke and Executive Director Mazur are finalizing plans to meet with Brother Flemke and his associates in Stamford in order to finalize the operating details of our relationship. In the next issue of The DELTASIG a feature on Junior Achievement will appear; meanwhile, please learn about the Brother of Delta Sigma Pi leading this organization through his remarks delivered at the Grand Chapter Congress Banquet which follow:

I appreciate the opportunity to be with you here today, to be able to meet many of you and I'm especially pleased to be here tonight to accept your kind offer to become an Honorary Member in the International Fraternity of Delta Sigma Pi. I am personally honored to become a part of your Brotherhood, but feel that it is also appropriate to accept this accolade on behalf of the entire Junior Achievement Organization which I represent.

The more I learn about your fraternity the more I am convinced that we can build a successful partnership for the mutual benefit of both our organizations and, in doing so, make a much greater impact together than either of us could do alone. I know that one of the goals of your fraternity is the advancement of the business community. And Junior Achievement believes that this advancement is heavily dependent on proper education-education not only from the classroom and books, but education that is provided through actual experiences and the "learn by doing" method. And so our purpose, supportive to yours, is to provide this practical and realistic education and experience in the private enterprise economic system.

You have taken the first step toward this partnership by adopting Junior Achievement as your National Community Service Project for this upcoming year. For this I want to thank you. Your decision provides both of us with a real opportunity. We at JA are very honored to be involved with such an elite professional business fraternity as yourselves. And I must add successful, too, you having generated membership of over 100,000 in over 200 locations. By blending the history and accomplishments of your fraternity since its inception in 1907 with that of JA since our founding in 1919, we should be able to help make a difference in the way people think about business, economics and entrepreneurship.

There was never a greater need than there is today to accomplish this objective. I am sure you are all aware of the confusion that exists in the public's mind about how businesses operate and why they must operate in a free enterprise system.

More importantly, I don't feel that there is a great deal of empathy for the tremendous challenges that businessmen and women face every day. It seems that every time you pick up the Wall Street Journal, New York Times or any newspaper, there is another story on another survey supporting the fact that the public does have many misconceptions about business. The most recent Gallup Survey on this issue reported that business, and particularly "big" business suffers from a "continuing negative image". They state: "Concurrent with strong antibusiness attitudes among students is a startling lack of knowledge and understanding of the private enterprise system. For example, students and the populace as a whole grossly overestimate the profits made by a typical large national corporation, show little knowledge of the high costs of labor . . . and grossly underestimate the federal income taxes paid by corporations." Interestingly, one suggestion for improvement was: "Business people should help present the case for the free enterprise system to students."

Recently, the National Task Force on Education for Economic Growth was formed. It consisted of 41 governors, corporate leaders and other prominent figures. The article in which the New York Times reported their findings was entitled, "Study Says Weaknesses of Schools Pose an Economic Threat to U.S.". This is a pretty direct statement of their concern which should be all of ours. Now I can understand some of the difficulties that the schools face, so I am not here to place any blame, but rather I mention this Task Force because some of the solutions they recommend are appropriate for both Delta Sigma Pi and JA. The two most appropriate are: 1) Re-examination of lifetime tenure for teachers and modification of state certification rules to allow "qualified persons" from business and elsewhere to teach in public schools . . . and 2) more effective "partnerships" between industry and the public schools. The schools need help and our two organizations are positioned perfectly to implement these solutions. In fact, this is just what Junior Achievement has been doing for the past sixty years, and what you have agreed to become a part of this evening.

This past year, JA involved over one half a million students in our five primary programs. And I know these past few days some of you heard more about these programs from Phil Cofield, our Director of Operations, Western Region: Business Basics, a program introducing the concepts of how a business operates to fifth and sixth graders; Project Business, which develops teamwork between an experienced businessperson and a teacher to bring practical economics to eighth and ninth graders, also introducing different career choices to these students; our traditional JA after school program which allows High School students an opportunity to own and operate their own miniature corporation, with the assistance from adult business advisors; Applied Management, where college students like some of yourselves, assist the business adviser teams in consulting to these miniature companies; and finally, Applied Economics, probably our most exciting program, is a comprehensive, inschool, broad economics course to be offered to High School juniors and seniors-it combines the tried and true methods employed in our school hands-on program, with the latest computer technology, management games and again brings an experienced business consultant into the classroom. So we think that we are bringing to our partnership five strong, quality programs which can become vehicles through which you can accomplish both your personal and fraternity's objectives. And the end result is that we both are working to help the schools correct the problem of economic illiteracy.

And you can bring to our partnership a number of talents which are naturally inherent within Delta Sigma Pi. Specifically, I want to address Leadership, Volunteerism or that sense of brotherhood in helping others, and maintaining a future oriented vision.

Many of the problems I alluded to earlier exist because we live in such

a rapidly changing country and change always provides new challenges, especially in the area of reeducation. In 1975, Junior Achievement, along with Fortune Magazine, established the National Business Leadership Hall of Fame, where each year at a conference we induct giants and legends from the business community to honor their accomplishments and achievements. These are men and women who have successfully capitalized on the changes of their times and conquered the challenges that came with change. This past year the laureattes included: Leo Baekeland, the father of plastics; John Deere, who developed the first successful steel plow; Edward Harriman, who united the nation with steam engines and rail; Olive Ann Beech. Beechcraft Corporation; Ray Kroch, MacDonalds and Abe Plough, Schering-Plough Corporation.

It was in the spirit of honoring these men and women that Ray Hay, Chairman and CEO, LTV Corporation, stated in his evening address: "Regardless of the magni-

tude of change, or the difficulties of challenges, our future remains secure so long as we have men and women of vision-people instilled with a fierce loyalty to free enterprise and an open society-Individuals who are endowed with the ability to lead vigorously." We, then, need your leadership talents which you have exhibited through Delta Sigma Pi and other individual activities. As you know, leadership is more than talk, it is example and it is the example of your senior achievements that must be displayed to the youth of our country. And obviously JA is one forum for this,. So second to leadership, we need your positive attitude of helping others through volunteerism.

Volunteerism is so important to our country, which is why the President is calling on it to solve some of our social problems. From a business perspective, it is becoming more and more a responsibility, and for business reasons, a responsibility that they have to their stockholders; I would suggest as much a responsibility as returning a dividend. In a recent article by Owen Butler, Chairman, The Procter and Gamble Company, he refers to this position as "serving the enlightened self interest of the shareholders". Specifically he talks about education: "I think every one of us who is involved in a for-profit corporation in the United States not only has a right but also a responsibility to use some of our resources in an effort to strengthen the public education system in the United States. The future of our corporations will depend on the product of that system and working to improve this system clearly serves the enlightened selfinterest of our shareholders."

Obviously, these resources refer to money, but also the most valuable asset—our personal time. Delta Sigma Pi's attitude to volunteerism is clearly evident and by selecting us as your National Community Service Project, I believe you have reinforced the fact that the success of our programs is definitely in the enlightened self interest of both the business and education communities.

Finally, I admire the vision and creativity of your fraternity—a trait

that we also have in Junior Achievement. This positions both of us to meet the challenges we face in implementing our purposes,.

I truly believe that JA and Delta Sigma Pi are in alignment with our philosophies, have common objectives, and have reinforcing strengths to be drawn upon. This, along with the great need to re-educate the general public and youth on business, economics and entrepeneurship, forms the foundation of our partnership. I can commit to you support for your projects from our National office and 160 field operations and I know we can count on your commitment to our programs.

If we can unite our collective resources behind one common thrust for mutual gain, then we can definitely make a difference about how America thinks about business. Our purpose it too important not to.

Again, thank you for your time this evening and I appreciate being able to be an Honorary Member of Delta Sigma Pi.

She plans to pursue her CPA and is currently employed by Arthur Andersen and Company in New York City.

While at SUNY-Albany, Linda was initiated into Zeta Psi Chapter and served in a number of offices including president, vice president for professional activities, secretary and chancellor. She also served as the formal dance co-chairperson and served on the membership committee. She attended Grand Chapter Congresses in both Denver and Mackinac Island and also attended two Eastern Regional Conferences and one area conference. She served as the official delegate for Zeta Psi Chapter at the Grand Chapter Congress on Mackinac Island.

In addition to her work with Zeta Psi Chapter, Linda was also active in other areas at SUNY-Albany. 

Prior to attending Howard University, Noel enlisted in the United State Marine Corps. He currently serves his country as a Sergeant in the Marine Corps Reserve.







As a top business student he received the Vernal H. Carmichael Award from the College of Business.







Although you can't bottle it. the Brotherhood was infectious, and we're sure it has (or will) spread throughout the fraternity.

The National Executive Commit-





Although the state of the economy may have been somewhat depressed during the 1982-83 academic year, Delta Sigma Pi's expansion and reactivation program did not. in any way, experience a recession. Last year, the fraternity installed three new collegiate chapters and reactivated two previously dormant chapters. All of this activity took place during the spring of this year: four installations and reactivations occurred in April alone. We welcome all of the members of these chapters into our Brotherhood and present their success stories to you.

ETA NU CHAPTER BACK AT U.M.S.L.

After a period of inactivity dating from 1974, Eta Nu Chapter was reactivated at the University of Missouri-St. Louis on April 2, 1983. A total of 18 new collegiate members were initiated as the number of active collegiate chapters in the state of Missouri increased to five.

Jeffrey A. Janoski, a collegiate initiate of Iota Nu Chapter at Northeast Missouri State University who transferred to UMSL, initiated the efforts to reactivate Eta Nu Chapter during the fall of 1981. For over a year, Jeff received little

support from the student body for his efforts. He persisted, however, and was rewarded with the formation of Mu Sigma Lambda, a local business fraternity, late in 1982. The group grew in size and fulfilled many of the requirements for the reactivation of the chapter charter during the first few months of this year. By mid-March, the Board of directors voted to accept Mu Sigma Lambda's petition to reactivate the charter of Eta Nu Chapter.

Grand President Michael R. Mallonee served as the Headmaster of the Ritual Team during the reactivation ceremonies on April 2. Also present were District Directors Michael L. Marcotte and Frank J. Weber III: Collegian of the Year-1982 Steven P. Rasche; Director of Chapter Operations Mark A. Roberts; Dr. Donald H. Driemeier, Dean of the School of Business Administration and a charter member of Eta Nu Chapter; and members of Alpha Beta (Missouri-Columbia), Eta Sigma (Southern Illinois) and Iota Nu (Northeast Missouri State) chapters and the St. Louis-Gateway Alumni Chapter. Following a very festive banquet that evening, the newest members of Eta Nu Chapter were planning for a very bright and prosperous future as the representatives of Delta Sigma Pi on their campus. WINONA STATE UNIVERSITY HOME OF KAPPA UPSILON CHAPTER

The fraternity's 205th collegiate chapter and the state of Minnesota's fourth came into existence on April 9, 1983, as Kappa Upsilon Chapter was installed at Winona State University. Thirty-Three collegians and one faculty member were initiated as the charter members of the chapter.

As is frequently the case, a collegiate initiate of Delta Sigma Pi who transferred to a university that lacked a chapter of our fraternity, initiated the effort to establish the new chapter. In this case, Mark Dorn, who was inducted at Mankato State University by Epsilon Iota Chapter, wanted to share the Deltasig experience with his fellow business students at Winona State University. His efforts began during the spring of 1982 when he interested a group of a few students in working toward a chapter charter. Recruiting new members during the fall quarter increased the group's size considerably. In September, the organization sent a delegation to the North Central Regional Conference and received a visit from Assistant Executive Director Michael T. Walsh. Shortly thereafter, the group adopted Psi Alpha as the name of their local fraternity.

Additional recruiting activities were conducted during the fall and winter quarters as the members of Psi Alpha sponsored a wide variety of activities and fulfilled the requirements for a chapter charter. Their membership in the Winona Area Chamber of Commerce provided them with numerous valuable contacts for professional activities. By mid-January, when the members of Psi Alpha were visited by Director of Chapter Operations, a target date for installation in early April had been selected. In March, their petition for a collegiate chapter charter was approved by our Board of Directors.

On the morning of April 9, a large group of Deltasigs gathered in Winona in the midst of an unexpected snowfall. Grand President Michael R. Mallonee, Director of Chapter Operations Mark A. Roberts, District Director Scott W. Larkin, Faculty Advisor Mark R. Young (a collegiate initiate of Eta Rho Chapter), Golden Council member Rudolf Janzen and members of Alpha Epsilon (Minnesota-Minneapolis), Epsilon Iota (Mankato State). Eta Rho (Wisconsin-LaCrosse) and Theta Tau (St. Cloud State) chapters composed the installation team. The banquet that evening was held on board an elegantly refurbished riverboat on the banks of the mighty Mississippi. After the conclusion of that exciting and memorable event. the members of Kappa Upsilon Chapter resolved to prove that they were "The Professionals" at Winona State University.

DELTA SIGMA PI RETURNS TO THE UNIVERSITY OF MICHI-GAN

Since Xi Chapter became inactive during the 1965-66 academic year, many Deltasigs have harbored a desire to again have our professional fraternity represented at Michigan. On April 16, 1983, that desire became reality as 22 new collegiate members were initiated and the charter of Xi Chapter was reactivated on the impressive and beautiful

Ann Arbor campus of the University of Michigan. Five collegiate chapters are now active in the Great Lakes State.

Past East Central Regional Director Jeffrey L. Philippi set in motion the events leading to the reactivation late in 1981 by contacting Dr. Gilbert R. Whitaker, the Dean of the School of Business Administration at Michigan and an earlier initiate of Xi Chapter. He directed us to seek recognition from the Student Council which was obtained following a presentation to that body in January, 1982. In April of that year, the initial recruiting presentation, conducted by Central Regional Director John V. Henik, met with moderate success. David M. Weller, a collegiate initiate of Epsilon Xi chapter at Ball State University who had transferred to Michigan, offered to help coordinate future ac-

tivities on campus.

The effort to reactivate Xi Chapter gained a great deal of additional momentum following a second presentation in October by Director of Chapter Operations Mark A. Roberts and Reactivation Chairman Paul F. Smith. After that meeting, a group of 30 students began to fulfill the requirements for chapter reactivation and, in November, formally notified The Central Office of their intent. A diverse group of activities was planned and presented during the remainder of the fall semester and the first half of the spring semester. After all requirements had been fulfilled, the Board of Directors voted to officially reactivate the chapter charter.

Valparaiso University in Valparaiso, Indiana, is the home of Kappa Phi Chapter of Delta Sigma Pi, the fraternity's 206th collegiate chapter. During the installation on April 30, 1983, 32 collegians and three faculty members joined the ranks of our Brotherhood.

During the fall of 1981, former Chapter Consultant Jere W. White contacted Dr. F. Barry Haber, Dean of the College of Business Administration at Valparaiso and a faculty initiate of Zeta Psi Chapter at SUNY-Albany. It was not until April of 1982, however, that a group of students organized with Delta Sigma Pi. During the summer, plans were made to introduce the fraternity to all business students and a very successful presentation took place on October 3. The immediate result of that program was the establishment of Kappa Beta Alpha, a group of more than 40 business students which declared its intent to pursue a chapter charter from Delta Sigma Pi.






The final event of the Denver Congress was the Farewell Luncheon. Members of the Board leaving positions were presented framed Certificates of Appreciation for their service.


