



Dear Brothers:

On the way home from our 37th Grand Chapter Congress, I was remembering my first Congress in a place not so far away from St. Louis. That place was Tan-Tar-A at Lake of the Ozarks, Missouri. The year was 1975. There were many challenges and opportunities then—just as there are now. As we start this 42nd biennium, our challenges are different, but no less difficult; our opportunities limitless, but just as tough to pick and choose. Pick and choose we must or else we risk becoming a jack of all trades and master of none.

Lately, we have devoted a lot of time in a necessary and worthwhile effort to determine where we are heading as we approach our second century. Even as we plan for the steps of tomorrow, we must be equally aware of the steps we take today.

EDUCATION

As a professional organization, one of our top priorities must be the education and preparation of our membership. We have labored long and hard in the planning stages of our Educational Masterplan. Now, we must devote our energies and resources toward the successful conclusion of that dream. Our Officer Training Schools in the summer of 1991; the development of our Video Library and; the ultimate goal, our International Leadership School program.

ENCOURAGEMENT

We will continue to encourage all of our alumni to continue their participation at all levels in the fraternity. Although it may not have seemed so before, each of you is very important to us. We cannot, and will not, turn our backs on you.

Equally important, we must continue to encourage and educate our "grassroots" officers—our District Directors and our Chapter Advisors. We will encourage the professional development of all our chapters and help them effectively communicate and interact with corporate America. We have already begun with our extremely successful Career Fair at this Congress. This was our first real

attempt at this level and from all indications, it was a tremendous achievement for us and the companies who invested their time and effort.

Let's face it . . . it takes money to run our fraternity and support its programs and heritage. In conjunction with the Delta Sigma Pi Leadership Fund and the Delta Sigma Pi Educational Foundation, we have embarked upon the most important fund raising campaign in our history.

Many of you have already generously responded—Thank you. Many Brothers have wondered from time to time if we are a business or a government. Why does it seem like it takes so long to make decisions? Why does it sometimes seem like such a bureaucracy? Why is there so much paper? However, I would suggest to you that we really more closely resemble a partnership. 




Biennial Leaders Elected

The Final Business Session of each Grand Chapter Congress is devoted to the election of the Board of Directors who will lead Delta Sigma Pi for the subsequent biennium. The elections conducted during the 37th Grand Chapter Congress in St. Louis filled the positions of Grand President, Vice President for Alumni Benefits and Services, Provincial Vice Presidents and Regional Directors. In all, 17 Regional Directors, four Provincial Vice Presidents, one Vice President for Alumni Benefits and Services and one Grand President were elected to serve for the 1989-91 biennium. In addition, by fraternity law, the Past Grand President and the Collegians of the Year 1988 and 1989 assume positions on both the Executive Committee and the Board of Directors.

The Executive Committee, the basic policy making body of the fraternity, with powers delegated to it by the Board of Directors and the laws of the fraternity, was also elected directly by the Grand Chapter. Serving on the Executive Committee for the next two years are Grand President William R. Kinsella, Past Grand President John V. Henik, Vice President for Alumni Benefits and Services Marc A. Robbins, Collegian of the Year 1988 Matthew S. Levin, Collegian of the Year 1989 Chris E. Robinett, Northern

Provincial Vice President Samuel F. Shaheen, Southern Provincial Vice President Richard B. Featherston, Mid-American Provincial Vice President Randy L. Hultz and Western Provincial Vice President Paul J. P. Garcia.

Elected as Grand President and leading the Executive Committee and Board of Directors for the next two years is William R. Kinsella. An alumnus of Delta Sigma Chapter at Loyola Marymount University, Bill is a June, 1973, initiate. A resident of Waterbury, Connecticut, Marc is affiliated with the Southern New England Alumni Chapter.


MATTHEW S. LEVIN

CHRIS E. ROBINETT





Employed by the Vitro Corporation, Mike lives with his wife Cindy and children in Alexandria, Virginia.







Gateway to Brotherhood

The Gateway to the West on the Mississippi River, St. Louis, Missouri, was the host of the 37th Grand Chapter Congress held at The Adam's Mark Hotel from August 13-18, 1989. Excitement and fraternalism filled The Adam's Mark Hotel on Sunday, August 13, as over 725 Deltasigs from across the nation, including Hawaii, registered for the 37th Grand Chapter Congress. First-time convention participants formed many new friendships while others renewed those relationships which had been developed over many years.

Most attendees of the Grand Chapter Congress arrived on Sunday, August 13, when registration began late in the morning and continued throughout the day. Following regis-

tration, the Delta Sigma Pi Educational Foundation held its banquet that evening. After the banquet concluded, all participants had the opportunity to meet the national officers and staff during the Grand President's Reception. This year, following the reception, two dances were sponsored, one each for collegiate and alumni members.

The Opening Business Session of the 37th Grand Chapter Congress began the morning of August 14. Following a delegate orientation session, the Opening Business Session was called to order by Grand President John V. Henik. The Invocation was delivered by Bro. J. Alfred Moroni, FSC, followed by the memorial service for all deceased Deltasigs, con-

ducted by Grand President Henik. Grand President Henik welcomed the delegates and other participants to St. Louis and the Grand Chapter Congress. He introduced the Board of Directors, members of the Golden Council (past national officers and Central office executive staff members), members of the Order of the Golden Helmet, the Silver Helmet and the District Directors. He also recognized Michael W. Moegenburg as convention Chancellor, William R. Leonard as convention Parliamentarian and R. Nelson Mitchell as acting Chairman of the Committee on Nominations.



On Monday afternoon, delegates and other participants from each region conducted meetings covering topics of interest to that particular region. Following these meetings, the Delta Sigma Pi Leadership Fund sponsored a Reception in order to kick-off its Annual Campaign. The rest of Monday evening was free for participants to enjoy St. Louis and its attractions. Also on Monday, spouses, guests and several alumni participated in a tour of St. Louis and the Fox Theater.

On Tuesday morning, the fraternity's first Career Fair entitled, "Opportunity '89," took place. Several companies were represented with a strong attendance by the attendees of the convention. While the Career Fair was going on, resume writing and interviewing seminars were also conducted.

On Tuesday afternoon, the Awards Luncheon was held. Two special guests, Batman (Past Grand President Michael R. Mallonee) and Robin

Chapter Efficiency Index Honor Roll Certificates were presented to 20 collegiate chapters for 1988-89. The East Central Region was recognized as the region with the highest average in the 1988-89 Chapter Efficiency Index. The chapters in the East Central Region achieved an average of 92,054 points.

The national Chapter Advisor of the Year Award was presented to a Chapter Advisor from the South At-

lantic Region, Brother Greg Thurmond, Chapter Advisor for Gamma Lambda Chapter at Florida State University.

The District Director of the Year Award recognized co-winners, Karen M. Barkey, District Director of the Year for Iota Nu Chapter at Northeast Missouri State University and Adrian R. Avalos, District Director of the Year for Delta Sigma Chapter at Loyola Marymount University.

The Most Improved Chapter for 1988-89 was Delta Sigma Chapter at Loyola Marymount University and the Most Improved Region was the South Central Region, Connor L. Coward, Director.

Finally, the Most Outstanding Chapter and National Community Service Awards for alumni and collegiate chapters were presented to only two chapters. The Most Outstanding Alumni Chapter and National Community Service Awards for alumni chapters both went to the St. Louis Alumni Chapter. The Most Outstanding Chapter and National Community Service Awards for collegiate chapters were presented to Iota Nu Chapter at Northeast Missouri State University. Further information on national and regional award winners is presented elsewhere in this issue.

Collegian of the Year 1989 Chris E. Robinett addressed the Awards Luncheon attendees after presentation of a plaque in recognition of his selection as Collegian of the Year 1989.

Following the Awards Luncheon, educational seminars were scheduled for the remainder of the afternoon with over 20 different seminars being

presented. Following the afternoon seminars was the Alumni Reception which was well attended. Also scheduled on Tuesday afternoon was the tour to St. Charles, Missouri, attended by spouses, guests and alumni.

While another free evening was scheduled for Tuesday night, over 200 Deltasigs did make the short walk to attend the St. Louis Cardinals/Atlanta Braves baseball game at Busch Memorial Stadium in downtown St. Louis. Beside being treated to a Cardinals victory, the Deltasigs were recognized on the stadium scoreboard and provided the most enthusiasm during the game. Following the game, Deltasigs returned to The Adam's Mark Hotel and other St. Louis night-spots to continue the festivities into the night.

On Wednesday, August 16, the Legislative Business Session took place with the delegates considering amendments to the Laws of the fraternity. Final nominations for elected office were also accepted.

On Wednesday afternoon, National, Provincial and Regional Candidate Caucuses were scheduled to provide an opportunity for all candidates to present their views and answer questions for interested delegates and other convention attendees.



Ever since the concept of honoring only the most outstanding individuals in business, education and/or government was first introduced on a national level within the fraternity in the late 1930's, Delta Sigma Pi has consistently honored those individuals who have represented the very best in their field. The Honorary Member-at-Large, now called the National Honorary Member, was first created in 1939 when Walter D. Fuller, President of the Curtis Publishing Company was initiated at the 13th Grand Chapter Congress in Philadelphia. Throughout the years, outstanding men have been honored by Delta Sigma Pi in this way.

During the 37th Grand Chapter Congress in St. Louis, another outstanding businessman joined the ranks of the National Honorary Members and of the fraternity. He transferred to company headquarters in Midland, Michigan, as an Executive Vice President of Dow and member of the company's Executive Committee in 1985. He was named President and Chief Operating Officer of The Dow Chemical Company on May 14, 1987.

Mr. Popoff is a Director of Dow Corning Corporation, Chemical Bank & Trust Co., Midland, the Chemical Manufacturers Association, The American Institute for Contemporary German Studies and The International Committee of The Salk Institute. He is a member of the Business Roundtable, the Conference Board and the American Chemical Society. Mr. Popoff also serves on the Boards of The Indiana University Foundation and its School of Business Dean's Advisory Council and the University of Michigan School of Business Visiting Committee.

Born in Sofia, Bulgaria, Mr. Popoff emigrated to Terre Haute, Indiana, and earned a Bachelor's degree in chemistry and an MBA from Indiana University in 1959, prior to his joining Dow.

Following Mr. Popoff's initiation as the fraternity's newest National Honorary Member, he made several remarks to the Brothers in attendance at the initiation during the Grand Chapter Congress and answered questions, as well. Mr. Popoff was presented with his membership certificate at the 37th Grand Chapter Congress Banquet on Thursday, August 17, 1989. Memoriam

If ever anyone could be described as having a love affair with Delta Sigma Pi, that someone would have to be Rudie Janzen. Rudie Janzen, who loved his fraternity more than almost anything else, died earlier this year on June 24, 1989. While that love for the fraternity may have died with him, the memory of his love and dedication to Delta Sigma Pi will be with us always.

Rudolph Janzen, was born on January 15, 1902, and grew up in Mountain Lake, Minnesota, where his father was a farmer and a banker. He attended Carleton College in Northfield, Minnesota, for two years before enrolling at the University of Minnesota and graduating with a degree in Business Administration in 1925. While at the University of Minnesota, Rudie met a bunch of fellows who had just formed a business fraternity the previous spring who invited him to join. His initiation on November 7, 1924, began what was to be an almost 65 year love affair with Delta Sigma Pi as a collegiate and alumni member.

To say that Rudie was an involved

Deltasig was an understatement. His involvement in the fraternity raised that term to a new level with his constant interaction with not only his Alpha Epsilon Chapter Brothers at the University of Minnesota, but with Deltasigs from across the country. Whether it was Rudie's attendance at Alpha Epsilon Chapter Anniversary Banquets in the 1920's, 30's, 40's and beyond, or his outstanding work in maintaining contact with his Alpha Epsilon Chapter Brothers over the years by publishing an alumni newsletter, Rudie Janzen was involved with and loved his fraternity as much or more than anyone.

As a member of the Grand Council (Board of Directors) and Golden Council, Rudie was devoted to Alpha Epsilon Chapter and Delta Sigma Pi. His involvement in keeping Alpha Epsilon Chapter Brothers up-to-date with the happenings of each other is almost beyond belief. This love and devotion to the fraternity was recognized at the 60th Anniversary of the founding of Alpha Epsilon Chapter when Rudie was specially honored by the members of his chapter.

Following Rudie's graduation from the University of Minnesota, he went to work for the now-defunct Gladness Bakery in Minneapolis for 28 years as secretary-treasurer. In 1957 he started the Edina Kitchen, a bakery/deli which specialized in homemade Danish pastries and barbecued ribs. Although he retired in 1967, he continued to work part-time as a courier for the Gelco Corporation for another 10 years. His wife, Eleanore, said he was known as "Mr. Deltasig," to his friends and Brothers.

"He was not a joiner," she said. "He was not a Rotarian, he was not a Shriner, he was not anything else, but put all his love and devotion into the fraternity."

Rudie is survived by his wife, Eleanore, a brother, Kuno, who is an alumnus of Delta Sigma Pi and Alpha Epsilon Chapter of over 55 years, and his sisters Hilda Warkentin and Erna Paulsrud.

A man like Rudie who so loved his fraternity and brought so much happiness to all Brothers, will be remembered always.


erboat provided riverboat cruises while dinner and dancing continued on board The President throughout the evening.


