I think of the short time that I was a pledge and what seemed like unending hours of initiation. I think of the parties skipped, the work left undone, and the hours spent trying to cram all the information into my reeling mind, the week before the test. I think that I must have been insane!

No, I wasn't really insane, after all, insanity would seem to indicate that I endured all of what it took to get this far without some reward. But, here I am with my Brothers, enjoying good conversation, a good laugh, and most of all, the good feeling of Brotherhood. It's a fantastic, warm, wonderful feeling that I wouldn't trade for anything. It's a feeling of belonging, of being an individual, accepted by the group. But, while I could anticipate this feeling of mutual acceptance as I progressed through my pledgeship, I really can't say that that was the reason I joined. As a matter of fact, the first reason I joined this fraternity was almost wholly due to my first contact

with it. These first contacts were through one member, and from the first time he mentioned the fraternity until the time we shared the grip of Brotherhood after initiation, I was impressed by the professional atmosphere of the fraternity, and, more importantly, by seeing the special kind of relationship he shares with his Brothers. Now that I am one of his Brothers, I can see why he took the time to recruit someone else. I am glad he took the time to recruit me so that I can enjoy the same feeling of Brotherhood. May I do the same!"

May each of you do the same. And, even if this issue ends up collecting dust until your next spring cleaning, may you never forget the lessons of recruiting, pledging and Brotherhood.





Whether it would be your first Grand Chapter Congress or your tenth, Washington, D.C. is where you will want to be later this summer. In August, the 38th Grand Chapter Congress will be in full swing and it is an event that all Deltasigs, both collegiate and alumni, as well as their family and friends will not want to miss. Ask a fellow Brother who has previously attended a Grand Chapter Congress why you should go and you will invariably receive a long discourse in favor of attending. But, previous convention attendees also invariably find it difficult to express the true impact that the Congress has had on them. How can you describe an event where you were installed as Collegian of the Year; where you witnessed your chapter receiving a fraternity award, or where you first met a lifelong friend, your spouse or even spent your honeymoon? These are but a few actual convention experiences of fellow Brothers over the years.

In the previous issue of The DELTA-SIG magazine, a wealth of information on Washington, D.C. was provided with information on The Omni Shoreham Hotel, your convention headquarters. In this issue, complete details on the convention events as well as convention registration and hotel reservation information is provided.

This first convention held in our nation's capital is also the first convention with several major changes that have been adopted for the Congresses of the 90's. In response to feedback from attendees at previous conventions, as well as an assessment of the needs of our members and chapters, changes to the convention program have been adopted by the Executive Committee. These are exciting changes that will benefit both first-time attendees and "Congress veterans."

August 13 through 18, 1991 are the official dates of the 38th Grand Chapter Congress, but the needs of individual attendees will determine the actual dates that they attend. Collegiate chapter officers and those with ambitions to be one as well as current and future fraternity officers will want to register for the Officer Training School that begins early on the morning of Tuesday, August 13, 1991. See the related article for more details on the 1991 Officer Training Schools. Most other attendees will want to arrive on Wednesday, August 14, 1991. All participants will want to make plans to depart Washington no sooner than Sun-

day, August 18, 1991, to secure a reduced air fare most of which require a Saturday night stay. Incidentally, be certain to call the Ohio Auto Club—Oxford Branch, the Official Travel Agency for the 38th Grand Chapter Congress, for special discounts on selected air fares available only on travel booked through that agency.

Now, let's look at the convention on a day-by-day and an event-by-event basis . . .

WEDNESDAY, AUGUST 14, 1991

After a full day of the Officer Training School on Tuesday, August 13, 1991, Wednesday begins with a morning Delegates' Orientation Session. During this session, Official Chapter Delegates and Alternates will be provided with information on the policies and procedures followed during the Business Sessions and

will preview the legislation that will be considered. The afternoon is free for all to explore Washington and its many free attractions. Registration will be open throughout the day so attendees can pickup their convention materials at their leisure. The evening events begin with the Grand President's Reception. Each participant will have an opportunity to meet the Grand President, the Executive Director, the Vice President for Alumni Benefits and Services and many other fraternity leaders from both the volunteer and Central Office staff



ranks. The first social event of the convention, the Opening Dance, follows the reception. Concurrent with the Opening Dance will be the Yellow Dog and Pink Poodle Initiations.

THURSDAY, AUGUST 15, 1991

A busy day is scheduled for all on this day. The 38th meeting of The Grand Chapter of Delta Sigma Pi officially begins with the Opening Business Session. At this session, a variety of recognitions and business matters are handled. Traditionally, the Keynote Address is held during the first segment of the Opening Business Session. Our plans for the delivery of the Keynote Address for this Grand Chapter Congress are flexible as this event has taken on a Presidential stature. President Bush is our invited Keynoter. While confirmation of his attendance is pending we know that all attendees will share in the excitement at the prospect of witnessing the first time that the President of the United States of America addresses a Grand Chapter Congress of Delta Sigma Pi.

The Opening Business Session continues throughout this day including nominations and the presentation of official reports. On Tuesday evening, the Career Fair will occur. Representatives from several major companies will be on hand to discuss employment opportunities with both collegiate and alumni members. The Career Fair provides an excellent means to gather information on potential employers and to establish those all important initial contacts. The evening is free after the Career Fair for those who want to explore Washington nightlife and all that it has to offer. From Georgetown to Adam's Morgan the choices are almost limitless.

FRIDAY, AUGUST 16, 1991

Another full day of activity is scheduled for Friday. This day begins with the Legislative Business Session. Delegates will consider over 50 amendments to the Laws of the Fraternity and will have the opportunity to debate their positions. The Awards Luncheon immediately follows. This special convention highlight provides an outstanding forum for recognition of the best that Delta Sigma Pi has to offer.




SOUTHEASTERN REGION


PRESIDENT BUSH SLATED AS KEYNOTE SPEAKER







Founded in 1962,
but inactive for
nearly 20 years,
Epsilon Omicron Chapter
at Western Michigan University
was reactivated
on December 8, 1990

n Saturday, December 8, 1990, Epsilon Omicron Chapter, the fraternity's 120th chapter, was reactivated on the campus of Western Michigan University. Originally founded on May 19, 1962, Epsilon Omicron Chapter has been inactive since the 1970-71 academic year. The reactivation of the chapter was the culmination of the work of several individuals who wished to see Delta Sigma Pi again represented at Western Michigan University.

An alumnus of Epsilon Omicron Chapter, David Biek, contacted The Central Office of Delta Sigma Pi in 1988 to inquire if the fraternity had any plans to reactivate Epsilon Omicron Chapter. Brother Biek's son, Michael, was a student at Western Michigan University and was quite interested in joining his father's professional business fraternity. Director of Chapter Services C. Dean Ferguson met with Michael Biek during the spring of 1988, and discussed those steps needed to reactivate Epsilon Omicron Chapter.

An initial interest group of students was formed in the fall semester of 1988. It was not until January 19, 1989, that university approval for the reactivation of the chapter was granted by Dean Darrell G. Jones. A letter of intent was also received in January, from colony President Jeffery Ostema. A roster of members was submitted in March, indicating there were 30 colony members. Director of Chapter

Services C. Dean Ferguson also visited the Delta Eta Xi Colony in February, and met with the officers of the colony as well as Brother Robert Beam, an alumnus of Epsilon Omicron Chapter and Vice President for Business and Finance at Western Michigan University. Recruiting was discussed extensively and a list of all remaining requirements for reactivation that needed to be submitted were given to the colony. Frequent visits to Delta Eta Xi Colony were made by Huron Regional Director Frederick C. Lipsey during 1989 and 1990. The colony also benefited from the assistance of Brother Beam, and Chapter Advisor Brother Fred Hirt.

During March of 1989, the colony began submitting requests for points in the Chapter Efficiency Index. The members attended the Huron Regional and Area Conferences in early 1989 and 1990, and the Grand Chapter Congress in August of 1989 in St. Louis, Missouri. In August of 1989, then Assistant Executive Director Michael T. Walsh conducted a one-day recruiting seminar at Western Michigan University for our colony. With the strong recruiting program in the spring of 1990, membership in the colony rose to 40 individuals. In the fall of 1990, the colony also extended bids to additional students, which increased the size of the colony to 62 members.


On Saturday, December 8, 1990, Deltasigs from across the country gath-

ZIEGLER NAMED HONORARY AICPA MEMBER






