# RETURNS

Founded in 1966, but inactive over the past two years, Zeta Phi Chapter at Florida Atlantic University was reactivated on January 18, 1992

n Saturday, January 18, 1992, Zeta Phi Chapter, the fraternity's 144th chapter was reactivated on the campus of Florida Atlantic Uni-

versity. Originally founded on December 3, 1966, Zeta Phi Chapter had been inactive since January, 1990. The reactivation of the chapter was the culmination of the work of several individuals who wished to see Delta Sigma Pi again represented at Florida Atlantic University.

In August of 1990, faculty Brother Michael Pantya, an alumnus of Beta Omega Chapter, contacted The Central Office to learn what would be required to reactivate the Zeta Phi Chapter. Director of Chapter Services C. Dean Ferguson contacted Dr. Pantya and reactivation efforts began. In November Dr. Pantya, Golden Council Members Heather A. Bailey and Charles A. Hazday, and District Director Daryl T. Logullo conducted recruiting events for students.

On December 3, 1990, a list of officers was received at The Central Office. A letter of intent was received on February 8, 1991, from 35 members of the Zeta Phi Colony.

Frequent visits to Zeta Phi Colony were made by Golden Council Members Heather A. Bailey and Charles A. Hazday and District Director Daryl T. Logullo. Director of Chapter Services C. Dean Ferguson made a two day visit to Zeta Phi Colony on March 11 and 12, 1991. He met with the Dean of the College of Business Stanley Hille. He also met individually with all colony officers. At this time, a calendar of activities, membership roster, and chapter Bylaws were submitted.

During April of 1991, the colony began submitting requests for points in the Chapter Efficiency Index. In addition to attending Grand Chapter Congress in Washington, D. C., three members attended an area conference in the spring of 1991. An even larger group of members attended a second area conference in the fall of 1991.

On April 5, 1991, 19 students were pledged in accordance with the fraternity's pledging ceremony and with the recruitment of 13 students in October of 1991, the size of the colony increased to 32 members.

On Saturday, January 18, 1992, Deltasigs from across the country gathered in Boca Raton, Florida, to reactivate Zeta Phi Chapter. Fraternity officers in attendance included Grand President William R. Kinsella, Southern Provincial Vice President Richard B. Featherston, South Atlantic Regional Director Ronald W. Richards, District Director Heather A. Bailey, District Director Charles A. Hazday, District Director Daryl T. Logullo, District Director Adine R. Nicholson, District Director James A. Saccullo, District Director Jarrett M. Strawn, District Director B. Todd Whisenant and Golden Council Member Elaine M. Norton. Executive Director Michael J. Mazur, Jr., represented The Central Office staff at the reactivation.

Several chapters participated in the reactivation of Zeta Phi Chapter and served on the Ritual team. The Ritual Team was represented by Beta Omega Chapter at the University of Miami, Theta Sigma Chapter at the University of Central Florida and the South Florida Alumni Chapter.

. Following the initiation, a memorable reactivation banquet was held. Dean of Student Affairs at Florida Atlantic University, Dr. Karl F. Ijams, provided a history of Florida Atlantic University. Following this presentation, Rebecca S. Jones, Senior Vice President of Zeta Phi Chapter presented the history of Zeta Phi Colony. Remarks were also heard from Southern Provincial Vice President Rich-

# **Headquarters Headlines**

MENTORS - those special people in our lives who provide inspiration, guidance and example without even knowing or trying. This is a definition that you will not find in a dictionary. It's mine; off the top of my head. I have been blessed with more mentors than the average person deserves. I can pinpoint, as can you for yourself, those people who had a special influence on me; who cast a spell resulting in my utmost respect and admiration, and who forever have affected the course of my life. I consider my mentors as special, unexpected gifts. To lose one to death is a pain from which one never recovers. I have lost six already and it hurts.

A few months ago I had a chance to have dinner and conversation with one of

my nephews. He is attending a large university in the South and is a member of a large and prestigious general (social) fraternity. His chapter is well-managed and my research tells me that his chapter has won several awards.

Our conversation took an interesting turn when he asked, "What do you do about alumni?" The tone, which was similar to "What do you do about an oil spill or toxic waste?", told me that problems had occurred at the recent Homecoming reception that he chaired. Weeks before I heard about the extra work being devoted to cleaning up the chapter house; the extra effort to follow up every invitation with a telephone call, and the lavish spread that the house chef was preparing.

Overall, the event went well but the antics of a few alumni now provide the most vivid memory of alumni for this chapter. Apparently, they had more than their share of the stereotypical "plastered alumni dancing with a lampshade on his head." The abuse about running a cash bar to comply with risk management policies and watering down the initiation "fun" to comply with hazing policies and statutes coupled with the damage from spilled drinks left a negative attitude toward alumni among these college students.

The interfraternal relationship among alumni and collegiates requires mutual efforts if they are to be successful. The key is to remember that we are all Brothers of equal rank in Delta Sigma Pi regardless of initiation number. Mutual respect goes a long way in strengthening fraternal bonds.

Perhaps the most meaningful and important purpose that alumni can serve is as a mentor to one or more collegiate members. Little is accomplished when an alumni comes back to his or her chapter and attempts to relive the past. A tremendous amount is received when an alumni comes back and shares some guidance or some professional expertise with collegiate Brothers. The ultimate experience for a collegiate member is to have someone who they respect listen to their ideas and offer some meaningful advice. It's a special experience for an alumni member to have someone listen to their ideas and to consider their advice - often their own children do not afford them this opportunity.

Mentoring can be a special experience for all parties involved if it is done in a genuine and meaningful way. Collegians — here's your chance to actually do something with alumni in a positive way and to benefit in the process. Alumni — your opportunity is here to be a special, unexpected gift rather than a bad memory wearing a lampshade! It's challenging for all but the rewards can be great.
