
-SOUTHWESTERN-CINDY J. COLLUM

The Fraternity helped orchestrate the event with Miami-Ohio and other Oxford area schools.

elta Sigma Pi participated in the first-ever Regional LeaderShape[®] Institute on July 19-24, 2001. Ten Deltasig students joined 39 other students from Xavier University, the University of Cincinnati, Northern Kentucky University, the University of Dayton, and Miami University for this six-day leadership event.

Similar to the Delta Sigma Pi Ultimate Academy, The LeaderShape[®] Institute is an intensive, energizing, and unique educational experience designed to develop students' ability to lead with integrity. The Institute is comprised of no more than 60 students from diverse experiences, ethnic, religious, and cultural backgrounds.

The Delta Sigma Pi Leadership Foundation selected a committee from its Trustees to review the applications received and select the attendees for the ten spaces reserved. Alison Spring, *Drake*, volunteered her time for the six days to serve as the Deltasig-appointed facilitator for this event. Brother Spring is a facilitator and human resources manager for PricewaterhouseCoopers in Chicago.

At The LeaderShape[®] Institute, participants created a "LeaderShape Vision," a project that is implemented throughout the following year. The objective of these participant programs is to create "extraordinary improvements" on campus or in the community. LeaderShape[®] makes the most impact when participants make a commitment to test and apply the principles and skills learned through making a difference for others. In committing to LeaderShape, the first Delta Sigma Pi participants were affirming a year-long commitment to improving the Fraternity, their respective schools, and surrounding communities.

The Institute environment resembles a laboratory more than a formal classroom. Participants are encouraged to practice new skills, give and receive feedback from peers and faculty, and test new behaviors in a safe, supportive atmosphere. LeaderShape's guiding principle is that everyone at The LeaderShape Institute is a teacher and everyone is a learner.

The LeaderShape Institute emphasizes the fact that "You Can Make a Difference!" as participants take on bold challenges and understand that leaders are not born or made, but shaped—and that each has a significant role to play in his/her own shaping.

Considerable thought has gone into making sure that The LeaderShape Institute curriculum promotes participant development. A variety of teaching methods are used to engage participants with different learning styles. The Institute believes that everyone has the capacity to effectively lead with integrity, and that this capacity can be developed in all people who are committed to doing so.

The Deltasig participants were enthusiastic and reflected the inspiration they had found at The Institute. Here are some of their comments:

"I learned so much about leadership and working together as a community. I plan to take the ideas I have learned and share them with my chapter and others that I work with. This has been a valuable experience which I believe will benefit both myself and the Fraternity."

"The material and program was great and what I learned was unbelievable. I have never been to anything like this where, in such a short period of time, you could learn so much."

"This was an outstanding program and I feel privileged for the opportunity to participate in The LeaderShape Institute. I personally found the development of a vision and goals very intense and enlightening, and now believe that I will be able to make a difference for others."

"LeaderShape provided me the opportunity to become a better leader in my community and my chapter. There were 49 proven leaders at LeaderShape, and imagine what it would be like if we all attended the same university. Can you think of the difference we could make?"

ence in the future. It will change your life dramatically."

To date, more than 8,000 participants from colleges, universities, and corporations from across the country have attended The LeaderShape Institute. In addition, more than 700 volunteer faculty have contributed their time and talents since the program began in 1986. More than 30 colleges and universities conducted campus-based sessions for their students in 2001.

LeaderShape, Inc., a separate non-profit corporation which oversees The LeaderShape Institute and furthers its mission of leadership development, is governed by a Board of Trustees, staffed by a team of employees, and supported by numerous committed volunteers.

eltasigs met at California State Polytechnic-Pomona on June 2, 2001 to re-charter the Eta Chi Chapter which had been closed since 1989. A colony targeting the reactivation officially began on September 3, 1999 with special assistance from Brother Jennifer Webb, *South Carolina*, who was studying at Cal Poly-Pomona.

During their time as a colony, the students planned a variety of programs to meet the objectives of the Fraternity and meet the extracurricular needs of the members. The professional program included topics on Robert's Rules of Order, consulting, personal investing, entrepreneurship, and resume writing. In addition, speakers represented Enterprise Rent-A-Car and a tour was taken of the APL Company.

The ceremonies were held on campus, with a banquet following at the Sheraton Suites Fairplex.

Then-Grand President Norm Kromberg was the installing officer, with assistance from collegiate members from CSU-Fullerton, UC-Riverside, and Redlands. Brothers Jennifer Webb and Joe O'Brien continued their support and assistance throughout the day of celebration and were recognized with appreciation from both the chapter and the Fraternity.

Pacific Coast Regional Director Darrell Keller served as Master of Ceremonies for the reactivation banquet. The program began with an invocation by new member Orsolya Forgo and a history of the university and College of Business Administration by Chapter Advisor, Brother Ralph Miller. New member Steve Rodriguez shared a history of the colony via a slide show before receiving the charter from the Grand President.

Leadership Foundation Trustee Greg Howell presented the Scholarship Key Plaque to new member Pascual Castillo, and Provincial Vice President Claire Sammon Roberts presented Brother Forgo with the new chapter gavel. Cal Poly alumnus and Golden Council member Adrian Avalos presented the president with a pearl and ruby badge as a special token to begin a tradition of transition for future chapter presidents. Upon the conclusion of presentations, Educational and Leadership Consultant JoAnne Hendricks delivered Fraternal greetings from the Central Office staff and other brothers who sent their greetings but were unable to attend.

Other Board members in attendance for the celebration were Vice President

for Alumni Benefits and Services Mark Roberts, Collegian of the Year 2000 Missy Ekern, and Leadership Foundation Trustee Bill Tatum as well as a host of Golden Council members and other alumni.

California State Polytechnic University-Pomona was founded in 1938 when Charles B. Voorhis donated his school for boys (founded in 1927) to the California State System.

There was already a vision by Cal Poly-San Luis Obispo to expand to a southern location and this acquisition made it a reality. The campus is well known for its Arabian horse ranch which was donated by W.K. Kellogg in 1932. Today, enrollment exceeds 16,000 students.

The College of Business Administration was formed in 1968 and is now accredited by AACSB and offers seven majors to 4,000 undergraduates. In addition, two other departments qualify for Delta Sigma Pi: Food Marketing/ Agribusiness Management and the Collins School of Hospitality Management. With this large market, the chapter is sure to be successful for many years to come. Eta Chi Chapter was first chartered on November 16, 1969, and has now initiated 335 total members. Welcome back Eta Chi! ▲





Wolfe Bequest Enhances Scholarship Program

On February 2, 1999, Brother Melvin Wolfe (Zeta - Northwestern) passed away, leaving a bequest of \$100,000 to the Leadership Foundation. There were no stipulations regarding use of the bequest. The Board of Trustees decided to place the money in the Foundation's invested funds and to use a portion of the income each year to provide two undergraduate scholarships of \$1,250 each. This year marks the first presentations of the Melvin Wolfe Scholarships.

The Collegian of the Year Scholarship Program

Since its inception in 1971, the Collegian of the Year program has honored hundreds of exceptional Deltasigs. The award, known today as the Mr. and Mrs. Sidney A. Sparks Collegian of the Year award, recognizes the brother chosen as the most outstanding collegiate member of the Fraternity as evidenced by Fraternity service, scholarship, extracurricular activities, demonstration of responsibility to self and others, and the representation of conduct according to the highest standards of ethics and integrity. In the selection process, one candidate is chosen from each Region of the Fraternity, and the National Collegian of the Year is selected from these Regional Collegians of the Year.

The Leadership Foundation awards each Regional Collegian of the Year a scholarship of \$400, made possible through the Clyde Kitchens/Thoben Elrod Endowment Fund and the Sidney A. Sparks Endowment Fund. The National Collegian of the Year is offered a scholarship for graduate studies of \$3,000 from the Sidney A. Sparks Endowment Fund. In addition, the National Collegian of the Year serves a two-year term on the Fraternity Board of Directors.

Alumni Chapters Build a Legacy

During the past year, two alumni chapters, the Chicago Alumni Chapter and the Space City (Houston) Alumni Chapter, have established funds with the Leadership Foundation to endow scholarships for collegiate brothers, thus committing to build a legacy for the future. This makes three alumni chapters that have created such funds. The Lincoln/Greater Nebraska Alumni Chapter established a scholarship fund in 1997.

By establishing such a fund, the chapter commits to raise \$10,000 for the fund within five years. When the balance of the fund reaches this level, the scholarship is considered permanently endowed and will generate an annual scholarship. The alumni chapter may restrict the scholarships from the fund to brothers of a specific collegiate chapter or group of chapters, and the chapter has the opportunity to be involved in selecting the recipients.



While memorial funds have been established in honor of each known Deltasig victim, other giving options exist via the Red Cross, United Way and other such relief funds. Additionally, the Delta Sigma Pi Leadership Foundation accepts memorial gifts, as well as contributions in honor of those who may have made a difference during all of the recent events. For gifts in "memory of" someone, the Foundation will send a letter to the family recognizing the contribution. In the case of honorary gifts, a letter is sent to the honoree.

Our thoughts and prayers go out to the victims' families and friends, and to all those that have been affected by the tragic events. Only in unity do we find strength, and may the bonds of fellowship through Delta Sigma Pi offer comfort during these times.

Chartering a new chapter: In order to be awarded an alumni chapter charter, the following must be submitted to the Central Office: a petition to charter, a chartering fee of \$25, a list of officers, and a roster of 10 members living in the general locale. Previously chartered chapters are required to franchise annually.

Franchising an existing chapter: To be recognized continuously as an alumni chapter of Delta Sigma Pi, the chapter will need to complete franchising requirements between April 1 and June 30 for an upcoming fiscal year. For example, to be recognized for the July 2002 - June 2003 fiscal year, requirements must be completed by June 30, 2002.

Franchising requirements:

- Submit a roster of current chapter members (National Bylaws require a minimum of 10 members living in the same general locale.)
- Submit a List of Officers (Form L)
- A Franchising Fee of \$25
- Chapter Bylaws must be on file at the Central Office
- A Charter Renewal Fee of \$25 (if franchising has lapsed for the chapter)
- A liability insurance fee of \$50

Fraternity Staff Update


