2017 National Honorary Initiate



Alden J. McDonald Jr. is President and CEO of Liberty Bank and Trust Company, one of the top African-American owned financial institutions in the United States. McDonald oversees an expanding network of banking institutions serving urban communities and providing leadership in community development to a diverse customer base throughout America. He is recognized as a passionate advocate

and dynamic catalyst in providing avenues for economic growth, home ownership, wealth building and leadership development in the African-American community. Mr. McDonald has gained a national reputation as a creative, insightful, yet practical problem solver who has developed mortgage and banking products that enhance the opportunities for the financially underserved, as well as, upwardly mobile populations of America's cities.

A graduate of the LSU School of Banking and of Columbia University's Commercial Banking Management Program, Mr. McDonald celebrates 50 years in banking this year. Under his stewardship, Liberty has grown from an initial asset base of \$2 million to more than \$650 million in assets. Over the past ten years, Liberty has closed over one billion dollars in loans. Liberty now operates financial institutions in eight states and nine major urban areas.

Following Hurricane Katrina, Mr. McDonald's extraordinary efforts in rebuilding the bank and providing guidance in the recovery of New Orleans has been chronicled in the *New York Times*. He was recognized as one of the most dynamic African-American business leaders in *Fortune Magazine* and he has been celebrated on numerous occasions in *Black Enterprise* magazine and several local and national publications.

In addition, Mr. McDonald has served on the boards of numerous local, regional, and national institutions and agencies, including FannieMae, the FDIC Advisory Committee on Economic Inclusion, the American Bankers Association, the National Bankers Association, the Louisiana Bankers Association, Entergy New Orleans, and Minority Alliance Capital.

Recognized locally and nationally for his many endeavors, Mr. McDonald was recently recognized as the "Father of the Year" by the American Diabetes Association and he received an Honorary Doctorate Degree from Loyola University in New Orleans. He received the 2013 100 Black Men, Inc.'s Trailblazer award, the 2012 National Urban League's Business Pioneer Award and was one of *Fortune* magazine's 2006 Portraits of Power. ▲

Eddie Stephens has been actively involved with Delta Sigma Pi since his initiation in 1991. In addition to



Eddie is a Board Certified Family Law Attorney who specializes in high-conflict matrimonial law. He has earned the AV[®] Preeminent[™] Peer Review Rating by Martindale-Hubbell, a professional rating indicating the highest ethical standards and professional ability, and has been selected for inclusion in Best Lawyers in America[®], a peer-review publication recognizing the top 4% of attorneys in the country.

In addition to practicing family law, Eddie is an author, lecturer, and community leader who supports a number of local civic and charitable organizations including Leadership Palm Beach County, Boy Scouts of America, Big Dog Ranch Rescue and Peggy Adams Animal Rescue League. Brother Makes Opening Remarks at Presidential Debate

Kenneth Sng, *Washington-St. Louis*, had the honor of delivering the opening remarks before the second U.S. presidential debate in St. Louis on October 9.



As the Student Union President, Sng spoke for the student body of Washington University and welcomed everyone to the campus. His opening remarks highlighted the importance of democracy in which he stated it, "provides momentous occasion to show that while citizens might disagree fervently on issues, they agree it is important to stay engaged in the democratic process."

When first starting to write his speech, Brother Sng felt inspired by a long conversation he had with an international friend and thought that, "the occasion would present an excellent opportunity to remind everyone that the rest of the world is watching the national election and that America has the potential to send a message of renewed confidence in democracy." Much of the world was in fact watching, and Kenneth pointed out that he was humbled to have received encouragement from his country, including Singapore's Prime Minister. When it came to preparing for his remarks, Sng said, "I tried to make every word count."



Brother Sng is very involved at Washington University, where he studies economics and mathematics. He mentioned that his experiences with the Fraternity have been nothing less than transformational. "Through Delta Sigma Pi, I got to be part of a tightly knit community of brothers who have been there for me every step of the way. Brothers have given me invaluable advice and support within and outside of the Fraternity. Interestingly, it was a brother who recommended that I get involved with the Student Union in the first place. The same brother later encouraged me to run for Student Union vice president of finance in my junior year and Student Union president my senior year," said Sng.

Upon graduation, his plan is to return to Singapore and work for the civil service. Due to strong preference for microeconomic policies and industry regulation, he is applying to ministries that deal largely with those areas, like the Ministry of Transport, Law and Finance. ▲

Brothers Network, Lead and





Brother Bikes 4000 Miles for CANCER

Laura Elizondo, *Texas-Austin*, took the ride of her life last summer—bicycling from Austin, Texas to Anchorage, Alaska. From the red dirt and cliffs of West Texas and New Mexico to beautiful desert lightning storms and the amazing colorful mountains in Zion National Park, Brother Elizondo saw some spectacular sights. “We saw the gorgeous snowcapped mountains in Yosemite National Park and the fogginess of San Francisco and the California coast. We were humbled by the Redwood Forest. Up

through Oregon and Washington, we passed over beautiful bridges and spent a lot of time in the cutest little towns. In British Columbia, we rode through gorgeous wildflowers and had spectacular views of mountains. Finally, through the Yukon and Alaska we saw so much wildlife. We saw moose crossing the street and bears along the side of the road. It was really cool.” But this ride wasn’t all about seeing cool sights. Laura made the journey as part of Texas 4000 to support the fight against cancer.

Texas 4000 for Cancer was founded by two engineering students at the University of Texas in Austin in 2004. According to their website, Texas 4000’s mission is to cultivate student leaders and engage communities in the fight against cancer. The student organization fights cancer by fundraising for cancer research and support services. After a competitive selection process of essays and interviews, the University of Texas students spend a year and a half raising money, training, volunteering in the community and planning the journey. During the 70 day cross-country bike tour, participants spread hope, knowledge and charity throughout North America. About 60 riders on three different routes embarked on the summer ride this year.

Brother Elizondo joined Texas 4000 as a way to honor her grandfather Bert Guerra who passed away from cancer when she was in middle school. “My grandfather loved adventures and people. I know he would be so proud to know that I got to experience such an amazing thing.” Laura participated in the Sierra route which spans through West Texas, New Mexico, Arizona, Utah, and Nevada, along the coasts of California, Oregon, and Washington, through British Columbia and the Yukon before finally reaching Alaska. She and her team left Cedar Park, Texas on June 4 and finished in Anchorage, Alaska on August 12.

“The ride was one of the most amazing and surreal experiences ever,” recalled Laura. “After riding about 80 miles a day on average, we would usually be greeted by people in churches and community groups. Getting to know people and hearing their stories about cancer was powerful and inspiring. People everywhere were incredibly generous and offered us meals, showers and a place to stay. After a good night’s rest, we would wake up in the morning and get ready for another day. My favorite tradition, however, was our ride dedication circle. Before

we left on our bikes, we would gather the team and our hosts together and each dedicate our ride that day to someone who inspired us to be there.”


According to Texas 4000’s website, “riders report growth and increased skills in the areas of physical fitness, leadership, accountability, confidence, resiliency, decision-making, conflict resolution, cancer advocacy, community engagement, volunteerism, fundraising, networking, mentorship, nonprofit operations, bike maintenance, nutrition, public speaking, interviewing, time management, teamwork and more.” Laura also learned that attitude makes a huge difference and attitudes, both good and bad, can be contagious. “It is easy to complain about being uncomfortable and missing home, but it bums everyone out. When someone had a good attitude, it was contagious and we all were inspired to get through the really hard days.”

She also learned that it is best to tackle a problem head-on by frontloading your hard work. “When climbing a hill or a mountain, you need to start at it full speed ahead so that your momentum will keep you going.” This message can be used in life, your career and in Delta Sigma Pi. “Instead of procrastinating and grumbling about something, I now try to just get right into problem-solving,” she claimed.

Laura gained even more at the finish line though. Her longtime boyfriend Garrett Oliveira, *Texas-Austin*, surprised her in Anchorage, Alaska with a marriage proposal. And if that wasn’t romantic enough, Garrett was actually Laura’s big brother when she pledged fall 2011. ▲

WunderBrothers Start



From sleepaway camp to corporate office! First meeting at middle school camp, two Syracuse brothers created Wundershirt, a company selling T-shirts that incorporate nanofabric technology. After camp, Sam Sanders and Michael Shaw stayed connected on Facebook, but it wasn't until they realized they were both attending Syracuse to study business did they team up.

Although Michael and Sam have very similar business goals which brought them together in business, they joined Delta Sigma Pi for different reasons. Michael joined Delta Sigma Pi to help him stand out in the Syracuse community. He also wanted the opportunity to expand his personal network. Sam wanted to grow, personally and professionally, while being able to share his knowledge and experiences with like-minded individuals. Delta Sigma Pi gave him a group of peers that he could count on for advice and growth.

Before pledging his freshman year, Sam was walking to a class presentation in a suit. It was a hot September day. When he finally arrived, he was tired and dripping with sweat. He asked himself "Why can't clothing do more for you than just be fashionable?" Determined to find an answer, he began to research clothing that could provide health benefits. Sam did not have the scientific background, so Michael joined him to help with research and product development. The two became

industry experts through endless hours of research. And what they don't know, they outsource.

The company came to fruition with the Couri Hatchery and Student Sandbox incubators at the Whitman School of Management, which both brothers graduated from last May. "Our current product's material raises stamina and endurance, boosts speed and strength, allows for quicker recovery, relieves stress on the body, and regulates temperature," explained Sam. According to their website, wundershirt.co., the shirt "contains multiple ingredients including optically responsive minerals that are embedded into the fabric that allow the shirt to enable increased oxygen and blood flow levels. These active ingredients are very small; in fact, they are smaller than a human hair. The materials react to light and heat."

In the beginning stages of creating Wundershirt, other brothers supported Sam and Michael with their goals. "Delta Sigma Pi gave us the network and tools to succeed.

It was beneficial to speak to brothers on campus, as well as professional speakers the chapter brought in, and use them as a sounding board. Furthermore, having other brothers on campus who have started businesses allows us to support each other and will continue going forward," said Michael. "The power of people is everything," Sam continued. "Personal relationships and how you manage and communicate with people will help determine how you will shape your life."





Starting a new venture in college is no easy task. “When working with a startup, we have to explore every possible option and possible lead we have,” said Michael. “Sometimes the biggest success can come from the most unlikely sources.” The two would schedule meetings to specifically talk about business. Time management and learning how to prioritize activities were important skills they both learned while in school. Sam learned to plot activities on a graph to help him prioritize. “I label the x-axis Importance and the y-axis Time Sensitivity. I then plot all of my activities I need to do, completing the time sensitive and high important items first.”

If you watched the summer Olympics, you may have spotted their shirts in Rio. These brothers

contacted English-speaking countries with ten or fewer athletes to pitch their product. They were hoping to equal out the playing field so that all countries have equal access to top technology, which typically countries with a small number of athletes do not have access to. After many emails and phone calls, representatives from Olympic Track and Field Teams from St. Kitts and Nevis, U. S. Virgin Islands, Bermuda and Trinidad and Tobago all purchased their shirts.

So what is next for WunderShirt? “I believe Wundershirt will one day become the future of clothing. We will be looking to explore other cutting edge fabrics that will help customers get the most out of the clothes they wear,” claimed Sam. ▲







Gratitude from 2016 Chapter Advisor of the Year – Terri Mische

I was serving as the Director of Development for the Herberger Business School at St. Cloud State University (Minn.) when I began working with Theta Tau during a small 2.5 million dollar fundraising campaign to enhance space being remodeled for the business school. I also had the opportunity to observe several of the chapter brothers when in 2007 the school hosted John Stumpf, then President and COO of Wells Fargo, during a day of presentations and meetings on campus. I continued my relationship after the campaign with the chapter as a resource for event planning assistance. I was initiated in April 2011 as a faculty initiate and have continued volunteering as the chapter advisor.

During the campaign planning and celebratory events, I was consistently impressed by the maturity, professional presence, courteousness and organization of the brothers. For example, when the mother of the first deceased brother visited campus to attend a reception, Mrs. Jirik was constantly engaged in conversation and was never without a brother as an escort during her visit. In fact her daughter who had accompanied her to campus, felt comfortable enough to venture away from her mom and engage in separate conversations. It was at that point that I realized the brothers were a distinctive group of students and the manners and polish I had been witnessing was being fostered by the Fraternity.

My duties as the advisor have grown over the years. Initially, I continued to offer guidance with special event planning and to explain and sign off on required University documents. I began to attend more executive committee meetings and to participate in events. After my initiation, my knowledge and understanding of Delta Sigma Pi grew exponentially. Delta Eta Time Capsule

Brothers at Delta Eta Chapter at Lamar in Beaumont, Texas joined together in October during the university's homecoming to celebrate the 50th anniversary of the chapter. Brothers had a special treat--they were able to see the contents of a time capsule buried on campus thirty-five years ago.
