The 50th Grand Chapter Congress of the International Fraternity of Delta Sigma Pi, Inc. was called to order at 8:30 a.m. on Thursday, August 13, 2015, by Grand President Onuka Ibe at the Renaissance Schaumburg Convention Center Hotel near Chicago, Illinois.

Ibe presided as Chairman of the Congress, per policy. Other positions were as follows: Wendy L. Eilers (*Epsilon Omega*), Parliamentarian; Norman Kromberg (*Alpha Delta*), Credentials Committee Chair; Randy L. Hultz (*Iota Nu*), Chancellor; Nominations Committee Chair, Chiacchiari; and Recording Secretary, Schilling.

The first order of business was the opening Ritual, followed by the initiation of National Honorary Initiate Barry Salzberg, retired Global Chief Executive Officer of Deloitte Touche Tohmatsu Limited. Theresa J. Drew (*Zeta Omega*) conducted an interview with Brother Salzberg following his initiation.

Ibe then offered a welcome to the Congress. The Delta Sigma Pi Memorial Service was conducted in memory of all brothers who passed away since the last Grand Chapter Congress. Specifically memorialized were these brothers: Bridget Achenbach, *Eta Rho*; Dale Bails, *Epsilon Psi*; Jordan Basl, *Beta Gamma*; Joshua Beach, *Omicron Pi*; Robert G. Ibe then introduced the Board of Directors and Regional Vice Presidents, the Trustees of the Delta Sigma Pi Leadership Foundation, National Committee Chairs, Past Grand Presidents attending the Grand Chapter Congress, Golden Council Members, Lifetime and Career Achievement Award honorees, Faculty

Members, Chapter Advisors, District Directors, National and Provincial Committee members, host chapter attendees, members of the Central Office Staff and colony members.

At this time, Ibe relinquished the chair to Chancellor Hultz, who introduced Credentials Chair Kromberg. Kromberg then presented the Roll Call of Delegates and the report of the Credentials Committee. He announced 236 delegates were confirmed with 228 present and eligible to vote. Philadelphia Alumni moved to adopt the roll of voting delegates and to accept the report of the Credentials Committee. The motion was seconded by Louisville Alumni and adopted.

At this time, Hultz introduced Parliamentarian Eilers to present the report of the Rules and Resolutions Committee. Zeta Omega moved to adopt the Proposed Standing Rules for the 50th Grand Chapter Congress as presented. The motion was seconded by Eta Psi and adopted.

Long Beach Pier 9 then moved to adopt the agenda for Old Business—which was “none”—as presented by Eilers. The motion was seconded by Xi Rho and approved.

Epsilon Iota moved to adopt the agenda for New Business as presented by Eilers. The motion was seconded by Lambda Pi and approved. The proposed Bylaw Amendments will be considered in this order: Amendment #1, Amendment #3, Amendment #2 and last, Ritual Proposal #1.

Cincinnati Alumni moved to dispense with the reading of the minutes of the 49th Grand Chapter Congress and to approve the minutes as distributed. Seconded by Eta Pi and approved.

Nu Tau moved to receive the printed Official Reports as distributed to the delegates. Gamma Tau seconded and the motion was adopted.

Hultz then introduced Ibe to present the “State of the Organization” report to the Grand Chapter. (This report and those of the Vice Presidents, Committee Chairs and others are contained in these proceedings.) Ibe introduced Gabe Ottolini, representative of national philanthropy partner Ronald McDonald House Charities, who thanked Delta Sigma Pi for our involvement, summarized past contributions and outlined future opportunities.

Iota Nu moved to receive the report of the Grand President. The motion was seconded by Theta Chi and approved.

Brian Krippner, Chair of the Leadership Foundation, was invited to say a few words on behalf of the Foundation.

Ibe then presented charters to members from Gamma Mu, Gamma Sigma, Sigma Omega, Tau Upsilon and Tau Phi. He also welcomed new alumni chapters Charlotte (NC), Honolulu-Oahu (HI), Long Beach-Pier 9 (CA), Miami/Fort Lauderdale (FL), Florence, SC, Portland Cascadia (OR), and St Pete-Clearwater (FL).

Hultz recessed the meeting at 11:45 a.m., reconvening at 2:15 p.m.

A new delegate count was taken by Credentials Chair Kromberg and he certified 229 delegates present and voting.

At this time, Chiacchiari presented the report of the Nominations Committee.

The following nominations were withdrawn: Patrick Flynn for Steel Valley Regional Vice President and Erica Lakey for Desert Mountain Regional Vice President.

Gamma Theta moved to receive the report of the Nominations Committee. The motion was seconded by Omicron Pi and approved.

OLD & NEW BUSINESS

Chancellor Hultz then noted there was no old business and moved into new business. The first items were the proposed amendments to the bylaws.

The Chancellor brought to the floor **Bylaw Amendment #1** (proposed by Onuka Ibe/Board of Directors): Amend Bylaw Article XVI, Section 3 to determine the naming of collegiate chapters after Psi Omega. The motion was seconded by Psi Omega.

Bylaw Amendment #1 was then **adopted** by approval of over 2/3 of the delegates.

Article XVI, Section 3 of the Bylaws will now read:

Section 3. Designation of Collegiate Chapters --- The Collegiate Chapters shall be designated alphabetically, in the order of their installation, using the Greek alphabet. When the Greek alphabet has been used through, the chapters shall be designated as Alpha Beta, Alpha Gamma, and so on through Alpha Omega; and as Beta Gamma, Beta Delta, and so on through Beta Omega; and Gamma Delta, Gamma Epsilon, and so on through Gamma Omega; and Delta Epsilon, Delta Zeta, and so on through Delta Omega; and Epsilon Zeta, Epsilon Eta, and so on through Epsilon Omega; and Zeta Eta, Zeta Theta, and so on through Zeta Omega, etc. The combination of Alpha Alpha and Beta Beta shall not be used. When the Greek alphabet has been used through Psi Omega, the chapters shall be designated with two

Greek letters in reverse order: Omega Psi, Omega Chi and so on through Omega Alpha; and as Psi Chi, Psi Phi and so on through Psi Alpha; etc. Prior to 2015, Bylaws prohibited the combination of letters in reversed alphabetical order (e.g. Beta Alpha) to be used to designate chapters.

The Chancellor brought to the floor **Bylaw Amendment #3** (proposed by Jodi Schoh/Board of Directors): To amend Bylaw Article XIV, Section 5 to allow the Board of Directors to align discipline of a chapter with the university discipline.

An amendment to the proposal was moved by Chicago Alumni and seconded by Zeta to add text at the end of the proposed new Section 5 stating "Additional ninety (90) day periods may not exceed a total of sixteen (16) consecutive periods (4 years), at which time the chapter shall be removed from probation, or shall have its charter revoked per article XIV, Section 6 of the bylaws." The amendment failed to be approved by a simple majority.

The **original proposal for Bylaw Amendment #3** was then **adopted** by approval of over 2/3 of the delegates.

Article XIV, Section 5 of the Bylaws will now read:

Section 5. Suspension of Chapters --- The Board of Directors may, by a two-thirds (2/3) vote, suspend a chapter's activity for a period of ninety (90) days. A suspension may be renewed for additional ninety (90) day periods by the unanimous vote of the Board of Directors.

The Chancellor brought to the floor **Bylaw Amendment #2** (proposed by Joe Ward and Andrew Sawa/North Central Province): To amend Bylaw Article VI, Sections 4 and 8 to replace the current National Alumni Development Committee with an elected National Alumni Chapter Committee.

Bylaw Amendment #2 then **failed** to gain approval of over 2/3 of the delegates. Article VI, Sections 4 and 8 of the Bylaws will remain unchanged.

Kromberg confirmed 226 delegates were present and eligible to vote.

Chancellor Hultz then moved into the Ritual Proposal. These minutes are purposely vague in places to honor the secrecy of Ritual. Refer to the "Confidential 50th Grand Chapter Congress Ritual Proposals" for additional specifics.

The Chancellor brought to the floor **Ritual Proposal #1** (proposed by Pi Tau): To remove Part I in its entirety.

An amendment to the proposal was moved by Pi Tau and seconded by Xi Omicron to retain Part I but remove some of its content. Ibe spoke on behalf of the board in favor of the amended proposal. Standing rules of debate were suspended unanimously and continued to 35 minutes. Dallas Area Alumni moved to extend debate for an additional 10 minutes. The motion was seconded by Long Beach Pier 9 Alumni. The motion to extend failed. The amendment was adopted by a simple majority.

The **amended Ritual Proposal #1** then **failed** to gain approval of over 3/4 of the delegates. Part I will remain unchanged.

At the suggestion of the Chancellor, Shepherdstown Alumni moved to refer the research (including consultation with the Provincial Councils) of Part 1 of the Initiation Ritual to the Board of Directors with a report, including recommendations, due back to the 2017 Grand Chapter Congress. The motion was seconded by Sigma Phi and approved.

Chancellor Hultz recessed the meeting at 4:18 p.m.

Friday, August 14, 2015

Chancellor Hultz reconvened the Grand Chapter at 8:02 a.m., Friday, August 14. Schilling made announcements.

Credentials Chair Kromberg certified 225 delegates present and voting.

Nominations Chair Chiacchiari noted there was one candidate withdrawal from the floor:

Theta Pi moved to close nominations, second by Lambda Xi. Motion carried.

The meeting was then recessed at 8:15 a.m., after which caucuses for Grand President and Vice President-Finance were held.

Saturday, August 15, 2015

Chancellor Hultz reconvened the Grand Chapter at 8:31 a.m. on Saturday, August 15, 2015. Schilling made several announcements.

Kromberg gave a supplementary credentials report and certified 223 voting delegates on the floor.


Ibe and Chiacchiari then presented thanks and testimonials of service to Grand Officers, staff, committee chairs and others.

Additional testimonials were presented by many members. (Refer to Testimonial Addendum).


