Candidates may begin campaigning once their candidate information is published in this beacon, updates to which will be made by the end of the day each Friday. Once nominations for any given open position are closed, chapter presidents from all voting eligible chapters will receive the full candidate listing. Inclusion in this report means the Nominations Committee has confirmed the candidate’s eligibility.

All candidates are required to hold a current Certified Deltasig Leader Tier 2 credential in order to be eligible for election. While CDL is not required to be confirmed as a candidate, the CDL status of each candidate is listed, and any candidates not completing CDL requirements prior to the election will be disqualified at that time. For more information, to check your CDL progress, or to complete or renew your certification, visit [dsp.org/BeACDL](http://dsp.org/BeACDL).

The nominations form remains open and available at all times. Nominations submitted in advance of a call for election will be confirmed and reviewed if and when a vacancy is declared and nominations opened. Nominations for Grand Chapter Congress 2025 elections will be accepted through July 1, and will be published in this document. Any nominations received after July 1 will be considered floor nominations and will be made from the floor during the Grand Chapter Congress, pursuant to Fraternity Policy Section P. Floor nominees will have their Nomination Forms posted as designated at Congress.

Campaigning by those nominated by July 1 will begin earlier than floor nominated candidates. Refer to Fraternity Policy *Section O. Grand Chapter Delegates, Credentials and Voting* and *Section P. Nominations, Campaigning and Vacancies* for more details.
