Nominations Committee Reports Candidates for Grand Offices -- More Needed!

The Nominations Committee, pursuant to Bylaws Article VI, Section 1, reports its activities with respect to submitting a slate of nominees for the 52nd Grand Chapter Congress in the *Congress Beacon-Candidates Edition*. In addition to myself as Past Grand President and Chair, the committee is composed of Kathy Jahnke, Avery Moore, Brittany Salazar, and Darrick Williams. Please note that along with the nomination form, a "statement of platform" and/or "comments" is requested from candidates for office. Each candidate is required to certify they have read and understand the Fraternity's Code of Conduct and will abide by it. In addition, each candidate for the office of Provincial or Regional Vice President is required to certify that he or she complies with residency requirements per policy N.3.

All chapters are reminded that nominations will be accepted through Grand Chapter Congress. They may be submitted at any time prior to July 1, and will be published in this document. Nominations prior to Congress are *strongly* encouraged – via <u>www.dsp.org</u>. Campaigning by those nominated by July 1 will begin earlier than floor nominated candidates. Refer to Fraternity Policy *Section M. Grand Chapter Delegates, Credentials and Voting* and *Section N. Nominations, Campaigning and Vacancies* for more details.

Any nominations received after July 1 will be considered floor nominations and will be made from the floor during the Grand Chapter Congress, pursuant to Fraternity Policy Section N. An electronic "Official Nomination Form" must be completed in detail and submitted to the committee before the nomination will be recognized. Floor nominees will have their Nomination Forms posted in an area designated at Congress.
