Dear Brother Wright:

I received your communication of the 20th upon my arrival home, and also your letter written yesterday this morning.

I had luncheon today with four of the eleven men at Drake University who compose the local fraternity of Alpha Kappa Tau. All of the members of the organization are Gentiles, and the four which I interview appeared to be splendid men. The majority of the men are engaged in some commercial pursuit while attending the University. For instance Mr. Albert Guggedahl holds the position of Assistant Secretary of the Rotary Club of Des Moines, another member has been four years with the advertising department of the Des Moines Register-Tribune, another with a printing company here and several others with the Flynn Dairy Company of this city. The men who were unable to attend the luncheon today were apparently home on a vacation. Those whom I did meet seemed very much interested in the field of business. One of their group is a member of Phi Alpha Delta, professional legal fraternity as he graduated from the Law College at Drake before entering the College of Commerce & Finance. The men range in age from 18 or 19 to 25 or 26. Approximately nine men, I recall, graduated last year leaving eleven active men to carry on the work this semester. Professor Hoffman is the Faculty Adviser of the Group and was present this noon. The group hat taken in no faculty members or honorary members as yet, feeling that, with regard to the latter, it would be better to wait until they became national.

About twenty-five of the 210 students registered in the College of Commerce & Finance at Drake are women.

Last June was the first real commencement of the College of Commerce & Finance, and at this time twenty-five, roughly speaking, graduated. You will note that Alpha Kappa Tau had nine out of this group on the graduating roll. You will note also from the university Record that the college was first organized in the fall of 1919, and therefore we could not expect a graduating class until 1922 at least.

I do not think that the faculty of this college is a very strong one. You will note further from the list of faculty members as given on page four of the Record that there are only about four or five men actually engaged in teaching pure commercial subjects, the remainder being filled in from other colleges. It also should be pointed out that the Dean of the college is apparently a professor of law, and there is a possibility that he knows little of the problems confronting colleges of commerce. It is upon him that we must look for the future growth of Drake University and incidentally the growth of a chapter of Delta Sigma Pihere.

They are planning to take in more members at the end of this semester which will be around February 1st, and I am fairly certain that they will petition our organization at this time. I am in favor of considering this group favorably. I do not think that it would be necessary to a present any one else here to look over the situation, for I am sure they will present a petition soon. If you choose, however, it might be wise to send someone from Epsilon to inspect the entire group after their petition has been receive in February.

I will not be leaving Des Moines until Wednesday morning of next week. If, therefore, you have any other duties for me to perform, let me hear from you at any time before this date.

SUDJECT: Drain University

In Jamuary 1922, we received a petition for Alpha Kappa Tau, a local commerce fraternity at Druke University, Des Heines, Ious, signed by twenty-one petitioners all taking courses in commerce at Druke. This potition was never presented to the Board of Directors because of the fact that it was disapproved by the Chairman of the Extension Committee who felt at that time that the courses offered in Business at Druke were not quite up to the standard that they should have been.

This local organisation, Alpha Rappa Sau, has not reopened the subject for they feel that the sources new offered at
Drake and the standing of the University are of sufficient calibre
for us to give favorable consideration to their potition. This
matter has been investigated by the Chairman of the Extension
Cornittee, Brother Hoyt, who concurs in this opinion but before we
give this local group any encouragement, or before we cond investigators to negotiate with them, it is the desire of the Chairman of
the Extension Consists to get the approval or disapproval of the
Board of Directors toward the establishment of a chapter of Dalta

Brief History of Alpha Kappa Tau

Alpha Kappa Tau fraternity was organized at Drake University in the fall of 1920, and the organization was completed in January 1921.

A platform, constitution and by-laws were drawn up by the charter members, at that time, and the same were approved by the committee on organizations of the University.

The eight students, named by the faculty members of the school, who formed the charter group, were:

Douglas Billings Hawley E. Collins Henry F. Dodds Leon A. Garber Arthur R. Howe Ellis P. Smith Frank L. Staves Harry C. Winslow.

The first officers were: Henry F. Dodds, President, Douglas Billings, Vice President, Harry C. Winslow, Secretary-Treasurer.

During the same year, six additional members were taken in, bringing the chapter membership to fourteen.

In the fall of 1921, nine members were back in school; eight men were admitted to membership, total of seventeen.

In September 1922, eleven members were back in school; six men were initiated, again bringing the chapter membership to seventeen.

At the first meeting of the fraternity in October, 1923, six active members were in school. Seven men had completed their work for B. C. S. degree, and three did not return to school. Six men were immediately pledged and later initiated. By resolution, plans were made at that meeting to take in more men during the last half of the year. This has been carried out, with the pledging of seven men at the beginning of the second semester of school. The total membership, now in school, is nineteen.

Alpha Kappa Tau Platform

We recognize that industry and its organization occupies a place of prime importance in our civilization. We believe in the practical introducation and application of commercial science to industry.

We believe in the College of Commerce and Finance of Drake University, and believe the college prepares its students in a qualified manner to promote industrial efficiency, thus fitting them to better serve their fellowmen.

The criterion for admission into this organization shall be primarily a standard of scholarship, fellowship, and leadership. We believe that such an organization of students will tend to promote and develop those ideals of intellect and attributes of character which will directly assist us in our professional work.

We believe in fellowship as an attribute which gives a student the proper viewpoint on life and places him in proper harmony with the human and material components of civilization. It is the necessary part of the character of every broadminded man, and the trait of character which causes him not only to appreciate but to conciliate true friendship among those of all professions.

We believe in leadership. We believe that proper interest and participation in school activities should be the aim of every student, not as a privilege but as a duty. We may thereby ascertain the appreciation and loyalty of a student to his Alma Mater, and judge his viewpoint of life.

Upon these principles in which we believe every broadminded student will concur; which we believe will gain the respect of all students and non-members; and which will determine its standing in Drake University, the honorary commerce fraternity of Alpha Kappa Tau is founded.

Alpha Kappa Tau Constitution and By-Laws

(In Brief)

"The purposes of this organization shall be to promote higher standards of scholarship, closer fellowship, and greater interest in all university activities.

"A regularly enrolled student who has completed a year's work in the College of Commerce and Finance is eligible to membership upon recommendations by the Dean of the College and upon unanimous secret ballot by all members present at any regular meeting of the fraternity, provided his cholastic standing places him among the first 25% of the sophomore class, or 30% of the Junior class, or 35% of the Senior Class.

"The Dean of the College of Commerce and Finance shall be an honorary member of this organization, acting as well in the capacity of faculty representative. At least one other faculty members the college shall also be designated as a faculty representative.

"The regular meetings of the fraternity shall be held biweekly, beginning on the first Tuesday in October and continuing throughout the school year. Special meetings may be called by the President upon request of twenty five per cent (25%) of the active members".

The Initiation Fees are \$9.30, including the cost of a badge. Special assessments may be made for college publications, etc., upon a vote of the fraternity.

By adoption of resolutions, rulings, and precedents, the following are in effect with respect to Alpha Kappa Tau:-

1. Only male students are eligible to membership,

2. Only Gentile students are eligible,

3. Dinner meetings with the alumni invited are held downtown once each month,

4. A committee of three chosen by the President to attend Council of Members' Meeting of the Des Moines Chamber of Commerce,

5. A like committee to attend Des Moines Ad Club.

THE COLLEGE OF COMMERCE AND FINANCE.

The School of Commerce, Finance and Journalism of Drake University, was established in the fall of 1919. In April 1923 the name was changed to the College of Commerce and Finance, the courses in journalism being transferred to the College of Liberal Arts.

The first Director of the School was Reid S. Fulton, A.M., followed in June 1921 by Arthur Albert Morrow, A.B., J.D., who in April 1922 became the first Dean of the College.

The first faculty of the school consisted of three professors who devoted their entire time to instruction in commerce courses. Professors primarily connected with other colleges offer courses open to students in Commerce, particularly courses in economics, english, mathematics, political science, contracts, agency, sales, bills and notes.

A regular four year course leading to the degree of Bachelor of Commercial Science, and a two year course grating a Certificate of Proficiency were offered during the first year of the School. The latter course was eliminated in 1920.

Upon the basis of the four year course for B. C. S., the courses offered werefurther outlined in 1921 and 1922 requiring students to follow definite schedules for the first, second, third and fourth years. However, students may in addition elect other courses to complete the one hundred and twenty hours required for graduation.

The enrollment during the first year, 1919-1920, totalled 125 students, of which 100 were men.

From June 1920 to June 1921, the enrollment numbered 191, of which 34 were women, 24 unclassified adult, part-time students, and 13 were enrolled for the secretarial courses only. The actual enrollment was therefore 154.

From June 1921 to 1922, 155 men and 25/were enrolled for their entire college work in commerce.

From June 1922-23, the enrollment increased to 206.

So far this year of 1923-24, 210 students have enrolled in the College of Commerce. With new students entering with the beginning of the second semester on February 4, 1924, the total for the year will show a considerable increase over past years.

Brief Historical Sketch of Brake University

Drake University was founded in 1881, under the leadership of Daniel R. Lucas, George T. Carpenter, the first President and Chancellor, and General Francis Marion Drake, former Governor of Iowa, and for whom the university was named.

The institution by the action and repeated expressions of its founders is independent of ecclesiastical control, but it is under the auspices of the Disciples of Christ, a democratic religious communion. The purposes of the institution were clearly set forth in a preliminary announcement of the university:-

"This university has been designed upon a broad, liveral and modern basis. The articles of incorporation provide that all its departments and immunities shall be open to all without distinction of sex, religion, or race. In its management and influence it will aim at being Christian without being sectarian".

Nine building provide facilities for work in the various departments of the university. The value of these buildings is approximately \$800,000.00.

The university is located in the heart of "University Place". The campus is beautified by natural trees, and artificially arranged flower beds. It is crossed by winding walks and drives.

Located at a short distance from the campus is the athletic field, the Brake Stadium, a natural bowl, and considered one of the finest in the country. It has a seating capacity of ten thousand, with space for enlargement. The Drake Relays are held in the Stadium each year.

Financially, the university is provided with a permanent endowment of more than \$900,000.00, and the fund is growing.

Academically, the university has been placed in the first class by the Carnegie Foundation for Advancement of Teaching, United States Bureau of Education, Association of American Universities, North Central Association of Colleges and Secondardy Schools, and by the Iowa State Board of Education Examiners.

Athletically, the university is a member in good standing of the Missouri Valley Association, and its athletic record is on par with the schools of the association. The enrollment in the university totals 2200-2300 annually; and its graduates number more than five thousand.

The University is composed of six distinct colleges:----

- College of Liberal Arts:
