
HISTORY OF SACRAMENTO

Sacramento, California, is geographically located at the confluence of the Sacramento and American Rivers and is the capital of the most populated state in the union. In 1839 John Augustus Sutter, a Swiss-American adventurer, founded Sutter's Fort. This was the first permanent settlement in the Sacramento Valley, the fort being located in the present city of Sacramento. In 1860 Sacramento became the western terminal for the Pony Express, and was soon to become the hub of the first transcontinental railroad in 1869. With the advent of rail transportation into the area, the future of Sacramento was assured.

Known for it's beauty and dynamic growth, the Camilla City, Sacramento has played a more important part in the history of the state than any other city within the borders of California. Embracing in her confines the most precious gifts of the lofty Sierras and the foothills at their base-- and not the least of these, the fertile alluvial soil washed down from their hillsides and canyons to fill up the inland sea of which she once was a part, making her a second Valley of the Nile, no whit inferior to the original in fertility and productiveness--she is almost without a peer. But the mountains and foothills were not niggardly in their magnificent gifts, for in addition to the splendid soil so given, they sprinkled it literally with golden dust and nuggets that enriched many a one of the Argonauts and the generations who succeeded them.

Today 1963, however, Sacramento has a much more stronger base than that of gold; it's foundation is continually being built upon by new commerce and industry. Large corporate organizations have selected Sacramento to bury their roots and sprinkle the seeds of economic strength. The city like a strong rose vine is spreading out in all directions, adding new areas and removing old downtown slum areas, only to replace them with modern productive facilities.

Once the jumping-off point for gold miners to the north and east, Sacramento is now the center of Northern California's commercial and industrial productivity. By the end of this year large ocean going vessels will steam up the new channel to distribute and take out Sacramento's vast agricultural and manufactured goods to feed the less fortunate dwellers of the world and to spread the fame of her wealth.

THE HISTORY OF SACRAMENTO STATE COLLEGE

Located on the east side of the city of Sacramento and close to the banks of the American River, Sacramento State College educates and serves the people of California's growing state capitol and neighboring counties. Sacramento State College was created by the California State Legislature in June of 1947. A report of a state-wide survey of higher education had recommended that the college be established in Sacramento, yet be designed to serve the lower Sacramento Valley and surrounding area.

The story of Sacramento State College is the story of rapid but orderly growth in the fifteen year period since it was founded. Initially the college offered course work in the junior and senior years only, while utilizing classrooms and facilities of Sacramento Junior College. In 1949, new legislation authorized the college to extend its offering to the full four year undergraduate program. The college was then under the control of the State Board of Education and subject to the laws and regulations governing California State Colleges. Land for an independent campus was later purchased on the east side of Sacramento. Construction of the first stage of campus buildings, following the master plan for a modern integrated campus complex, was completed in the spring of 1953. The first freshman class was admitted in the fall semester of 1954.

Since then the college has grown substantially both in

educational program and physical plant. From the 100 students, who first enrolled in 1947, last fall's enrollment reached a record of 7,274 students. Of these students 4,505 are full-time regular students and 2,769 are part-time or limited students. From the first limited course offerings in only selected fields, Sacramento State College now offers a bachelor's degree in 40 different liberal arts and professional fields ranging from anthropology to zoology. Master's degrees are awarded in 15 different areas of study. Within the near future, it is anticipated that joint doctoral degrees will be awarded in cooperation with the University of California. In 1947, when Sacramento State College first opened its doors, the staff included only four full-time instructors and 27 part-time staff members. Today the faculty is approaching 400, of which 325 are teaching on a full-time basis. The academic reputation of Sacramento State College rests squarely and securely on the shoulders of these competent and talented people. In today's competitive market for teachers with the doctoral degree, Sacramento State College boasts a faculty of which over 50 per cent possess the doctorate. The national average of all U.S. colleges and universities does not exceed 40 per cent.

The campus of Sacramento State College represents an investment of approximately \$25 million. Recent additions have included an engineering building and art center. A three story, 80,000 square foot library serves the students and faculty. Sacramento State's campus also serves the community.

The new art building provides a permanent art gallery for student, faculty, community, national, and international exhibits. The music and drama departments present outstanding shows throughout the year. The business administration division hosts an annual management conference, which this year was attended by over 400 leading executives from throughout the area. Every year the social science department conducts a public forum on major public issues, with outstanding speakers from government circles and the academic world. Sacramento State serves its community, as each year it plays host to dozens of institutes and special instructional programs, workshops conferences, and conventions.

Today Sacramento State has students from almost every county in California, as well as over 100 from nations around the world. The college draws its students from the top 37% scholastically of the high school graduates in California, which will soon be lowered to the top 33 per cent. This is a more rigorous standard than that maintained by many of the well-known major colleges and universities of the country. Requirements and standards are continuously being tightened to further the rise of the academic level of the college. Today's entering freshmen exceed the national freshmen college average in intelligence and aptitude. The men students have an overall grade point average of 2.48 and the women average 2.52.

Today Sacramento State College is one of the eighteen

state colleges supervised by the trustees of the California State Colleges, a board created under legislation approved by the governor in April of 1960. This board now provides the colleges with a new and important measure of autonomy. The college is fully accredited by the Western College Association, the regional association that accredits colleges and universities in California and other western states. Credits are thus readily transferable to other accredited colleges and universities in California and in the United States. The college is also accredited for teacher education by the State Board of Education and the National Council for Accreditation of Teacher Education.

Under the leadership of president, Dr. Guy A. West, Sacramento State College can look proudly to its progress over the relatively short space of fifteen years, and to the prospect of an ever expanding role in the future.

HISTORY OF THE DIVISION OF BUSINESS ADMINISTRATION

The division of Business Administration was one of the original six divisions of study when Sacramento State College was founded and started instruction in 1947. The first semester offered twelve units of business courses. Daniel D. Gage, Ph. D., and Merrell W. Skeels, C.P.A., were the first full-time instructors on the Division's staff. In 1949, Dr. F. Blair Mayne was appointed chairman of the Division of Business Administration. In 1952, Dr. Mayne was elevated to Executive Dean of the College, and also continued to serve in his position as chairman of the Business Division. By 1949, the business administration program offered thirty-five courses of study. In 1954, Dr. Mayne assumed the full-time role as Executive Dean, and Dr. William R. Blockler was appointed as the new chairman of the Business Division. In 1956, Dr. John R. Cox became chairman of the Business Administration program, a position he held until 1963, when Dr. Mayne was promoted and Dr. Cox became the new Executive Dean. The new chairman of the Business Division is Dr. Herbert J. Chruden.

The Business Administration Division of Sacramento State College has had a history of excellent leadership, a fact attested to by the promotions of its division chairmen to high-level administration positions of the College. The Division's faculty is equally outstanding. Today there are twenty-six full-time instructors and a number of part-

time teachers drawn from the academic world and business. A number of leading textbooks in the field of Business Administration have been written by staff members. A majority of the instructors possess doctorate degrees; five are C.P.A.'s and two are lawyers.

The Division's students are drawn from many areas. Today's full-time and part-time enrollment of over 900 consists of recent high school graduates, veterans, military men, foreign students, and business executives from the surrounding metropolitan area. Sacramento, as seat of the state government of California, has given the business division a tremendous government and industrial complex to draw upon for study and education.

Business Administration students enjoy classes in a modern, two-story building, complete with accounting laboratories, research facilities, lecture rooms, and faculty offices. In the near-by Social Science building, two large rooms of business machines are available for classroom instruction and research use. As the campus expands more facilities will become available for the use of the Division. The third floor of the library contains the Business Administration and Social Science Department. Reference works, professional journals, and periodicals, and volumes of all types pertaining to business are available.

The Division of Business Administration also has a Bureau of Real Estate Research, whose job and function has

been expanding by leaps and bounds. In fact, it could more aptly be called the Bureau of Business Research. The current project, now nearing completion, is an exhaustive study of the Metropolitan Sacramento single-family housing market. The project is conducted under the auspices and financial support of the California State Division of Real Estate. Over 1,200 personal interviews and extensive market analysis make this study one of the largest of its kind ever undertaken. Next year's project will entail a study of the economic impact of the soon-to-be-completed, Sacramento Deep Water Channel, a channel that will bring ocean-going ships directly from San Francisco Bay up the Sacramento River to Sacramento. A number of faculty research projects are underway, which give students an opportunity to work as research assistants.

The current curriculum of the Business Division offers degrees of Bachelor of Science and Master of Science in Business Administration. The following academic areas of concentration are offered: Accounting, Finance, Industrial Management, Marketing, Personnel Management, Secretarial Administration, and General Business. Soon to be offered will be a program in Real Estate and Insurance. A minor in Business Education is also offered. The division currently offers some seventy courses in business on the undergraduate and graduate levels.

The outstanding faculty and administration of the

Division coupled with the success of its graduates gives the Division of Business Administration a reputation to be proud of. Currently the Division has applied for membership and additional accreditation in the American Association of Collegiate Schools of Business. If application is successful, the Division can be even more proud of the progress it has made in the short space of fifteen years.

HISTORY OF DELTA SIGMA CHI

During the fall semester of 1960 an interested group of students in the Division of Business Administration at Sacramento State College, met with a national representative of the International Fraternity of Delta Sigma Pi to discuss the formation of a business fraternity on campus. Enough enthusiasm was generated and a chapter was formed, however this chapter did not apply for a national charter. There were 18 members and the chapter continued in operation through the spring semester of 1961. During this time the organization held many meetings and had a number of guest speakers. The leaders of this chapter were seniors and graduated in June 1961. Apparently when these leaders left the campus they took with them the enthusiasm of the chapter, for in the fall of 1961, there was not sufficient interest and the chapter died a quick death.

On February 19, 1963, a meeting was held when a small group of students expressed an interest in re-activating the Delta Sigma Chi chapter. During the remainder of February several meetings were held to orient new students with the objectives of Delta Sigma Chi. The following officers were elected: President, Dale Brinsley; Senior Vice-President, Ken Marques; Vice-President, David Swidrak; Secretary, Jeff Cowan; Treasurer, Roger Peake; Chancellor, Bill Nelson;

Historian, Walter Barns. Dr. H. Nicholas Windeshausen, a Delta Sigma Pi member, was asked to be faculty advisor to the chapter and expressed genuine interest in assisting the chapter. On March 8, 1963 the members decided to apply to the International Fraternity of Delta Sigma Pi for a national charter. On March 12, 1963, re-activation papers of Delta Sigma Chi were turned in to the Board of Directors of the Associated Students of Sacramento State College and were subsequently approved. At the same time plans were made for the national charter application, committees were appointed and the plans were put into motion.

On March 19, 1963 the pictures were taken for the charter application, money for dues was collected, and work was reported to be progressing very satisfactorily. As plans to go national progressed we found there was an increasing number of new inquiries from fellow students and at the present we have approximately 30 members in attendance.


International Fraternity of Delta Sigma Pi Sunday installed the Epsilon Phi Chapter of the Division of Business Administration at Sacramento State College.
