HISTORY OF TENNESSEE

There is a tradition that some Welshmen landed at the site of Mobile, Alabama, and came up into the Tennessee country in the eleventh century. However, the first Europeans to visit Tennessee probably were Spaniards, members of the expedition (1539-1544) of Hernando de Soto, which passed through lower East Tennessee and later crossed the Mississippi River at or near the present site of Memphis.

The Spanish did not attempt to colonize the area, and more than a century later the British and French entered into a long and bitter struggle over the region. King Charles II of England included the Tennessee country in the Carolina grants of 1663 and 1665. However, the first Englishmen to visit the region were James Needham and Gabriel Arthur of Virginia who came to East Tennessee in 1673. In the same year two Frenchmen, Jacques Marquette and Louis Jolliet, landed at the site of Memphis while on a voyage down the Mississippi River. This rivalry between the British and the French for control over the eastern part of the Mississippi Valley reached a climax in the French and Indian War, with the British victory extinguishing the French claim.

During the Revolution the future Tennesseans repelled Indian attacks and participated in some campaigns against the British and Tories, the most important engagement being the Battle of King's Mountain in October, 1780, which was the turning

point of the war in the South. In the meantime, North Carolina, within whose charter bounds Tennessee was, formally annexed the region. North Carolina held this western region until 1784, when it ceded its claim to the United States. Encouraged by a congressional ordinance authorizing the creation of new states, the people of the eastern part of the ceded region organized the State of Franklin, with John Sevier as governor. Even though North Carolina repealed the cession before it could be accepted, the Franklinites attempted to maintain themselves as a separate state. Failing to gain recognition from the United States or North Carolina and handicapped by Indian troubles, fruitless intrigues by Sevier with the Spaniards of Florida and Louisiana, and dissension within its own ranks, the state collapsed within four years, and North Carolina re-established its jurisdiction in 1789. Later in the same year North Carolina, after belatedly ratifying the U.S. Constitution, again ceded to the United States the Tennessee country, and in 1790 that area was organized as the "Territory South of the River Ohio," commonly called the Southwest territory, with William Blount as governor. With the meeting of a territorial assembly in 1794, the Tennessee region became the first territory to reach the second, or representative government, state under the provisions of the Northwest Ordinance. It was also the first territory to send a delagate--Dr. James White--to the U.S. Congress.

On June 1, 1796, Tennessee became the sixteenth state--the first to have been admitted to the Union, after having passed

through the pre-statehood period of territorial government. In becoming a state it followed what later became known as the "Tennessee Plan," in that it adopted a state constitution, elected a state legislature, a governor (John Sevier), and two senators, and put the state government into operation under the constitution several months before Congress passed the statehood act.

During the War of 1812 Tennessee furnished soldiers far in excess of its quota. These troops engaged in much Indian fighting and displayed such valor in the Battle of New Orleans that the state became known as the Volunteer State. During the half century after 1815, Tennessee showed great progress in railroad building and in state banking ventures. It was also the home of three U.S. Presidents: Andrew Jackson, James Polk, and Andrew Johnson.

Following the election of 1860 and the secession of the first group of Southern states, Tennessee refused to call a convention to consider secession. However, after the firing on Fort Sumter and the beginning of the Civil War, a secession sentiment swept over the state and on June 8, 1861, the people of the state voted their overwhelming approval of separation from the Union. East Tennessee, however, where slavery was less important than in the other two sections, voted against secession and attempted unsuccessfully to form a separate state.

Next to Virginia, Tennessee was the leading battleground of the war, with more than 450 battles and skirmishes being fought within the state boundaries. Tennessee furnished about

145,000 troops for the war, more than any other southern state, but 30,000 of them fought for the Union.

When the Union troops occupied Middle and West Tennessee in 1862, President Lincoln appointed Andrew Johnson military governor of the state. On March 4, 1865, Johnson relinquished this post to become Vice President of the United States, after having arranged for the restoration of civil government in Tennessee. Under the leadership of Governor William G. Brownlow, Tennessee, which had been the last state to secede, was the first state to be readmitted to the Union, following its ratification of the Fourteenth Amendment in July, 1866. It therefore escaped the harsh program of military reconstruction applied by Congress to the other ten states of the Confederacy.

Following Reconstruction Tennessee participated actively in the move toward industrialization which characterized the "New South." This was particularly true of the eastern section of the state, although Nashville and Memphis also became extensively industrialized. By 1900 the state had more than 3,000 industrial establishments, and the value of manufactures had grown from \$18,000,000 in 1860 to more than \$92,000,000.

A prohibition movement had swept the state after the Civil War, and by means of a gradual extension of the "Four Mile Law" of 1877, which prohibited the sale of liquor within four miles of an incorporated school, secured the enactment of state-wide prohibition in 1909.

As had been the case in the Spanish-American War, in which

the first shot was fired by a Tennessean (Com. Washburn Maynard of the gunboat Nashville), during World War I the Volunteer State maintained its military tradition. Several of its National Guard units, consolidated with others from North and South Carolina, comprised the famous "Old Hickory" Division, named for Andrew Jackson. These and other troops including those raised by selective service, served with distinction. The state contributed a total of 100,000 men to the armed forces.

Tennessee, like other states, suffered severely from the Depression, with a prolonged drought accentuating distress in agriculture. A total of 353 business establishments closed their doors in 1931. Education suffered acutely, with teachers being paid in warrants, and state and local appropriations were greatly reduced. The state's emergence from the Depression was aided materially by the creation in 1933 of the Tennessee Valley Authority (TVA).

Tennessee's contributions in World War II were outstanding. In addition to housing the Manhattan Project for the manufacture of the atomic bomb at Oak Ridge, Tennessee was the site of several other important defense industries, such as the Du Pont powder plant near Millington, the Consolidated-Vultee Aircraft Corporation at Nashville, and the Proctor and Gamble shell-loading plant at Milan. Training camps for the armed forces included Camp Forrest near Tullahoma, Camp Tyson near Paris, and Camp Campbell near the Kentucky-Tennessee line.

A major problem facing the state today is the need for a

reapportionment of seats in the state legislature to provide more equitable representation of urban areas. Despite the state constitutional requirement for reapportionment every ten years, no act for that purpose has been passed since 1901. In 1961 a lawsuit designed to bring about a reapportionment was brought before the U.S. Supreme Court.

Memphis, county seat and port of entry of Shelby County, Tennessee and the largest city of the State, is situated on the Mississippi River in the southwest corner of the State. On the Fourth, or Lower Chickasaw Bluff, east bank of the Mississippi River, the city flattens out from its 40-foot elevation to the black cotton lands and the rolling forested country of the Wolf River on the north and east and Nonconnah Creek on the south. Its position on the banks of a great river that like the Nile flooded the delta lands each spring made the name Memphis an appropriate choice.

The history of Memphis, for all practical purposes, began in 1541, which marks the date when the Spanish explorer Hernando De Soto is believed to have seen the Mississippi River for the first time. Later, toward the end of the seventeenth century, the first permanent settlement on the site of Memphis was established by the French who built forts near a Chickasaw Indian village visited by De Soto and the region was occupied alternately by the French and Spanish until the British took possession after the French and Indian War. A town was founded on the site in 1819, incorporated in 1826, and chartered as a city in 1849.

During this time Memphis was being settled rapidly, chiefly by North-of-Ireland Scots, Scotch Highlanders, and Germans from East and Middle Tennessee, who had come originally from North

Carolina, Virginia and South Carolina. Among the first industries were gunsmithing and blacksmithing and by 1830 stores, repair shops, and sawmills were operating with cotton warehouses and mills following. In 1850, because of its central position on the Mississippi, Memphis was designated as a port of customs and though fires, explosions, river piracy, collisions, and wrecks made shipping and travel by steamboat hazardous, packet lines prospered, and Memphis became one of the busiest ports in the United States.

At the beginning of the Civil War, the city was an important commercial center and following a Union naval victory on June 6, 1862, the city was occupied by Union troops and held by them for the duration of the war. Following the war, during the 1870's, Memphis was ravaged by epidemics of yellow fever but recovered completely in the next decade, after the installation of numerous sanitary improvements.

The immediate aftermath of the epidemics in the city was worse than the dismal days of Reconstruction. Surrendering its charter to the State, Memphis was made the Taxing District of Shelby County. Then trade boomed and by 1890 Memphis had grown in population to 65,000 and three years later in 1893 the State restored the charter.

In 1892 the first railroad bridge across the Mississippi south of St. Louis was built at Memphis, followed by the Harahan Bridge in 1909. These bridges brought increased trade with the Southwest, and Memphis soon became the greatest inland

cotton market and hardwood lumber center in the world.

In 1909 the commission form of government was adopted under which system all the functions, both executive and legislative, are placed under the jurisdiction of a board of commissioners, each elected for a term of four years, one of whom is the mayor.

The Mississippi River floods in 1927 and 1937 imposed upon Memphis the huge task of providing for refugees from the lowlands overflowed by the river.

In 1934, Memphis became the first city in the nation to create and completely equip a motor vehicle inspection bureau. Every motor vehicle in the city must undergo inspection for mechanical defects. Due to these inspections, safety engineering and the increased interests in traffic safety, Memphis was awarded the title of the Nation's Safest City for 1937. This honor was won again in 1941.

Memphis was given top honors in the Inter-Chamber Public Health Contest for 1939, 1940, 1941, and 1942. The National Fire Protection Association gave Memphis awards for fire prevention in 1937, 1938, 1939, and 1941. In 1937 and in 1938 the Chamber of Commerce of the United States recognized Memphis as the "first city." In 1948, 1950, 1951, and in 1961, Memphis was named the Nation's Cleanest City by the National Clean-Up, Paint-Up, and Fix-Up Bureau--the first city to win the award four times.

Today, Memphis ranks twenty-second in the nation in total

population and among the twenty-five largest cities only six had great percentage gains in population during the last decade. With transportation facilities including eight railway systems, eighty-nine motor freight lines, eleven bus lines, four barge lines, and seven air lines and because of its central location and other advantages Memphis is the metropolis of an area comprising parts of six states.

The Memphis trade area, composed of more than 286 counties, last year reported sales of almost eight billion dollars and effective buying income of more than eleven billion dollars. Within its metropolitan area there are approximately 800 manufacturing enterprises with industrial employment ranging up to 50,000 persons.

In addition, the city is the site of a number of outstanding educational institutions which include fourteen colleges and universities, the home of approximately 650 churches and boasts of the South's largest and best equipped medical center which ranks among the finest in the world.

This then is Memphis, a city not only justly proud of her past but ever progressive and anxiously eyeing the future and the role it will play as the Leader of the New and Emerging South.

HISTORY OF CBC



The brothers of the Christian Schools, better known in the United States as the Christian Brothers, are a religious congregation of the Roman Catholic Church. The society was established in 1684 by St. John Baptist de la Salle, a man who popularized the simultaneous method of teaching and the use of the vernacular in education. All the members of the organization are teachers; they have been extensively and intensively trained and educated for that purpose.

The brothers conduct 1,347 schools with 350,000 students in 64 countries of the five parts of the world. Of these, 41,000 students are in 98 schools in the United States, and of these 98 schools in the country, Christian Brothers College of Memphis, Tennessee, is the one making the most rapid advances as a college.

At the request of the Most Reverend Bishop Feehan and the Reverend Clergy of Memphis, Brother Maurelian of the Christian Brothers was called from Christian, Mississippi, to open a college for men. Christian Brothers College was therefore opened in Memphis in 1871. In 1872 the college was granted a charter by the legislature of the State of Tennessee as a degree granting institution, a charter that it holds to this day.

The college functioned as both a high school and a degree-granting institution until World War I, when the entire student

body entered the Officers Training Corps in the United States Army. College work yielded to high school work, and it was not until 1940 that college training was resumed. CBC found its Adams Street location inadequate in size and accommodations, so a city-wide building fund drive was held. Memphis citizens rose to the call and responded generously: \$175,000 was collected. Property at the northeast corner of Central Avenue and East Parkway was purchased, and construction of the present administration building was begun. This building contained the Brothers' residence, a chapel, offices, a small library and classrooms.

Christian Brothers Junior College, under the direction of Brother Ignatius Leo, started the 1940 academic year with 17 students and 14 faculty members, while the high school continued classes with 400 students. The Junior College enrollment increased slowly, until, in 1942, 53 students had enrolled for the year. But World War II chopped the number back to 16, and CBC suspended operations for the duration of the war.

After the war, the junior college reopened and was approved for the training of the veterans under the G. I. Bill of Rights. Enrollment in both the junior college and the high school increased, and in 1950 the junior college was given full accreditation by the Southern Association of Colleges and Secondary Schools.

Under the leadership of the new President, Brother Lambert Thomas, and the new Dean of Studies, Brother Levian Thomas, enrollment increased and new buildings were erected. They worked

well together with no conflicts, and under the supervision of these men CBC expanded to a full four-year curricula in business administration and electrical engineering. This was the beginning so to speak. In 1955, plans were made and carried out to include a four-year program in mechanical engineering, and a fourth year in chemistry was added in 1956.

Application was made to the United States Government for a loan to finance the construction of a dormitory, and this application was approved with construction beginning in 1956. By the end of 1957, CBC had expanded from a one building school-- in which building both high school and college classes were held simultaneously--to a college with an administration building; a gymnasium; a classroom building with extra offices, classrooms, and a student lounge; a 200 man dormitory with a lounge; and an engineering building. Needless to add, private loans were made on some of the buildings.

Also by the end of 1957, 347 titles and degrees had been presented. A summer school with a day and night division had been instituted. CBC had come a long way and was to go a long way yet.

Christian Brothers Junior College passed from existence in 1958, when the Southern Association of Colleges and Secondary Schools accredited CBC as a four-year college. The end of 1959 saw the completion of the Scholasticate, the house of studies for the student brothers. By 1960 the college had acquired facilities for presenting Bachelor of Science degrees

for majors in electrical engineering, mechanical engineering, mathematics, physics, chemistry, engineering chemistry, accounting, and marketing.

Christian Brothers College's progress during the first seventy years of its existence has been--naturally--slow. But its advancement in the last ten years has been so phenomenal that CBC holds the distinction of being the "fastest growing college in the United States."

The year 1960 saw additional growth--new classrooms were erected, along with other buildings. Consequently, tuition was raised from \$200 to \$250 per semester. The budget thus far has worked out to be moderately successful. Keeping in mind that first of all tuition must be kept low, the budget committee made studies in attempts to keep tuition and room and board at a minimum.

In 1961 the completion of the new auditorium and social hall was witnessed--thus completing the college's planned expansion for at least a year or two.

Christian Brothers College is a very young school, especially in connection with accreditation. In that sense it is only three years old. Accreditation helped CBC in more ways than one: enrollment increased rather feverishly: more students went to their various homes after academic sessions and spread the good news of CBC by word of mouth. In 1960, enrollment reached 720 students.

A change in administration was witnessed at Christian

Brothers College in 1962 with the appointment of Brother I. Terence as President. Following Brother Lambert Thomas, who was responsible for most of the physical growth at CBC, Brother Terence is continuing to expand CBC. The present 40-acre campus has proven to be inadequate to hold both a high school and the college; therefore attempts have been made to alleviate this problem with the purchase of 25 acres for the site of a new high school. The expansion of the college follows from the successful high school project. The college will take over the old high school building and will add \$300,000 to the drive in payment. In addition to the expansion into the high school building, the college hopes to have a new dormitory for 250 more men ready in September, 1965. A further look into the future would reveal new library and chapel buildings gracing the campus. This is CBC; past, present, and a look into the immediate future, concerning its physical development.

CBC is not listed in many, if any at all, of the college manuals. It is known throughout the mid-south area and in some sections of Chicago, St. Louis, and Vincennes to mention a few places; but it is practically unknown in the Ivy League states and around the--as one person aptly put it--"high pressure colleges." However, CBC is not completely unknown in other areas; drawing students from 30 states and 16 foreign countries. Enrollment has continued to grow in recent years with the present figure standing at 775 students. The administration is presently planning on 1,500 students by 1970.

Students attend CBC because of its reputation, for CBC stands up well in reputation wherever it is known. It cannot compare by any means with graduate schools, but it stands on a par with the undergraduate departments of the "high level" colleges. Graduates of Christian Brothers College are well-equipped for practically anything that might arise. Engineers and businessmen have a high regard for the type of graduate that the college turns out.

STUDENT GOVERNMENT OF CBC

In order to develop a greater sense of responsibility and to foster cooperation between the student body and faculty, the Student Government was formed in May of 1955. The Student Government acts as the official group of the student body, to make known its views, to promote its best interest with the college administration and faculty and to improve relations with other institutions and the public in general.

In addition to the coordination functions of the Student Government, it also promotes all social and cultural activities of Christian Brothers College. In order for the graduate of CBC to be a rounded individual, the student government has five areas of concentration and development: arts, athletics, publications, religious and social. Through the Student Government the students of CBC can develop in areas other than academics and hereby become more mature adults and responsible citizens.

ENGINEER'S CLUB

The Engineer's Club at CBC is open to all engineering students. It attempts to acquaint these students with the current happenings in his chosen profession. The club attempts to do this by having speakers at their monthly meetings as well as

informative meetings. In an attempt to better acquaint the public with CBC and the field of engineering, this club organizes the annual open house which is held during Engineer's Week.

INSTITUTE OF ELECTRICAL AND ELECTRONIC ENGINEERS

In the year 1963, a major step was taken in the fields of electrical and radio engineering with the formal merger of the American Institute of Electrical Engineers and the Institute of Radio Engineers into a new club, the Institute of Electrical and Electronic Engineers (IEEE).

In keeping with the activities of the national clubs, the CBC chapters of the AIEE and the IRE merged to form the IEEE. The aims of the IEEE are to acquaint the students with the practical end of electrical engineering and to assist them in selecting and planning a career.

MECHANICAL ENGINEERS CLUB

The basic aims of the Mechanical Engineers Club are to stimulate interest in the area and to educate the student in the most modern developments in his field. At the meetings, the student learns about some of the jobs available to him and new methods of engineering from both professional engineers and educational movies.

AMERICAN CHEMICAL SOCIETY

The student chapter of the American Chemical Society is composed of students of Siena and Christian Brothers College. Our chapter is relatively new, having been formed three years ago. Their meetings are held monthly, consisting of speakers in the field and field trips.

THE COMMERCE CLUB

Nov.15, 1954 May 20, 1963

The Commerce Club was formed November 15, 1954 when the students of business administration decided that they needed an organization to promote a professional program and give these men a common interest, an organization to gather around. Brother Emery of the Business Administration faculty was the first moderator. Monthly meetings were held and as a feature of these meetings a speaker would be present or a film would be shown on some aspect of the business world. In its first year it likewise held a social function, that being a dance and it concluded the year with a trip to the Firestone Rubber Plant in Memphis.

The club structure was merely a group of men, meeting to learn more of the business world. In its beginnings no dues were paid and membership was limited to upper classmen. In its second year the club matured and became more formal in its organization. In its second year the field trip went to

International Harvester Corporation and the monthly meetings continued to have speakers from the various fields of study.

In its third year the Commerce Club continued its career of bringing men of the business school together for the betterment and fulfillment of their education. During this year the motion was raised on the floor to admit freshmen members into the club, but it was vetoed; however, they were allowed to become associate members that did not pay dues nor did they have a vote.

The club assumed the responsibility of keeping the alumni notified of the school activities that would be of interest to them. This year as in past years the club sponsored the mid-term dance and once again it was a success. The field trip of this third year was to the Mallory Air Force Base where the club saw the operations of the IBM 750 computer. Also in this third year the club applied for membership to the American Marketing Association, and was accepted. The professional program was still having speakers at the monthly meetings.

Since this time there has been no major change in the organizational structure of the club. It has continued to partake in professional programs which include speakers from the Memphis area and field trips to industry of the mid-south. The club has attempted to further round out the education that is received in the classrooms, by means of practical experience.

At this time the members of the Commerce Club are petitioning Delta Sigma Pi to further educate the students of Business

Administration. The Commerce Club has served the students well; yet the members feel that through membership of an international fraternity their knowledge of business administration will be further advanced.



Christian Brothers College is said to have the best Electrical Engineering department in the midsouth area. The head of the school of Electrical Engineering is Brother L. Philip, F.S.C. In order to maintain its high standards the Electrical department has gone to great expense keeping its laboratories up to date with the changing times. It has been estimated that the engineering departments have between a quarter and a half million dollars worth of equipment of which half belongs to the Electrical Engineer Department.

In the year 1963, a major step was taken in the fields of electrical and radio engineering with the merger of the two fields into one national club. C.B.C., in keeping with the activities of the national clubs, also merged to form the Institute of Electrical and Electronic Engineers. The aims of the club are to acquaint the students with the practical end of electrical engineering. This department is the largest in the college. The number of students is two hundred thirty nine. The department uses nine laboratories and five class rooms.



ENGINEERING CHEMISTRY DEPARTMENT

The Engineering Chemistry Department at Christian Brothers College has been relatively small since its beginning. But in the last year the graduating class has jumped to five hundred twenty percent higher than ever before. Under the direction of Brother J. Edward, F.S.C., the department also has the highest number of Ph.D.'s on its teaching staff. With the full expansion of the school in 1966 the department will be able to offer a B.S. in Chemical Engineering. There are now twenty-two students in the department, of which eleven are seniors. The Engineering Chemistry Department has the use of five laboratories and five class rooms. All laboratories are located in St. Joseph's Hall and in the old high school building. The four-year program is designed to give the maximum amount of knowledge the student needs in this great field.

PHYSICS DEPARTMENT

The Physics Department at Christian Brothers College is headed by Brother J. George, F.S.C. The Physics program is a four-year program giving the student at the end of his studies a B.S. degree in Physics. The School of Physics is said to be second to none in the mid-south area. In 1960 the Physics department forms its discussion group named "The Student Section of the American Institute of Physics." The purpose of the group is to keep the members up to date on new developments in physics and to provide information on particular topics in this vast field. The Physics Department includes nineteen students and its facilities include eight laboratories and the use of fifty thousand dollars worth of equipment. This school along with others has grown tremendously in the last few years.

SCHOOL OF BUSINESS ADMINISTRATION

The School of Business Administration at Christian Brothers College is geared to prepare its graduates to accept the challenges imposed upon them by the competitive business world, by offering a Bachelor of Science Degree in Business Administration with an area of concentration in either Accounting or Marketing. The Accounting and Marketing departments are presently under the competent direction of Brother J. Alfred and Dr. Richard Deutsch, respectively.

Students of the School of Business Administration at Christian Brothers College are unique in the sense that they receive a liberal education in addition to acquiring intensive instruction in their specialized fields. This liberal approach is accomplished by requiring fifteen semester hours of philosophy, twelve semester hours of English, and twelve semester hours of history. In addition to this diversification, our program is so arranged as to enable each student in the School of Business Administration to take courses offered those in the other areas of concentration. This is to say that a student with an area of concentration in Accounting can supplement his study of business by partaking in the courses offered to those in the field of Marketing or vice versa.

In 1954, Ave Maria Hall was built to accommodate the increased enrollment brought about by the expansion of Christian

Brothers from a Junior College to a full four-year college.

With the completion of this classroom building, adequate facilities for offices and laboratories were made available.

Responsive to the needs brought about by the increased emphasis of Electronic Data Processing in the field of business, Christian Brothers College, in 1962, acquired an IBM 1620 Digital Computer and constructed a Computer Center to house this machine and its auxiliary equipment. This equipment was placed at the disposal of all students taking the computer programming introductory course. This computer system and its related courses was one of the first of its kind to be offered to students of the undergraduate level.


Accounting

The Accounting Department at Christian Brothers College is oriented toward professional attainment in the fields of public, industrial, or governmental accounting. A student with an area of concentration in accounting is required a minimum of 23 hours of upper division work with intensive study of: Advanced Accounting; Cost Accounting; Municipal Accounting; Taxation; Auditing; Corporate Finance; and Business Seminar.

Marketing

In the field of Marketing, Christian Brothers College offers a well-rounded curriculum. The student of Marketing receives

a strong foundation in general business before pushing into a vigorous program of Advertising, Transportation, Retail Management, Wholesaling, Sales Management, Research and Analysis; thus, presenting him with the total Marketing Concept.

ADDITIONAL FACILITIES

Library

The Christian Brothers College Library is an integral part of the educational program of the College. It is considered the workshop of the student and is closely coordinated with the requirements of the curriculum. The library is staffed by well-trained professional librarians whose chief objective is to see that books and information are secured quickly for those who need them.

The library collection contains approximately 40,000 volumes of books and bound periodicals. More than 350 periodicals are regularly received. In the past two years, the library has been growing at the rate of 2,000 volumes a year. In the near future, the College hopes to have a separate library building complete with all the usual departments and facilities.

Evening Division

For the benefit of the working men of Memphis, Christian Brothers College offers limited courses in the evening which lead to a degree in electrical engineering. There are 39 students presently enrolled. The courses that are offered for

credit are the following: General Chemistry, Principles of Electrical Engineering, Principles of E.E. lab, Math Analysis I & II, Physics I, and Physics I lab.

W.C.B.C. Radio Station

On the campus of Christian Brothers College, there exist a group of fifteen dedicated young men whose main objective is to transmit soft listening music. They accomplish this task through the means of a closed-circuit transmitting station which can be heard anywhere on campus and is known to the student body by the call letters W.C.B.C.

Their broadcasting schedule is between the study hours of 6:30-11:00 P.M., Monday through Thursday. W.C.B.C.'s most important school service is the broadcasting of all of the out-of-town C.B.C. basketball games.

The Public Relations Office

Among the various offices on our campus is the Public Relations Office. This is one of the most active and most influential departments of the college in relation to the graduating senior and the general public.

The Public Relations Office has three distinct functions: placement of the graduating seniors in business, coordinating alumni activities with the publication and mailing of alumni and college information, and the keeping the general public

informed through the use of the different modes of communication.

Placement is by far the most demanding of the three activities. To place the seniors in business, the Public Relations Office contacts industry and schedules interviews for the students on the campus with the personnel officers of the various companies. The office also compiles a composite of every graduating senior and sends the resulting brochure to over 850 companies and subsidiaries located in all areas of the country. The Seniors do their own thinking in relation to whom they would like to work and the actual applying for the job, but the Public Relations Office furnishes much of the information about the different companies and the methods by which the application is made. The Public Relations Office also keeps companies informed of the availability of seniors for different types of positions.

The second major function of the Public Relations Office is that of keeping the Alumni informed about school and Alumni affairs. To do this the office edits and prints the Alumni newspaper called "The Bell Tower," and sends it to all Alumni registered with the school. This paper is generally put out six times per year. It is also the function of this office to promote Alumni meetings through the mailing of letters written by the officers of the different Alumni chapters. These officers are nominated by the Public Relations Office basing the judgement on the person's activity in the organization's affairs. The balloting is made by mail and the results

tabulated by the office.

The final major function is the promotion of the school through the use of general publicity. Mainly the publicity consists of weekly stories in the local papers. Occasionally out of town papers are given an important story. The radio is also used with a fair degree of success for promoting various types of affairs held on the campus and open to the general public.

BROTHER J. ALFRED, F.S.C.

Brother Alfred has published an accounting system manual for Catholic high schools which is widely used in Catholic high schools, throughout the country. He is presently the head of the Accounting department and the Development Department at CBC.



DR. RICHARD DEUTSCH

Dr. Richard Deutsch is a native of the Austrian province of Lower Austria. He was reared and educated in Vienna, his native country's capital city. A graduate of the Viennese School of Economics (Masters in Business Administration in 1921; Doctor of Economic Science in 1932), he specialized in the field of foreign economic relations. Dr. Deutsch, who immigrated to this country in 1938, is a certified public accountant in Arkansas and Tennessee, a Professor of Business Administration at Christian Brothers College, Head of the Department of Marketing at the college, a former Internal Revenue Agent, and also associated with the accounting firm of Minor and Moore. As European business economist, he had accumulated 15 years of international experience and in this country he is completing twenty-one years of practice as a CPA, three of which were with the Federal government.



Brother H. Edmund, F.S.C., entered the Christian Brothers in 1935 after graduating from Cretin High School in St. Paul, Minnesota. He graduated from St. Mary's College in Winona, Minnesota, with a B.A. in Economics. While teaching high school in Chicago, Illinois, he received his M.B.A. in Economics from De Paul University. Brother Edmund came to C.B.C. in Memphis from St. Mary's College, where he was an economics instructor. Active in professional organizations in Memphis, Brother Edmund is a member of the Memphis Sales Executives' Club, Pi Sigma Epsilon, and a past president of the American Marketing Association. Brother Edmund is presently teaching Economics and Marketing at CBC. He is currently the moderator of the petitioning group to Delta Sigma Pi.



BROTHER LIGUORI GABRIEL, F.S.C.

A member of the Business Administration faculty at CBC, Brother Gabriel was born in Glendale, California. He received his grade and high school education in various schools in the U.S. and Europe. After a four-year stay in Germany, he entered La Salle Institute, Glencoe, Missouri, the house of training for the Christian Brothers. He received his B.A. with honors in 1959 from St. Marh's College, Winona, Minnesota. After two years' teaching at St. George's High School, Evanston, Illinois, he transferred to CBC High School, St. Louis, where he studied at St. Louis University's Graduate School of Commerce and Finance. In 1963 he completed course requirements for the M.S. in Commerce and will defend his thesis in 1964. At CBC Brother Gabriel teaches Principles of Economics, Economics for Engineers, and Principles of Salesmanship. He is a member of the Catholic Business Educators' Association.




DR. FRANCISCO SALA
