REPORT OF CALIFORNIA AGRICULTURAL STATE UNIVERSITY

California Polytechnic State University, consisting of over 5,000 acres, is located in San Luis Obispo, a Community of 55,000, midway between San Francisco and Los Angeles.

Cal Poly began in 1901 as a technical high school. In 1923 Cal Poly began offering junior college courses, and in 1933 became a 2- and 4-year institution. In 1936 a degree transfer program was added, and in 1940 the first Bachelor of Science degree was conferred. Approval of general and Master of Arts degrees in education was received in 1948, and in 1951 the Master of Science degree in 1961.

Cal Poly has a faculty of 150 to serve the 10,000 students enrolled in both undergraduate and graduate studies. Faculty members, who are selected on the basis of academic qualifications, professional achievement, and track in teaching are encouraged to give the highest priority to classroom teaching.

Cal Poly has a faculty of 850 to serve the 16,000 students enrolled in both undergraduate and graduate studies. Faculty members, who are selected on the basis of academic qualifications, professional experience, and teaching ability are encouraged to give the highest priority of effective teaching.

At Cal Poly, there is a constant interplay between general principles and practical applications characterize instruction, whether in the laboratory, the classroom, or in field study. Departments assist students in obtaining actual experience through individual and group projects, work-study programs, cooperative education, and internships. An extensive cocurricular program, consisting of over 300

organizations, helps the student to develop citizenship, leadership, and skills necessary for a constructive and productive life in the community.

Students are drawn to Cal Poly's over 50 academic programs by its statewide and national reputation, making it the most popular campus in the California State University system. Students come from all counties of California, as well as other states and countries.

The University is divided into seven schools: Agriculture and Natural Resources, Architecture and Environmental Design, Business, Communicative Arts and Humanities, Engineering and Technology, Human Development and Education, Science and Mathematics, and the Division of Social Sciences. Each of these consist of several specialized departments. Bachelors degrees are offered in 57 subjects and masters degrees in 14 areas.





Dear Members of the Board:

California Polytechnic State University at San Luis Obispo, California has a School of Business with an enrollment of some 1,450 under-graduate and graduate students. Of that number over 1,400 are under-graduates. The School of Business at Cal Poly is rapidly developing a reputation as a School that prepares outstanding candidates for the business world. The reputation of the University throughout this region is high and growing. Our students are heavily recruited by many firms that are multinational in character. The roster of companies who come to the campus to recruit is very impressive and include many of those companies appearing in the Fortune 500.

Our campus is impacted; this means that there is an upper limit placed on the number of students that we can take. Consequently, we must turn thousands away each year. Within the School of Business it required a 3.6 GPA, based on a 4 point scale, for entering Freshmen to be accepted in the Fall of 1980. The Business School is receiving only the very top students from the State of California and from throughout the country.

With this high quality of student input the graduating students from the School of Business at Cal Poly are truly outstanding. I believe that Cal Poly students meet the objective of Delta Sigma Pi encouraging scholarship. With respect to Delta Sigma Pi's objectives of encouraging social activity, the students at Cal Poly, I think without a doubt, exercise every opportunity to further that objective. At Cal Poly each student must do a Senior Project as a requirement for graduation from the under-graduate program. This Senior Project must be original in character and practical in nature. Delta Sigma Pi's objectives of the mutual advancement of students through research and practice is supported by our long standing policy of requiring a Senior Project of all our students. The Delta Sigma Pi objective of promoting close affiliation between the commercial world and the students of commerce is aided and abetted by the California Polytechnic State University School of Business Cooperative Education program and Internship program. These provide opportunities for our students to work directly in business organizations and provides the opportunity for them to apply the things that they have learned in the classroom to real world situations.

The objectives of the School of Business at California Polytechnic State University parallel precisely the objectives of Delta Sigma Pi. I therefore recommend that you grant permission to Sigma Lambda Omega to establish a chapter of your fraternity on this campus.

This Department will support the activities of Delta Sigma Pi and a Sigma Lambda Omega Chapter if such a chapter is established at Cal Poly.

HISTORY OF THE SCHOOL OF BUSINESS

The Business Administration Department at Cal Poly was established in 1959, offering a four-year curriculum leading to a Bachelor of Science degree. It later became known as the School of Business and Social Science. In 1970, the Master of Business Administration was added to the curriculum. On September 1, 1976, the formation of the School of Business was authorized and the faculties of the Business Administration and Economics departments recommended that it consist of four departments - three in business and one in economics. The change was made for the purpose of achieving accreditation for the School of Business. The School of Business is now seeking accreditation from the American Association of Collegiate Schools of Business. A letter of intention was submitted in September 1979 by Dean Coe and President Baker. In January 1981, an investigative team from AACSB came to Cal Poly. The results will be known later this spring.

The School of Business seeks to equip its majors with basic knowledge, analytical skills, and attitudes essential to employment in business, government, and other responsible positions in our society, and to serve students throughout the University by providing them with an understanding of the business and economic world in which they live.

To achieve these goals, the School is organized into four departments -- Accounting, Business Administration, Economics, and Management. This organization recognizes that education for business requires the interaction of business specialists with faculty in supporting disciplines to provide ability to function in the socio-economic environment in which business exists.

The School offers programs leading to degrees of Bachelor of Science in Business Administration, Master of Business Administration, and Bachelor of Science in Economics. A pre-law advisement service is available to all University students.

The School's educational philosophy follows the Cal Poly tradition -- that of enlisting maximum student involvement in the learning process through career-oriented study, special projects, and internships. Educational programs are designed to help the student achieve maximum personal development, to prepare the student for entry into the business world, and to foster citizenship, leadership, and constructive community living. The curriculum includes general education requirements and specialized studies in the student's major field. Optional areas of concentration within each major enable the student to select the program most closely suited to the chosen career field.

THE HISTORY OF SIGMA LAMBDA OMEGA

Sigma Lambda Omega is a local professional business fraternity which was organized in the Spring of 1980 at California Polytechnic State University, San Luis Obispo.

The establishment of a professional business fraternity was the idea of Pam Cosart, a Business Administration major with a marketing concentration. A friend of Pam's who attended Loyola-Marymount University in Los Angeles, Ca., was involved in a professional business fraternity on her campus and had always spoken of how many great opportunities the fraternity had given her.

At the beginning of Spring Quarter, 1980, Pam discussed her idea of a business fraternity with another student in the School of Business. They both agreed that Cal Poly's learning by doing motto would be reflected in a professional fraternity and that Pam's next step would be to speak with Dr. Robert Coe, Dean of the School of Business.

Pam met with Dr. Coe and he suggested getting in touch with Ben Wolfenberger, Executive Director of the International Fraternity of Delta Sigma Pi. Delta Sigma Pi was co-educational, and Dr. Coe was an alumnus and could assist in getting a fraternity started at Cal Poly.

It happened that Mr. Wolfenberger would be in California in the latter part of April for the initiation of two new

chapters. A meeting was arranged on our campus to allow Pam and other students to meet with the Executive Director. The meeting was publicized and an invitation was extended to all interested business students.

On April 28th, ten students met with Ben Wolfenberger to discuss the requirements of establishing a chapter of Delta Sigma Pi at Cal Poly. The following Thursday a breakfast meeting was held; thirteen students were in attendance.

Weekly meetings were begun; officers and an advisor were elected; a name for our local fraternity selected, and steps taken towards recognition by the Associated Students Inc. and the international fraternity. Committees were formed and the local fraternity met weekly for the remainder of the quarter with 20 students attending regularly.

The summer months were a period of slow growth for the fraternity. Our by-laws were finalized and were ready for submission to our Student Senate at the beginning of the Fall quarter.

In late September when Fall quarter began, the expansion of our local fraternity continued. A recruiting table was set up during the University's Week of Welcome activities. With the assistance of the Iota Phi, Iota Upsilon and the Epsilon chapters, we recruited new students to our University. Committee chairmanships were filled, and an announcement that we had a pledge master was made.

Plans for professional, service, fundraising and social activities plus plans for building a working relationship

with our faculty and local alumni of Delta Sigma Pi began. A barbeque and dinners before our meetings were held to assist members in getting acquainted.

October brought a visit from Mike Tillar, Assistant Executive Director of Delta Sigma Pi. He met with the entire fraternity and with the members of the fraternity's executive board. Also in October, nine members attended the Regional Delta Sigma Pi Conference, and the entire membership went pumpkin caroling on Halloween in costume at two local nursing homes followed by a progressive dinner.

November's agenda was filled with a tour of a local branch of Bank of America (the tour was lead by an alumnus of Delta Sigma Pi), a tour of Estrella Winery and a discussion with the winery's marketing director and a drawing for \$50 of gasoline. A western-attire pre-pinning party was sponsored for all out-of-town guests who would be attending our pledge pinning ceremony.

With the start of our Winter quarter, the fraternity toured San Luis Bay Inn, a local resort, and learned of opportunities in the hospitality industry, sponsored a swap meet fundraiser, and the entire membership went on a retreat. The purpose of the retreat was to bring our fraternity members closer to one another. A second pledge pinning took place, and our current membership stands at thirty-four.

In the near future, the fraternity has on it's itinerary a tour of our County Data Processing Center, a mud football

game against the social-professional Architecture fraternity
and a drawing for \$50 worth of groceries.
