
Dear Sir:





# **BELLARMINE COLLEGE**

# College History

Bellarmino College , a private institution located in Louisville, Kentucky, was founded in October of 1950 under the sponsorship of the the Catholic Archdiocese of Louisville. The college awarded degrees to its first class in June 1954.

On June 1, 1968, Bellarmine College merged with Ursuline College, a Catholic college for women which had been established in 1938 by the Ursuline Sisters of Louisville. From 1968 to 1971, the merged institution was known as Bellarmine-Ursuline College. On June 1, 1971, the name was consolidated to Bellarmine College.

Throughout its thirty-two year history, Bellarmine College has had one motto; "In Veratatis Amore" -- "In the love of truth" -- which was the motto of St. Robert Bellarmine, after whom the college is named. Employing this motto, Bellarmine strives for a Liberal Arts philosophy to the fullest extent, realizing that a person must have more than professional skills in the life which follows college.


In Bellarmine's short thirty-two years, it has surpassed other institutions, which are much older, as the pre-eminent private college in Kentucky. This is because of the progressive nature of Bellarmine's administration and of the support it receives from the community of Louisville. To help maintain its position as the leading private school in the state, Bellarmine College is embarking on an ambitious capital development program which is described later in the petition.

Bellarmino has many resources to which each student has access. These include a library of more than 100,000 volumes and one of the largest collections of magazines in the area of business and management to be found, through a special agreement with Data Courier, a subsidiary of the Courier-Journal and Louisville Times. Also housed on Bellarmine's campus is the Thomas Merton Collection. The college is also a member of the Metroversity program. This program enables the member colleges and universities to offer their students an expanded selection of classes and research and educational materials. The Metroversity is comprised of seven colleges and universities in the Louisville and Southern In-


diana area.

The many assets which Bellarmine offers to its students can be better comprehended by the following statements. In the last three years, the enrollment of the Freshman class of Bellarmine College has considerably increased. There also has been additional enrollment in the evening and summer classes. Today, Bellarmine College has 2600 students from twenty-one states and fourteen countries. The full time student body of approximately 1200 is composed of nearly equal numbers of males and females. Bellarmine College is accredited by the Southern Association of Colleges and Schools.

## **a** Administration Building

The Administration Building is the home of the administrative offices, including the offices of the president, the academic dean, admissions and educational services, and an executive conference room. In addition, this building also houses the college's computer data center. An entire wing of the Administration Building is dedicated to the college's multi-level library. Also as a part of providing for the needs of the students, there is a career placement office dedicated to providing information and interviewing opportunities for both the upper and underclassmen.

## **b** Pasteur Hall

Pasteur Hall houses the facilities and lecture rooms for the social, natural, and physical sciences. The facilities include three biology labs, two chemistry labs, a physics lab, a psychology observation room, and history and political science lecture theaters.

Pasteur Hall also houses the W. Fielding Ruebel School of Business, which encompasses the business administration and accounting departments.

## **c** Chapel and Lecture Hall

A major facet of the Christian education on Bellarmine's campus is the St. Robert Bellarmine chapel, which serves as an interfaith worship place. The Catholic Mass is celebrated daily and interdenominational prayer services are frequented by the students. Other prayer experiences offered include monthly Dorm Prayer Services, special Seasonal Liturgies, and weekly Jewish services.

## **d** College Activities Building

The College Activities Building is the bustling new center of Bellarmine activity. It includes a large assembly room, general and private

dining areas, student lounge, bookstore, chaplain office, newspaper/yearbook office, dark room, conference room, student government offices, health office and computer facilities.

## **e** Music Building

Bellarmino's new Music Building enhances an already integrated program of both classical and commercial instruction. This addition includes a large rehearsal room, an ensemble room, several studios, practice rooms, lecture facilities, a listening center, and various offices. The college's Music Department offers one of the few B.A. degrees with a concentration in jazz and commercial music.

## **f** Art Building

The expanded Art Building consists of classroom space for various degrees of art media, including printing, ceramics, photography, sculpture, painting, and drawing. There is a photo dark room, a dressing room, and an enclosed court. Also in this building are part and full-time art faculty office spaces. Currently, works by members of the Art Department are in prominent museum collections including the Whitney Art Museum in New York, and the Chicago Art Institute. Despite their numerous individual achievements, teaching remains the highest priority of these gifted men and women.

## **g** Humanities Building

The Humanities Building includes faculty and director office space as well as large and small seminar rooms for lectures on various fields of the Humanities. This building is used by the Theology, Philosophy, and English Departments. In addition, the faculty of the Humanities program is composed of a nationally recognized group of professionals.



## knights hall

Bellarmino College's gym serves as an all-purpose facility, and is the home of the Division II Knights and Belles basketball teams. Many of the school's semi-formal dances are held here. Also, many clubs and organizations, such as Alpha Beta Delta, use this large complex for their public events and inter-organizational competitions.



## residence and lenihan halls

Bellarmino's two building residence hall complex provides the advantage of living at the center of campus activity within easy walking distance of all classroom buildings. The residence complex offers recreational and kitchen facilities, a private phone service, and community spirit.

Lenihan Hall houses Bellarmino's expanding nursing school and the Thomas Merton Studies Center. The latter is dedicated to preserving the works and furthering the concerns of Fr. Thomas Merton, a Trappist monk who became internationally known for his religious profundity.

## W. Fielding Rubel School of Business

During its thirty-two year history, Bellarmine College has always offered excellent educational programs within a framework of concern for the moral and spiritual development of its students. The undergraduate programs in Accounting and Business Administration have been recognized as among the best in this region. The MBA Program was introduced in 1975 in response to the critical need of our business community and non-profit institutions for management talent.

At Bellarmine, the study of business administration provides knowledge for the basic operation of any enterprise. Bellarmine's Business Administration program is designed to prepare men and women for varied careers in the rapidly changing business world of today.

Top business leaders suggest that education for business must contribute to the development to such qualities as analytical ability and balanced judgment, capacity to solve problems, vigor of mind, ability to work with - and lead - others, understanding of human behavior and of social, political, and economic forces. These qualities are considered essential for creative management. Bellarmine's Business Administration program attempts to foster the development of those intellectual qualities which are indispensable in professional and management careers. It prepares a person to grow and move forward from the first job throughout a lifelong career.

In addition to Bellarmine's fine Business Administration program, there is the Accounting program, which also provides its students with a strong foundation for a future of professionalism.

Although the immediate purpose of accounting is measuring the results and performance of business and other organizations, the indirect effects of accounting are far-reaching.

It is obvious that accounting is essential for the efficient operation of businesses which provide the necessities of life for society - food, clothing, shelter, and other needs of the economy. In addition, accounting is necessary to calculate and to administer tax revenues for financing local, state, and federal government. Indirectly, then, accounting helps to provide government services, national defense, and a broad range of social benefits such as retirement plans, medical assistance, unemployment insurance, and other kinds of social security.

Accounting, therefore, is indispensable in controlling and directing practically every organization which provides service to society. It is, in fact, so necessary in this complex world, that today's society literally could not function without accounting.



Alpha Beta Delta Colony at Bellarmine College began in the Spring of 1981, when Dr. Richard A. Dolin introduced the idea of the fraternity. Dr. Dolin formed a steering committee consisting of Joseph Morrison and Walter Schwartz, presently members involved in the colony, and three others. Dr. Dolin invited several alumni of Delta Sigma Pi to speak to the committee in regards to planning the organization's recruiting strategy for the upcoming school year. Interest grew during the Fall semester of 1981, and the committee formed a colony. The committee mutually agreed to name the colony Alpha Beta Delta, and was recognized by the college upon the submittal of the bylaws of the colony.

In the Spring of 1982, Alpha Beta Delta had sixteen members and a staff of elected officers. The officers were as follows:

Joseph Morrison resigned the position of Secretary/Historian and was replaced by Sarah J. Niemann in the Fall of 1982.

Over the Summer of 1982, a calendar for the 1982-83 school year was formed. The colony's emphasis was on recruiting, social activities, and community service.

The agenda for the 1982-83 school year was as follows: Alpha Beta Delta began the year with recruiting on Clubs' and Organizations' Day, where membership grew to thirty-four. The new members were welcomed into the colony at a recruitment party in September. The following month Alpha Beta Delta co-sponsored a dance with Bellarmine's Pep Club. The Payne Brothers Band played, and the dance was successful in raising operating money.

Later in the Fall, Louisville Redbirds Baseball Club owner, A. Ray Smith, spoke on the advertising strategy of the Redbirds and their successes thus far.

During December, Alpha Beta Delta sponsored a successful project. Poinsettias were sold and the proceeds were donated to the Kentucky Hemophilia Foundation.

In early February, Alpha Beta Delta held a dance marathon for the Kentucky Hemophilia Foundation. A total of \$1400.00 was raised by the participants to further support the foundation. Later in the month, Louisville native and entrepreneur, Roger Davis, spoke to a representative number of students on real estate investments in Louisville. In addition, Mr. Davis spoke about the success of local projects he

had undertaken.



The organization's next order of business will be conducted by the newly initiated charter members of Delta Sigma Pi.






