
Dear Dean:

Academic Building

The Academic Building is a fine example of classic revival architecture, and faces what was the main entrance to the campus prior to the construction of the System Administration Building in 1932. A large mosaic Seal of the University, a gift of the class of 1978, is embedded in the rotunda floor in the Academic Building, and a replica of the Liberty Bell also is housed in this area.



System Administration Building

The System Administration Building was designed by S. C. P. Vosper, a staff architect. A brass and terrazzo inlaid map of Texas is located in the main lobby. The terrazzo indicates the different major soil types in Texas and the brass inlays recall incidents of historical interest. There is one error in the map--Austin is located on the wrong side of the Colorado River.



Kyle Field

The first Aggie football games were played at the Bryan Fair Grounds. In 1904, the athletic board set aside an area on campus as the permanent athletic field. E. J. Kyle, Chairman of the Athletic Council, gave a personal note for the purchase of the Bryan Fair Grounds' 500-seat covered grandstand. Enlarged for the fifth time in 1979, the stadium seats almost 70,000 spectators. The Aggies have won nine undisputed conference football championships, in addition to the national championship in 1939, in the stadium.



Blocker Building

Formerly known as the Academic and Agency Building, this building was renamed in 1984 for John R. Blocker. The Blocker building contains six floors and is home to the College of Business. The English Department and Performing Arts are also located in this building.

HISTORY

Texas A&M University is the state's oldest public institution of higher education and was established in 1876. The University owes its origin to the Morrill Act approved by the Congress on July 2, 1862. This act provided for donation of public land to the states. By resolution of the Legislature of the State of Texas in November 1866, Texas agreed to provide for a college under the terms of the Morrill Act, but no such institution was organized until the establishment of the Agricultural and Mechanical College of Texas by Act of April 17, 1871. The same act appropriated \$75,000 for the erection of buildings and bound the state to defray all expenses of the college exceeding the annual interest from the endowment. Proceeds from the sale of the 180,000 acres of land scrip received under the Land Grant College Act were invested in \$174,000 of gold frontier defense bonds of Texas, forming a perpetual endowment for the institution.

A commission created to locate the institution accepted the offer of 2,416 acres of land from the citizens of Brazos County in 1871, and instruction began in 1876. As the State of Texas grew, so did its land grant institution. Texas A&M University now has a physical plant valued at approximately \$300,000,000. The main campus at College Station includes 5,142 acres and is the largest campus of any major institution of higher education in the nation.

Texas A&M was established as a military institution and the Corps of Cadets has played an important part in its history and development. Even though membership in the Corps of Cadets became voluntary in 1965,

Texas A&M continues to furnish more reserve officers than any other institution in the nation. The University is one of only three institutions with a full-time Corps of Cadets including all three ROTC programs leading to commissions in all four branches of service--Army, Navy, Air Force and Marine Corps.

Texas A&M University offers a variety of programs in both undergraduate and graduate studies through its ten academic colleges--Agriculture, Architecture and Environmental Design, Business Administration, Education, Engineering, Geosciences, Liberal Arts, Medicine, Science and Veterinary Medicine--and through Texas A&M University at Galveston. In addition, its extensive research efforts in all fields totaled more than \$63 million in 1979, more than any other university in Texas.

In keeping with the diversified and expanded character of the institution, the 58th Legislature of Texas, on August 23, 1963, changed the name of the Agricultural and Mechanical College of Texas to Texas A&M University. Today, Texas A&M has established itself as a leader in many of the newer technological areas, such as the space, nuclear, computer, oceanographic, and marine resources fields. It also has placed added emphasis in such areas as the liberal arts and business administration and enhanced its prominent role in other traditional fields.

ENROLLMENT

The University's enrollment now exceeds 35,000, including more than 5,000 graduate students. Every state in the nation and 95 foreign countries are represented in the coeducational student body. To date, Texas A&M has awarded more than 109,000 academic degrees, including more than 4,300 doctorates, and more than 16,500 degrees at the master's level. As evidence of the recent growth and development of the University more than one-half of the advanced degrees awarded have been conferred in the last decade. Texas A&M University is accredited by the Southern Association of Colleges and Schools. Both the baccalaureate and the master's curricula in the College of Business Administration are accredited by the American Assembly of Collegiate Schools of Business.

HISTORY

When the Agricultural and Mechanical College of Texas began in 1876, the "Commercial Department" served to teach farmers and engineers how to manage their businesses. The Department of Accounting and Statistics was formed in 1926 and started a trend away from agriculture-related business.

Thomas Leland took over the Department in 1926. He was the major force in the growth of Business at Texas A&M. In 1946 Leland managed to consolidate all business courses under the Department of Business Administration, and in 1950 it achieved the title of Division of Business Administration. Thomas Leland was with the Department until 1961.

John Pearson became the Director of the Division of Business Administration in 1963. Under his administration, a higher quality education was made possible through better instructors and stricter standards. Accordingly, the Division was upgraded to the College of Business Administration in 1972. John Pearson left in 1978.

The current Dean, William Mobley, has headed the College of Business Administration since 1983. The academic program of the College of Business Administration is organized into five departments. The head of the Accounting Department is James J. Benjamin. Dean Wichern is the head of the Business Analysis Department. The heads of the Finance, Management, and Marketing Departments are Malcolm Richards, Lyle Schoenfeldt, Dan Robertson, respectively.

The College of Business Administration has grown since its humble beginnings. Today it boasts nearly 6300 students which constitute over

seventeen percent of the entire student body. The College of Business Administration is currently the second largest college on campus. It became the second largest college when it surpassed the College of Agriculture in 1948.

Junior, Accounting


