



THE BEHREND COLLEGE

OF

PENN STATE UNIVERSITY

Penn State Erie, The Behrend College, is a four-year and graduate college of Penn State University. The College's campus was donated to the University in 1948 by Mary Behrend in memory of her husband, Ernst, a founder (with his father and brother) of Hammermill Paper Company. In offering her family's 400 acre Glennhill Farm Estate to Penn State, Mrs. Behrend was responding to the need, expressed by a committee of prominent Erie residents, for a public, non-sectarian college in Erie.

In 1948, 152 students enrolled at what was known as "The Behrend Center." Those first students could complete only their freshman year at the center. When Penn State reorganized in 1959, the Commonwealth Campus System was established, and the Behrend Center became the Behrend Campus of Penn State. Enrollments and physical expanse of the campus both grew throughout the 1960's and early 1970's. By 1971, over 1,200 students were enrolled.

On January 20, 1973, the Penn State Board of Trustees granted four-year college and graduate status to Penn State-Behrend. Behrend is unique within the Penn State system as the only four-year college of the University not located at the University Park campus.

Today, enrollment is limited to 2,600 undergraduate students who attend classes in original buildings from the

Glennhill Farm Estate and in the more recently-constructed academic building, including the award-winning Hammermill and Zurn buildings completed in 1985. Over 900 students are housed in residence halls and student apartments on campus.

The College offers 27 baccalaureate and associate degrees in business, engineering, the humanities, the social sciences, science and technology, as well as the Penn State MBA and MEd graduate programs. Recently, Penn State-Behrend became one of the few colleges nationwide to offer an undergraduate program in plastics engineering technology.

Penn State-Behrend has recorded increasing enrollment for the past 16 semesters and is continuing to expand its facilities. The addition of three new apartment building in 1987, the recent construction of an addition to the Student Union Building and groundbreaking in the near future for an \$11 million library/academic complex, are among the indications that Penn State-Behrend is finding success providing the small-college experience with the nationally-recognized Penn State degree.





SCHOOL OF BUSINESS

The educational mission of the Penn State-Behrend School of Business is to provide an opportunity for nationally recognized graduate and undergraduate instruction for students preparing for careers in business and non-profit organizations.

Behrend College began offering four-year majors in business in the mid-1970s. In 1985, an MBA program was started and in 1986 the Penn State Board of Trustees established the School of Business with Behrend College. Today we serve over 650 undergraduate and over 150 MBA students.

ACCOUNTING

The Accounting major provides an opportunity to pursue a unique program that integrates knowledge and skill in accounting and information management. It prepares students for positions in public accounting firms, corporations, and government, where accounting skills are essential. In addition, the Accounting major provides the necessary academic training for students interested in administrative responsibilities in the area of accounting. The major meets the requirements for taking the CPA and CMA professional examinations.

BUSINESS ECONOMICS

Business Economics is a quantitative program of study in applied economics with a strong business focus. Use of mainframe and microcomputers as analytical and problem-solving tools is emphasized in the program's upper-division courses. Students may

choose upper-division courses in several areas of specialization, including business cycles and forecasting, economic theory, international economics, labor economics, managerial economics, money and banking, and urban and regional economics.

BUSINESS, LIBERAL ARTS, AND SCIENCE

In the Fall of 1990, the Business and Behavioral Science major was modified and the name was changed to Business, Liberal Arts, and Science. The students that enrolled prior to the change will graduate with the Business and Behavioral Science Degree. This interdisciplinary major provides students with considerable flexibility for customizing a program of study designed to meet individual interests and career goals. Depth of knowledge is achieved through the selection of modules that form the basis of the major. Students select three modules, each of which contains from 12-18 credits and encompasses a discrete subject area. Proper selection of modules will provide good preparation for careers in business and government or for entry into graduate school.

MANAGEMENT

The objective of the Management major is to develop the knowledge, skills, and abilities needed to perform the basic tasks of management—the coordination of human, material, and financial resources toward the accomplishment of organizational goals. The major provides a solid grounding in all of the core areas of business. In addition, Management majors take coursework specifically designed to give greater expertise in the management of the organization's key resource—people. Management majors may

further tailor their studies to individual career objectives by choosing from additional courses that allow greater specialization in quantitative methods for managerial decision making or in human resource management.

MANAGEMENT INFORMATION SYSTEMS

The Management Information Systems major offers students a business degree coupled with strong computer and information management skills. MIS differs from computer science in several ways. In MIS, the emphasis is on the solution of business problems rather than on the creation of new knowledge about computing. Where computer science emphasizes the study of computers and computer programming as ends in themselves, MIS emphasizes the application of computer science within an organization to help achieve its goals. Skills include the analysis of information management needs, implementation of large systems and practical technical knowledge, including database management, communications, and programming. The major adheres to the Association of Computing Machinery's curriculum recommendations.



Lee Sloan, the colony president, started his academic career at University Park, Penn State University. He stayed there for his freshman and sophomore years, recognizing the Delta Sigma Pi chapter all along. When Lee moved to the Behrend College, Penn State University, the fraternity was kept in mind. On September 5, 1989, Lee proposed the idea of starting a colony to William Poad, current Senior Vice President of the fraternity. Bill gave affirmation to this idea two days later, and the idea was beginning to shape.

After receiving the address from a friend at the Univeristy of Pittsburgh, Lee and Bill sent a letter of interest to The Central Office, and requested information about starting a colony at Behrend College. Upon receiving information from Delta Sigma Pi, Lee and Bill consulted with C. Dean Ferguson and decided to continue with the project in the Spring semester of 1990.

Lee and Bill still kept in touch with Oxford, Ohio, and C. Dean Ferguson over the Christmas recess. They single-handedly gathered the names of all business students at Behrend College. Furthermore, Lee and Bill filled the business students mailboxes with the professional pamphlets and fliers just before the arrival of the Spring semester, ending their own break early.

Launching into the Spring semester head first, they invited Richard Parnitzke, Past Grand President of the

fraternity, to come make a presentation. Mr. Parnitzke graciously accepted and brought the Alpha Kappa Chapter brothers from the State University of New York, Buffalo, to make a presentation.

On February 6, 1990, the Delta Sigma Pi Colony at Behrend College had its first meeting. The by-laws were approved and election of officers began to shape the executive committee.

Elected that evening were Lee Sloan as President, William Poad as Senior Vice President, Edward Brink as Vice President of Pledge Education, Cindy Cleveland as Vice President of Professional Activities, Robert Rozman as Vice President of Chapter Operations, Charlotte Brown as Secretary, Serene Jones as Treasurer, Eric Miller as Chancellor and Heath Kolodziej as Historian.

A letter of intent to petition was sent to The Central Office of the International Fraternity on February 20, 1990. On March 6, 1990, the first executive committee meeting was held, the dreams of these two men, Lee and Bill, were coming true. To round out the first semester of progress, on April 19,1990, the first professional activity was held. This event, a speaker from the Society of Retired Entrepreneurs, was attended by members of the new colony and Past Grand President, Richard Parnitzke. Along with the professional activities, a car wash was held to raise money and a picnic held at Presque Isle State Park. These events not only educated the new members of this colony, but brought them

closer together. And a foundation for growth and success was laid with thanks and gratitude to two men with a great vision.

One Lee Sloan, born on September 10, 1969, started his college career in engineering, only to switch to business his sophomore year. He is an Accounting major from Monroeville, Pennsylvania, who plans to graduate in May of 1991. A graduate of Gateway High School in 1987, his other activities are intramural sports, Accounting Club member and student member of the National Association of Accountants. A great supporter of Lee's in the fraternity is William Poad, Senior Vice President of the colony. Bill is a 1986 graduate from Brockway Area High School who is also an Accounting major. After starting his academic career at Virginia Polytechnic Institute, he transferred into the Penn State system at the DuBois campus, and then moved on to Behrend College. Bill is also graduating in May of 1991. Both men bringing their academic careers to an end with superior results, and are ready to hand their creation over to future leaders of this wonderful organization of fraternal brotherhood.
