HISTORIES

CITY OF AMES, IOWA



Ames was established in 1864 to serve the westward-bound Cedar Rapids and Missouri River Railroad. The railroad president named the town after a fellow rail promoter, Congressman Oakes Ames. Ames is centrally located in the Midwest and centrally located in Iowa. Ames is easily accessed by transcontinental US Highways 30 and 69 and Interstate 35. Ames is about 30 miles north of the capital of Iowa, Des Moines.

Ames is a university community with over 1,000 businesses sharing resources with Iowa State University. According to the 1990 census, Ames population is 47,198. ISU employs approximately 11,000 area residents and enrolls 25,000 students. Other major employers in Ames are: Mary Greeley Medical Center, the Iowa Department of Transportation, McFarland Clinic PC, the City of Ames, Sauer-Sundstrand, Ames Laboratory, 3M Company, National Animal Disease Center, and Hach Chemical. The Ames community also sponsors some annual events including Special Olympics, Iowa Games, and the VEISHEA celebration.

IOWA STATE UNIVERSITY AT AMES, IOWA

Iowa State College was founded on March 22, 1858 when Governor Ralph P. Lowe signed a bill to establish a State Agriculture College and Model Farm. It was then declared a land grant college due to the Morril Act signed by Abraham Lincoln.

It was formally opened on March 17, 1869 as the first coeducational land grant college. The first class was comprised of 173 students, 136 men and 37 women. Of this first class, only 26 students, 24 men and 2 women graduated.

The Bomb, the college yearbook was published for the first time in 1894. The nickname, the Cyclones came about in 1895 when a newspaper reporter described the football team as a cyclone from Iowa winning by a score of 36-09 over Northwestern University.

The Campanile, the bell tower on campus, was erected in 1899. The 10 original bells for the tower were purchased from John Taylor & Company of Loughborough, England. They were the first scientifically tuned chime of bells installed anywhere in the world. Tradition holds that ISU students are not "official" until they have been kissed under the campanile with the bells tolling the hour of midnight. Later that year the college colors became cardinal and gold and still remains as our colors.

In 1900, the Knoll was constructed as the house for the President of the

college. Mrs. A.B. Storms named it 'the Knole" after a beautiful baronial estate in England. However, President Pearson, Storms' successor thought it was a mistake and changed it to the Knoll.

Homecoming began back in 1912 with a big football game and parade. The Homecoming tradition still continues, however, the major events are the pep rally before the football game and the game itself. Two years later in 1914, the first Christmas tree was lit on campus. In 1991, Tom Sutherland and Terry Anderson, alumni of ISU, were honored at the lighting of the Christmas tree after being held hostage for many years Beruit.

In 1916, LaVerne Noyes donated money in order to construct a lake on campus. The lake is located on the South edge of campus and bears the name Lake LaVerne after Mr. Noyes. In 1935, two swans, Sir Lancelot and Elaine, were presented to the College by the Veishea Central Committee to be placed in Lake LaVerne where they still reside. It is said that if you and your boyfriend/girlfriend walk around Lake LaVerne three times you are destined to be married.

The annual Veishea celebration was first held May 11-13, 1922. The name Veishea represents the five divisions - Veterinary Medicine, Engineering, Industrial Science, Home Economics, and Agriculture - by using the first letter of each division. During this celebration there are many activities on campus from giant Twister to the Carnival to the elaborate parade.

In the 1930's and 1940's, ISU Professor John V. Atanasoff, a member of math and physics at ISU, helped create the first electronic digital computer. Later the computer building on campus was named after him.

The name of the student newspaper still in circulation today changed from the Iowa State Student to the Iowa State Daily in September, 1947.

The first mascot of the College was nicknamed "Cy", a cardinal. It represents Iowa State in the athletic conference that finally became the Big Eight in 1957.

In 1969, the name of the university changed from Iowa State College to its current name of Iowa State University. Also in that same year, C Y Stephens opened with the production of "Oliver".

In 1971, Hilton Coliseum opened with the Iowa State stadium following in 1975. The stadium was later named Jack Trice after the first black football player killed in a game against Minnesota in 1923.

The Scheman Continuing Education Building was built in 1975. It is

used for various lectures and conventions held in Ames.

The two most recent additions to Iowa State were Parks Library in 1982 and the Recreation Center in 1990. This center houses the largest indoor track in the world.

Iowa State University currently covers 1000 acres including 120 major buildings. The student body is approximately 25,500 strong and has a very active Greek system which includes eighteen sororities and thirtysix fraternities.






This aerial view of Iowa State University illustrates the dynamic buildings and beautiful campus. Our University is well known for its vast, beautiful central campus.




The Memorial Union was built in 1928 and was used primarily as a place for social gatherings. The oval shaped fountain was presented by the Veishea Committee in 1937. Tradition has it that any student who steps on the Zodiac sign inside the north entrance of the Union will fail the next exam. There are only two ways to break the curse: toss a penny into the fountain outside the Union or throw a penny off the bridge at the bottom of Union Hill.




The Campanile is our beautiful chiming clock on central campus. The bells are rung on the hour and every fifteen minutes thereafter according to the time. During the Christmas season, some carilloners play Christmas songs as you battle the cold to class.




In 1906, Beardshear was completed, being named after one of our Presidents. This building is where all the financial matters take place and where the President of the University's office is located. It is known on campus as the place to pay your University bill since it has a green dome on top to symbolize money!





Lake LaVerne is located directly west of the Memorial Union. The land was donated by LaVerne Noyes in 1916 and the lake area was then enlarged to its present size. Sir Lancelot and Elaine, two swans, call this lake home. The lake has also been used for homeade boat races during Veishea.

THE COLLEGE OF BUSINESS



Iowa State University has offered courses in business since the early 1900s. Carver, the building that currently houses the Business College, was built in 1968. Before 1980, the College of Business was under the College of Science and Humanities. It became the School of Business Administration in 1980, but was still under the College of Sciences and Humanities. Also in 1980, Accounting, Finance, Management, Marketing and Transportation and Logistics were offered as majors for the first time.

On July 1, 1984, it became the College of Business Administration, independent of the College of Science and Humanities. After six years of work, the college became accredited by ACASB in April 1991.

Students may receive a Bachelor of Business Administration degree by completing one of the following majors: Accounting, Finance, Management, Marketing, or Transportation and Logistics. The other alternative is to receive a Bachelor of Science degree with a major in General Business. ACCOUNTING: The major of accounting is designed to give students a conceptual foundation as well as to provide a wide range of basic skills for both public and private concerns. Completion of this program meets the current educational requirement for taking the CPA examination as established by the Iowa Accountancy Examining Board.

FINANCE: The courses in finance constitute a broad program of study designed to provide a descriptive and behavioral background of financial management to enable students to qualify for opportunities in banking, insurance, brokerage, government, real estate, and financial management of business enterprises.

MANAGEMENT: Management is a broadly defined discipline and activity. each student has the opportunity to become equipped with the conceptual, analytical, and integrative skills needed to assume an entry-level managerial role in a wide variety of organizations. The management curricula at ISU allow students to concentrate on one of two distinct areas: (1) Management of Operations, or (2) Management of Information Systems (MIS).

MARKETING: Marketing is concerned with management decisions that deal with the satisfaction of consumer needs in the purchase and use of goods and services. A major in marketing prepares the student for careers in such areas as product management, public relations, industrial purchasing, advertising and sales promotion, marketing research, personal selling and sales force management.

TRANSPORTATION AND LOGISTICS: Transportation and Logistics serves as a specialized program for those who plan careers working with shippers, carriers, and government agencies. It is a broad-based educational program which emphasizes the managerial aspects of transportation and logistics systems and concepts


GENERAL BUSINESS: The courses in general business are a combination of the 5 majors previously mentioned. This major provides students with a general knowledge and background of the business field.



AUGUST R. RALSTON



CHI UPSILON



These are the sequence of events that led to the establishment of the Chi Upsilon chapter at Iowa State University:

April 11, 1991 - A meeting was held for students to meet the fraternity. It was attended by the brothers of Alpha Iota, brothers from Epsilon Iota, District Director NolaKay A. Kelm, District Director Krista K. Aberle, Regional Director (then District Director) Mark E. Dorn, and District Director William E. Honan conducted the presentation.

April 18,1991 - This was an organizational meeting which included the colony electing its first officers for the Executive Committee, choosing the name of Chi Upsilon, and deciding to send the Letter of Intent to Central Office.

May 6, 1991 - An informational meeting was held. A few new members were also recruited at this meeting. This was the last official meeting for the semester. The Executive Committee continued to meet through the summer months to plan for the Fall 1991 semester.

- September 5, 1991 This was the first meeting of the Fall 1991 semester. This meeting was used to establish when to have the "Meet the Fraternity" night and to discuss recruiting possibilities.
- September 17, 1991 A recruiting activity was held as "Meet the Fraternity" night. Members from the Des Moines Drake chapter of Delta Sigma Pi came to speak to us and presented a slide show on what being a member is all about. This was also a recruiting night.
- September 22, 1991 Bill Reichardt was our first speaker of the semester. Mr. Reichardt gave a presentation on how to "Dress for Success" in the business world today.
- September 24, 1991 C. Dean Ferguson, Director of Chapter Services, visited the ISU Campus. Mr. Ferguson spoke to the Executive Committee and explained to them the requirements of their particular offices. He then spoke to the colony about what we needed to accomplish to become a chapter.
- September 28, 1991 This was the "North Central Kick Off Classic". They came to Ames to show support of the colonization. It was attended by Mid-American Provincial Vice President Randy Hultz, Regional Director Mark E. Dorn, District Director William E. Honan, and different chapters within the Region.
- October 9, 1991 Sally Hinders was the second speaker of the semester. Mrs. Hinders works in the ISU Placement Office. She spoke to us on resume tips and what a proper resume should contain.
- October 24, 1991 This was a general information meeting. We set up a new format to conduct the meetings. At this meeting we also elected Co-Historians to start keeping a scrap book for the colony.
