



Rockhurst University: "Wisdom Has Built Herself a Home"

We gratefully thank Rockhurst University for allowing us to use this excerpt from the Rockhurst Bulletin. Their support is truly appreciated.

The spirit behind Rockhurst

University was born in 1521, when a Spanish soldier took a cannonball in the leg at Pomplona. That soldier, later to be known as St. Ignatius of Loyola, used his recovery period to develop his spirituality and approach to life. That new spirituality led to the formation of the Society of Jesus. The subsequent Jesuit tradition of service to others through a liberal education has been renowned worldwide for more than 450 years.

The Ignatian spirit was expressed

in Kansas City in 1910 with the founding of Rockhurst College and High School. A charter from the state of Missouri empowered "Rockhurst University" to offer degrees. The construction of Sedgwick Hall in 1914 allowed the opening of high school classes that same year; college classes began in 1917. Small in numbers but infused with the Jesuit spirit, the first Rockhurst College students were all taught by the Rev. Alphonse Schwitalla, S.J. Just as

the Jesuit order grew from the calling of one man into a worldwide force, so Rockhurst has grown from the dream of a small, hardy crew of priests into an institution with national reach.

A commitment to academic excellence and community service has marked Rockhurst's path. Today the College serves approximately 3,000 students at the main campus in Kansas City's cultural district and at the Ignatius Center of Rockhurst College/Saint Louis University, located in suburban Kansas City. Both undergraduate and graduate degree programs feature the lifelong liberal

arts learning approach that is a hallmark of Jesuit education. Through a subsidiary, Rockhurst College Continuing Education Center, Rockhurst is also the nation's largest nonprofit provider of adult continuing education.

Historical highlights of Rockhurst College begin in 1908 with Bishop John J. Hogan approving the purchase of land for the Jesuit college. In 1909 Rev. Michael Dowling, S.J., bought 25 acres at 53rd and Troost for \$50,000. In 1910 the charter for awarding degrees was granted to Rockhurst by the state of Missouri. The first president of Rockhurst College was

Rev. Michael P. Dowling, S.J., serving from 1910-1915. In 1914 academic life began with the opening of high school classes in Sedgwick Hall. 1917 brought in the first college classes with Rev. Alphonse Schwitalla, S.J., him being the only faculty member. The first class graduated from Rockhurst in 1921, and the first honorary degree was awarded to Marshall Ferdinand Foch. Dowling Hall, the first college building, was completed in 1922, named after Rev. Dowling.

The president from 1933-1940 was Rev. Daniel H. Conway, S.J. Conway Hall, named after Rev. Conway,

was completed in 1937. In 1939, Rockhurst received accreditation by the Commission on Institutions of Higher Education of the North Central Association of Colleges and Schools. The first resident students were housed in Dowling Hall in 1940. Later, in 1946 the division of Business Administration was organized. St. Francis Xavier Church was dedicated in 1950.

The president of Rockhurst College from 1951-1977 was Rev. Maurice E. Van Ackeren, S.J. Van Ackeren Hall was named after Rev. Van Ackeren. In 1964 the Rockhurst Hawks won the N.A.I.A.

basketball championship. Cooperative Education Program was established in 1965. The college became coeducational in all divisions in 1969. The President's Roundtable was also formed. 1973 brought the completion of the physical education and Convocation Center. In 1975, Van Ackeren Gallery of Religious Art opened and the graduate business courses were initiated. The Master of Business Administration degree program was initiated in 1976. The Jesuit residence named Van Ackeren Hall in honor of Father Van Ackeren's 25th year as president.

1979 was the year that the Science in Nursing degree program was approved in conjunction with Research College of Nursing. The School of Management was established to operate alongside the College of Arts and Sciences in 1983. In 1986 the First Endowed academic chairs were established – the Joseph M. Freeman, S.J. Chair of Philosophy and the George and Gladys Miller Chair in Business Administration. The Rockhurst College Continuing Education Center, Inc. was established in 1991.

The only woman president
Rockhurst College has ever known served
from 1997-1998, Janet Watson Sheeran,
Ph.D. (Interim). In 1997 Rockhurst
College opened a new School of Professional
Studies, offering baccalaureate degrees in
organizational leadership, organizational
communication and computer technology.

The 13th and current president of
Rockhurst College is Rev. E. Edward
Kinerk, S.J., '64. Rockhurst College
officially takes on the name of Rockhurst
University on July 1, 1999.





The School of Management at Rockhurst University

The history of the School of Management has not been a long one, however it has been one which has built a strong reputation for excellence all over the Midwest. In the attempt to understand the business history here at Rockhurst College it is vital to start at the beginning so one may form a foundation to build upon.

In 1937 Conway Hall had just finished construction on the Rockhurst College campus. Conway Hall was eventually segmented as the hub of the Division of the Business Administration,

which was organized in 1946. This is the future building where several great business minds have been challenged sometimes failing in their endeavors, but ultimately triumphing in their lives.

Rockhurst College established a Master of Business Administration degree program in 1976 to provide the opportunity for the business minded scholar to further their education. The Masters program at Rockhurst was just a start. In 1978 the Executive Fellows Program began serving the surrounding businesses by

providing up to date education of real world practices for businesses' upper-management teams. This program was a great success from the beginning and continues to be one to this very day.

The success of the Masters Program as well as the Executive Fellows Program established an obvious demand for a separate school of business to be founded at Rockhurst College. This demand was answered in 1983 by the founding of the School of Management.

The School of Management strives everyday to achieve its mission to improve the practice of management by providing

our students with high quality teaching supported by a commitment to improving intellectual development and exchange, and promoting service to the community in a Jesuit tradition.

The School of Management offers several degrees in different functions of the business world. The following paragraphs will discuss those degrees as well as requirements set forth by the School of Management for acceptance.

Rockhurst College's School of Management (SOM) offers a Bachelor of Science in Business Administration in the following fields: Finance/Economics,

Management, and Marketing. The School of Management also offers a Bachelor of Science in Accounting and a Bachelor of Arts in Economics as well as Human Resources/Industrial Relations. The College offers minors in Economics with a Global Perspective or a Managerial Perspective, Human Resources/Industrial Relations, and Management.

In order to declare a major, a student must take these required courses: statistics, economics, and accounting while achieving a 2.5 cumulative G.P.A. Students normally declare their major at the beginning of their junior year.

There are 303 returning students to the SOM with 81 graduating students.







Concentration of Majors in SOM




SOM Year Distribution

Who We Are:
A Portrait of the Sigma Omicron Beta Colony

The precursor of the colony of Sigma Omicron Beta was an illustrious group called the Students of Business. The best part of the Students of Business was simply the name. At Rockhurst University, every other major had more than its own club; they have their own autonomy. The School of Management has an excellent reputation outside of the immediate Rockhurst Community, yet this did not equate to an amicable relationship between science and business majors. In the

eyes of many of our roommates: "You don't have homework-you're just a business major." However, when a biology major faces the Macroeconomics class that every business major is required to take, it becomes a different story. The School of Management needed a common identity.

This is where the Students of Business came in. It evolved from the Accounting Club to something that the entire School of Management could get behind. The Students of Business never

quite took off. The interest and the commitment was just not there. Our core membership was becoming frustrated until we were given a common vision: Delta Sigma Pi.

One of our advisors, Dr. Gail Hoover, invited a Delta Sig representative in to pitch the idea at one of our meetings. There was an interested consensus, but the fire had not yet been lit. In the spring of 1998, the Students of Business officially became the colony of Sigma Omicron Beta (we had to keep some of the original spirit). It seemed that the same fate awaited the new colony-until we started

recruiting. And recruit, we did. Our core membership began talking about Delta Sigma Pi to everyone-classmates, professors, members of the administration. Our advisors pitched it to their classes. Some of us even forced our friends, roommates, and neighbors to come only through our own coercion. Then, in the fall, we aimed for freshmen. We barraged the dorms with an invitation on every door to our next meeting. Luke Mohatt and Jennifer Damico spoke to the Freshmen in Business class in October; the attendance at our next meeting soared.

Not everything that we started progressed as such. Our original fundraiser was the starting of a pizza business. Michael Karr, our esteemed Chancellor and founding father, was the figurehead of the business. The original idea was this: feed the MBA students before their night classes to make a profit, and meet professionals at the same time. However, we ended up losing more money than we earned. Through all of this, enthusiasm was still present, but it was waning.

We did not receive this enthusiasm about Delta Sigma Pi out of thin air. The colonization process really seemed to "click"

after these four members attended the regional conference in St. Louis: Katie Cross, Illori Hunt, November Samnee, and Jack Schulte. The four split up to attack all of the informative seminars that were offered. Jack and November were fortunate enough to attend a fundraising seminar led by the Grand National President Norman Kromberg. He infused us with enough spirit that we brought it back to the colony.

Our first social gatherings were held at Dr. Nugent's house, one of our advisors. He is always the life of any party. In April of 1998, we held a mixer with the faculty on campus so that they






