# History

#### History – Ohio Dominican University



In 1911, the Dominican Sisters of St. Mary of the Springs received a charter from the state of Ohio to establish a women's college. A successful teaching congregation for almost 100 years, these Dominicans wanted to build on the excellence of their Academy and provide college classes in an

area where there was no Catholic higher education available to their graduates and to the candidates for the Order. After a decade of experimenting, the Sisters opened St. Mary of the Springs College in September 1924 as a Catholic four-year liberal arts college for women.

The new college continued the Sisters' tradition of welcoming students of various faiths, ethnic descent, and socio-economic backgrounds. Enhancing the liberal arts tradition, its teacher certification program was approved by the state of Ohio so that by 1929 the college could grant the Bachelor of Science degree in Education as well as the Bachelor of Arts, Bachelor of Science, Bachelor of Music, and Master of Music degrees. That year St. Mary of the Springs College opened both a new academic building and a new residence hall to join its new dining hall. The next year a local paper reported that this new venture in education had only one "hard and fast and definitely tangible regulation...'don't do anything that's going to require that a rule be made against it." In 1934, by its tenth birthday, North Central accreditation attested to the college's success.

Over the years, in order better to meet the needs of students, St. Mary of the Springs College dropped some programs and added others, all the while maintaining its Catholic liberal arts tradition as it included career-oriented preparation. In 1964, the college became coeducational and in 1968 changed its name to Ohio Dominican College. Enrollment greatly increased; new majors and degrees were added. All the while, the college remained true to its Dominican tradition, a tradition developed with the founding of the Dominican Order at the time of the great medieval universities. In July, 2002 the College became Ohio Dominican University and added graduate degrees to its program offerings. Faithful to its primary mission, to provide undergraduate and continuing education for the intellectual development and the growth in truth of each student, Ohio Dominican continues to retain the requirements of philosophy and theology as well as a core humanities program. These requirements give a solid grounding to all the various academic majors and all the rich educational experiences the University has to offer.

The university has nearly 3,000 students from over 13 states and 20 foreign countries and offers undergraduate degrees in 50 majors as well as several graduate degree programs. Ohio Dominican uses a student-centered approach, with a

commitment to quality teaching and learning with a number of academic programs of distinction. Ohio Dominican University is a private Catholic liberal arts university, guided in its educational mission by the Dominican motto, "To contemplate truth and to share with others the fruits of this contemplation."

Ohio Dominican offers a fully accredited, high quality, career-oriented education in a distinctive setting. The University spans 62 beautifully wooded acres. It is a place where diversity is embraced and individualism is celebrated. The Ohio Dominican University liberal arts curriculum teaches skills valuable in every career and life - the ability to think critically, write proficiently, and communicate clearly. The University's nationally acclaimed Humanities program is at the core of every student's academic study at Ohio Dominican.

We forge a new vision for Ohio Dominican based on the foundation of our enduring values.

The University also offers non-credit programs and activities on and off campus to further the lifelong education of the Columbus civic and religious communities.

Immersed in the technical progress, new human insights, and searching questions of the twenty-first century, Ohio Dominican University looks forward to helping individuals and society continue the search for truth in the expanding horizons of an unknown future.

attract student athletes and non-athletes alike, foster alumni participation, and enhance fundraising.




#### **Campus Development**

Under the direction of ODU President Jack Calareso, Ohio Dominican has embarked on an aggressive growth plan, and expects to have approximately 3,700 students enrolled on its main campus by 2007, compared to 1,900 in 2001.

#### **Lead Program**

Ohio Dominican University is visibly different from many adult degree programs. Even more important it is a University that uses its smaller size to its advantage-combining personalized attention and flexibility with a quality education that is recognized and respected by the business community.



#### History - Business Department

Today's business environment is made up of long-established firms; entrepreneurial start-ups and virtual "dot-coms," that reflect a variety of business structures from non-profit organizations to partnerships to publicly traded conglomerates. These entities are led by boards, groups or individuals - some of whom make questionable decisions and others who display exceptional business judgment coupled with sound moral principles. At Ohio Dominican University, business majors are prepared to navigate these uncertain waters, as they are introduced to not only contemporary business practices and knowledge, but also to the values and ethics they will be called upon to exercise in their chosen profession.

Ohio Dominican students who are planning a career in the world of commerce may choose a bachelor's level degree among these majors: Accounting Information Systems, Business Administration, Business Communication - through LEAD Program, Economics, Finance, International Business, and Sports Management.

More than 90% of ODU Business students participate in internship placements in Columbus-based businesses, industries and non-profit organizations as well as government offices.

This variety of majors enables graduates to specialize in chosen fields. Each Business major is based on a strong,

innovative core curriculum that imparts the skills and knowledge needed to develop leadership qualities, professional competencies, technical understanding and communication abilities that create workforce-ready graduates or prepare students to continue studies toward advanced degrees, such as Ohio Dominican's MBA/Master of Arts in Business.

Some ODU students will qualify for our 4+1 program, where they can earn both their Bachelor's Degree and their MBA in 5 years.

Ohio Dominican University offers an opportunity to complete both a bachelor's and a master's degree in five academic years. Students who qualify for our unique 4 + 1 degree program may earn graduate degrees in the following areas:

- Master of Business Administration (MBA)
- MBA with Concentration in Accounting
- Master of Arts (MA) in Liberal Studies

Ohio Dominican's 4 + 1 degree program offers a campus-based, traditional program for students who welcome being challenged. MBA candidates will develop and integrate their knowledge and understanding of contemporary thinking in management and leadership while strengthening their level of functional business knowledge. Liberal Arts candidates will expand their appreciation for and understanding of literary classics, as well as contemporary culture, as they prepare to begin an exciting career or continue their studies towards a doctoral or other advanced professional degree.

As a graduate of an accredited MBA program, students will not only be able to differentiate themselves from other future job applicants, but they will also become familiar with the latest thinking in ethical management and leadership while developing teamwork, critical thinking, problem solving, communication and leadership skills.

Students who enroll in one of ODU's 4 + 1 degree programs will spend four academic years in undergraduate-level study; during their senior year students will take graduate-level courses that will meet their undergraduate elective and graduate program requirements (when a B or better is achieved). At the end of the fourth year, an undergraduate degree is conferred. Students are then enrolled in graduate school full time and complete their degree in one year.



#### 4 + 1 Program Features

- The 4+1 MBA is designed to prepare students for the competitive world of business, as well as developing their critical thinking, writing and leadership skills.
- They 4+1 MBA with a Concentration in Accounting is also designed to prepare students for the competitive business world, but it also gives students the academic requirements necessary to sit for the Certified Public Accountant (CPA) Exam.

 The 4+1 MALS offers students the opportunity to create their own program with a focus in the area of humanities. Students may focus on one or two areas of study such as English and Political Science, or they may choose a more interdisciplinary approach.







In November 2002, the members of Ohio Dominican University's Business department were called together by a group of students who wanted to form a chapter of Delta Sigma Pi on their campus. Paul Nalley and Jim Johnston were in

charge of that group and became the President and Vice-President. Along with Dr. John Grant they went down to Oxford, Ohio to speak with members of the fraternity to see about starting a chapter at Ohio Dominican University.

After finding out what it takes to create this chapter Paul and Jim came back to campus very excited and full of hope for the colony. They held multiple events such as speakers, social gathering, and some community service events. They tried to get others interested, but were not all that successful. Every time they would have people come to an event, they would not show up to meetings or another event. Fundraisers were held and shirts were made but they seemed to only lose money and go deeper in debt. Jim lost interest in the business major and therefore dropped out of leadership in the colony. Paul also began to lose interest in the colony because he was concerned about his schoolwork and finding a job. He would be graduating soon and wanted to concentrate on that. Other members of the group also lost interest but a few faithful ones really wanted to succeed. Katie Sutton and Matt Chilicki

continued to work on the colony but were worn out from all the work and things that had to be done. Then, Dr. Grant heard word from Brandee Norris who was interested in taking over as colony president. Brandee spoke with interested members and those who had worked so hard



previously. The new board was formed and started off again with vigor. They decided that they needed to get a good solid plan together and then perform the needed events and recruit members.

Under the new leadership, the colony began to plan events and take order of the group. Slowly but surely the colony began to have consistent programs and began to pull themselves out of debt. The ODU colony started to become very fortunate in their fundraising efforts despite overcoming a large deficit. Prior leadership had taken this deficit on by buying t-shirts and food for concessions. They tried doing these concessions at home soccer games, but it proved to be unsuccessful. The new leadership team brainstormed ways to raise funds. They did a raffle and other little fundraisers. Then, Scott Sabol informed the colony about working concessions at the Cleveland Brown's football games. This fundraiser deemed to be extremely effective and the colony was able to make up the deficit, pay for the trip to DC, their charter, the charter fee, and still have

money left over to work with. They were still having issues with membership though. The leadership committee could not seem to retain any help. There was

a lot of interest, but the time commitment was too much. Also, people would come to the speakers and social events but no one would show up to meetings and service activities. Brandee was recruiting others like Katy Rensing and Jessica Hawkins to help start this colony off on a new foot. Then, because of personal issues, Katie Sutton had to leave the colony. After this, the team started to recruit new members once again. Next on board came DeAnna Purdie and then our powerful



freshman force, Christina Munoz, Monica Ramey, and Christina Castro. The executive committee was very hopeful that these freshmen would hold the key to their success. These seven girls, Brandee, Katy, Jessica, DeAnna, Christina, Monica, and Christina, as well as Matt would make up the winning combination on the executive committee. They worked very hard to plan fun and informative activities and increase the colony's membership.

Over the past years, Omicron Delta Upsilon has been involved in various community service and professional activities. A few years ago, ODU was involved in a tax internship. People from ODU helped people that didn't know and couldn't afford to get their taxes done. This was strictly a non- profit event/community service project and the students took time each day to run a free of charge tax filing center in the colonial room at ODU. Local residents were able to get help on their income tax returns from the students.

On October 21, 2004 many of ODU students were involved in Operation Smile. Operation Smile was a campus wide activity where students made sock puppets for kids waiting to go into surgery. These students gather in a classroom and made old fashion sock puppets, with socks buttons, markers, googley eyes, and yarn. They then were delivered to the Columbus Children's Hospital to be passed out.

Two days later on October 23, 2004, Ohio Dominican participated in the national Make a Difference Day. Make a Difference Day involved: collecting money for the needy, building a house with Habitat for Humanity, and playing bingo at our mother house on campus. The day was celebrated campus wide and there were multiple events to take part in, so overall we each selected a project and participated across the board. Everyone got to partake in different activities and find new projects for us to work on.

On November 9, 2004, some Ohio Dominican students went into fifth grade class rooms and played stock market games with the children and taught them a little bit about financial responsibility. The kids were able to play with fake money learning how to manage money and how to invest in useful items. The ODU

attendants were extremely happy with the event and hope to continue with this service event year to year making it tradition.

On December 11, 2004, seven people from Ohio Dominican went to the local Ronald McDonald house in Columbus and cleaned. We did everything from sweeping the floors to checking the empty rooms to see if anything was needed. Most of the work was done on the first floors, cleaning the common areas and the two kitchens, plus the bathroom. It was our main focus to get things in a clean, orderly fashion for new guest to start moving in.

On December 11, 2004, those who were unable to attend the Ronald McDonald House cleaning event, made cards to be sent to the local nursing homes. We collected large amounts of card stock in red and green, bought foam holiday cutouts, and created holiday wish cards and envelops. We put them all together and divided the cards up evenly to be delivered to various local nursing homes to bring cheer to those through the holidays that didn't have many visitors.

On January 22, 2005, we went to the Ronald McDonald house and made a taco lunch for the residents of the home at the time. We went to the store and bought all the needed supplies, arrived an hour before lunch time and began preparing all the essentials to having a taco lunch. We also made punch and cookies for dessert. Throughout and after lunch we were able to sit and socialize with the residents. When it was time to leave, some of the residents saw us off, with great thanks for taking the time to spend with them. We also made contact with their office and requested information on any other help they may need. Soon, we will be helping them move into their new house.

Another community service project that we completed was the Lenten Tree. The Lenten Tree is sponsored by campus ministry and Delta Sigma Pi. We all got a gift for a child in need. We made a difference for a child that would not be receiving that much for Christmas. The Lenten Tree was not a huge success, but it was a good deed that we did for the kids in need.

Meanwhile, the colony members also worked on getting the proper finances and much needed membership. Brandee, Katy, and Jessica attended the LEAD school in Buffalo where they spoke with Mark Chiacchiari and Scott Sabol. These two men gave the colony members that additional shove to get them back on the

right track. They also introduced them to the wonderful Suzanne Swire who would be their new District Director and lead them into their charter. With all this encouragement, the members of the colony worked feverously to fulfill the needed requirements. They planned lots of professional activities like:

In November of 2002, Dave Gerhardt came to Ohio Dominican and talked to us about starting your own business. Mr. Gerhardt is the President and owner of

Atria. We learned how important it is to stay focused on your goals and what you really need to accomplish. He also talked about the hiring process and what he looks for when hiring future employees. It was a good turn out and people really enjoyed him speaking, we would like Mr. Gerhardt to come back and speak to us again.

Again in November of 2002, a man named Rich Gross came to Ohio Dominican. The controller of the Columbus Blue Jackets came and talked to ODU students about, "The Business of Owning a Professional Sports Team." It was interesting to see how many people were interested in this topic. It is a very difficult job and costs a lot of money and time. He is very proud of what he does and the audience was very attentive. He has been one of our best speakers on campus and again gave our campus a lot of insight on how things are done in the sports world.

On November 19, 2002, a guess speaker from ENRON came to speak to the ODU community. This was a very informative meeting that dealt with accounting, economics, and criminal acts.

In December 2002, we brought in a guess speaker named Mercedes Moore. Ms. Moore spoke to us about emerging opportunities for Central Ohio in the global economy. Ms. Moore spoke about how to become a manager; she also talked about International Trade, the International Trade Assistance Center in Greater Columbus, and about the Chamber of Commerce. For people that didn't live in Columbus, this became a very informative speech because they were given a chance to learn more about Columbus. Even the residents of Columbus learned more. It was a very informative presentation, and she was a very pleasant lady.

On March 26, 2002, we had another guess speaker at ODU named Mark Kelnhofer. He was an ODU graduate. He came to speak to the ODU community about careers with restaurants and franchising. He is currently working with BDI Inc, which is the BRAVO! Developing Inc.

Also in March, we had another guess speaker. His name was Scott Stevenson. Mr. Stevenson is in the Interior Dunnage Specialties column. He discussed to the ODU community on how to start a small business. This was one of our most superb speakers because he discussed with us the importance of a small business. He also helped us learn how small business entrepreneurs compete in the large corporate world.

In May 2003, the business division at Ohio Dominican held a seminar on International Business and Economics. The attendance was mainly people who attend or work at Ohio Dominican or were former students. Case studies were the first subject that they talked about. They discussed all the opportunities and challenges facing Central Ohio firms and how it is also affected in global

economics. All this was discussed by ODU Cyber Students. The next thing on the agenda was Navigating Risk, Managing Growth and Globalization. This dealt with the study of electronic bill payments. Electronic bill payments was discussed and if it was a good thing and showed the audience how to use it. Dave Gramblis talked about the electronic bill pay and he believed that was a good idea in many ways, but it is taking away from jobs that we currently have. The last speaker was Matija Zitko, she talked about the banking structure, and how banks are set up and ran. Her main talk was about the study of Croatia and how everything there is similar to the United States, but just in a different country. Of course things are going to be different, but there were many similar concepts.

On September 22, 2004, we had a guest speaker named Michael Raia. Mr. Raia came in to speak to us about his company. How he has created his own company of which is based on screening potential employees for companies. There is a series of questions and social interactions that when read into, gives his company the ability to tell another company whether or not the potential employee is applicable for the job. He also covered key things to reference in your resume to catch the employer's eye, and the things of which not to wear or do while on an interview. The students and professors in attendance found Mr. Raia to be a very interesting speaker and have requested that we have Mr. Raia back again soon.

On November 11, 2004, we took a tour of the Anthony-Thomas Candy Factory. We learned that it started out as a deli run by Thomas and Thomas Junior. Then, when Thomas Junior went off to the war the deli began to carry candies and novelty foods like ice creams. Over the years, they slowly converted into a chocolate candy factory. Thomas Junior is still alive and still works there as the CEO, and his three sons are the President, Vice President and Vice President of Production. It was a very good tour and many interesting facts were learned. (We got to sample buckeyes too!)

On December 4, 2004, we took a tour of Delta Sigma Pi's Central Office in Oxford, Ohio. There we learned many interesting facts about how DSP became what it is now, who founded it, and the pink poodle. We got the chance to see the day-to-day operations of central office and a glimpse of what brotherhood is. For those of us that attended, it was a huge eye opener and a push to a passionate drive to complete our petition. 



Guest speaker Mr. Dick Hattwick, from the Business Hall of Fame, came to Ohio Dominican University to speak on business ethics. Dr. John Grant will be taking over for Mr. Hattwick when it gets to Ohio Dominican. We discussed many business owners from around the United States, starting with McHural. McHural is a well known business man; at the time, he was a man that tried to save people money. So, McHural knocked around ideas to cut insurance for farmers because most farmers stayed in the country and worked in the fields all day. They had no reason to have high insurance prices like the city residence. He went to the insurance companies and no on liked his idea to cut prices on insurance for the farmers, so McHural started his own insurance company, this was very popular to farmers at the time, but today, it is a very commonly used company. The insurance company is known as State Farm Insurance. A lot of people were there and listened to Mr. Hattwick's speech, they seemed interested in what he had to say. It was a very interesting speech; we thanked Mr. Hattwick for taking his time to visit Ohio Dominican and sharing his knowledge of business ethics. Mr. Hattwick came to Ohio Dominican on September 13, 2005 to speak to over 30 Ohio Dominican students.

We went to Nationwide Arena in Downtown Columbus to take a tour of the Columbus Blue Jackets stadium. The Columbus Blue Jackets are a professional ice hockey team. We saw the many different aspects of the facility, such as, food services, concessions, facility management, and the arena itself. We also were able to see the employee lounges, and the places that only employees get to go. This was a really exciting trip because we saw what it takes to run a major facility; we also learned that there are more than ice hockey games held at Nationwide Arena. There are concerts, arena football, bull riding, circuses, and the Globetrotters just to name a few. In the next few months, Def Leppard, Elton John, the Globetrotters, Lipizzaner and USA Women's Hockey team will be at Nationwide Arena. This was very nice to know because we can purchase tickets if we would like. We took the tour in October and it was a great learning experience.

Next, we went to the Better Business Bureau in Columbus, Ohio. We learned many interesting facts about the business world in Central Ohio. Only ten colony members were invited to go, and we were able to see some of the big name business presidents and their employees. Peebles Creative Group won the integrity award for people with 1-10 employees in their business. Also winning awards for this was More Time for You, Roush Honda, and the biggest one was Valvoline Instant Oil Change with 175+ workers. For the non-profit category, the American Red Cross of Greater Columbus won. This was interesting because each of these presidents and employees have worked so hard in making their businesses what they are today. The emcee for the day was Yolanda Harris, a news anchor for ABC 6/FOX 28 in Columbus. But the awards were not the biggest part of the day, guest speaker Herman "Art" Taylor was the keynote speaker. He spoke on behalf of the non-profit organizations; he gave statistics on non-profit organizations and telemarketing. He said some good things about the American Red Cross and the efforts to help clean up after Hurricane Katrina. We thought this was going to be a first-class organizational effort, but in the end, he gave the American Red Cross an incomplete. The job is not done yet, the American Red Cross needed about 2 billion dollars to clean up, right now they have raised over 1.3 billion dollars, this is good, but there are still a lot of people on the streets and in shelters in over 25 states. The last issue Art talked about was telemarketing and how people donate cars to get a tax write off. Most of the cars that people donated were not even worth the tax write off that they got. People would take cars that have rust spots and would not even run. They were getting more back in tax returns for these cars that were pretty much useless. The government stepped in and now the problem is less than what it was. Overall, all ten of us had our minds opened to what there is around Columbus and in fact the rest of the world.
