Dear DSP Board of Directors:

It is my great pleasure as colony advisor to recommend the Phi Sigma Upsilon colony to you as a candidate for chartering! I have been associated with them since the beginning of our journey, and I can say without reservation that I am very proud to be associated with this colony. We have a colony of dedicated, enthusiastic, creative, diverse, and hard-working collegians and even some alumni already.

Our Dean, Dr. Danny Arnold, asked our college Student Affairs committee (which includes student representatives) to investigate potential professional fraternities in the Fall 2005 semester. We did that, and after looking at several potentials, the committee chose Deltasig because of its purpose, affiliations, history, and because it is exclusively for business students (and maybe a little because our Dean is a Deltasig alum!). After initial inquiries and receiving advance information from Mr. Dale Clark, Ms. Kim May visited us in November 2005, and that visit confirmed our decision to request colonization. Within 3 weeks after Ms. May's visit, we had a core group of students, elected colony officers and advisor, wrote bylaws, and were recognized by the University as a student organization. In early February 2006, we officially became a colony.

This colony has been an inspiration to me. In a year, they have become a cohesive, cooperative group. Weekly meetings, sponsoring professional and service activities, fundraising, and socializing have turned a disparate set of individuals into a group with a strong bond. In their very first service activity last spring—Relay for Life—they won "Most Spirited Group." Visits from Mr. Mickey Johnson, Mr. Dale Clark, and attending LEAD events have helped the colony feel part of the national organization. They've been enthusiastic from the beginning, but with the petition ready to be filed, they are more than excited and single-minded!

The colony exists to support and promote the study of business via our programs in the college of business. One of my favorite activities they decided to sponsor every semester is a study event during finals week in which faculty are invited and students may come and talk with professors and study together (with

refreshments, of course!). The first event, in December 2006, was very successful and earned praise from all who attended.

The colony leadership has been essential to its success. When the officers were elected in December 2005, I didn't know many of them. Any doubts about them were quickly erased when I saw them in action. They studied Deltasig manuals, they planned, and they led. I tried to be as helpful and supportive as possible, but they mostly just needed me for my master keys and access to the Business Student listserver. They definitely run the colony and are solely responsible for leading it to success in meeting the petitioning requirements. I am very proud of all of the founding members, but especially the officers.

Frostburg State University is large enough to provide opportunities, but small enough that we are still a very personal and friendly place. I don't think the enthusiasm and dedication students have shown for the Deltasig colony will diminish anytime soon. I predict that we will have a chapter that is very active and productive for a long time. They will be an asset to Delta Sigma Pi and to Frostburg State's College of Business.

Can you tell that I love them? Yes, they've added at least two hours of meetings per week to my busy schedule, and many days of activities and events, but it has been a real joy. One of the best aspects for me has been seeing all majors come together and work as a team. We have many discipline-oriented student organizations that are very active, but they focus on one major. The Delta Sigma Pi colony allows us all to work together. I love seeing them be leaders, creating something from nothing, and organizing and managing themselves—applying what they learn in their various business programs. It really is a joy.

So to conclude, I wholeheartedly endorse this colony for recognition as a chapter of Delta Sigma Pi. Being familiar with the stated purpose of Delta Sigma Pi, I think they have not only met the letter of the requirements, but the spirit.


Gentlemen:



## History of Frostburg State University

**1898** The Maryland General Assembly authorized State Normal School #2 and a \$20,000 appropriation for a building. The Governor selected Frostburg as a site because the residents offered the best suitable location without cost to the State. **1898** Townspeople raised the money to buy Beall's Park—a two-acre site—for the State Normal School. **1900** Old Main—the first campus building—was completed. **1902** Fifty-seven students attended the first classes of the State Normal School at Frostburg. We offered a two year program of elementary school teacher training. **1904** Our first commencement. Students received a diploma and a lifetime teaching certificate. **1913** The Model School began operating in its new building. This was our first campus training school which allowed student teachers to work directly with children in the classroom. **1919** We opened our first residence hall. **1930** A sixroom training school for student teachers replaced the 1913 Model School. **1931** Our teacher training program expanded from two to three years, and then from three to four years in 1934. **1935** The institution's name changed to State Teachers' College at Frostburg. The first four-year degree students graduated with Bachelors in Science in Elementary Education. **1946** The college first offered a liberal arts junior college program. This degree was discontinued in 1960 when four year programs replaced it. **1947** We completed our first science building. It was followed by the Garrett Science Building in 1952 and the Tawes Science Hall and Planetarium in 1968. **1949-50** 50th Anniversary Year. **1950-51** The State Legislature funded a 40acre expansion to our campus and 5 new buildings. **1959** The new teacher-training laboratory school was completed and named after State Superintendent of Schools Thomas G. Pullen. It continued operating as an elementary school until 1976. **1960** The Board of Trustees granted Frostburg State Teachers College the right to confer the Bachelor of Arts degree and the Master of Education. **1961** Our first black student (Leon Brumback) graduated. **1963** In July, we became Frostburg State College. **1964-79** We experienced significant growth during these fifteen years. Six residence halls were completed as well as eleven campus buildings including the Chesapeake Dining Hall, Framptom Hall, Fine Arts, Dunkle Hall, Lane Center, the Lewis J. Ort Library, the Physical Education Center, Hitchins Administration Building, and the Stangle Service Building. **1971** The Master of Science in Management Degree was first offered. This degree was replaced by the MBA in 1989. **1975** The Appalachian Environmental Laboratory—part of the Center for Environmental and Estuarine Studies of the University System of Maryland—opened on our campus. **1986** The Nelson P. Guild Center was completed to house the Social Sciences and Business programs. **1987** In July, our institution was granted University status. **1988** We joined the University System of Maryland which is comprised of 11 of the State's 4-year institutions and two research institutions. The Center in Hagerstown opened. **1989** The first FSU Medallion was presented to Lewis J. Ort. Our second recipient was Governor William Donald Schaefer in 1990 and Gerald Arpino in 1994. **1990** The Frederick MBA program opened. **1991** Dr. Catherine Gira became the second woman president of our institution. Lillian C. Compton served as president from 1945-55. **1994** The Performing Arts Center was completed. On April 24, The Joffrey Ballet performed in the new Center in celebration of its debut on our campus 37 years ago. **1995** Bell Atlantic distance education classrooms were installed at Frostburg and the Hagerstown Center. **1998** The University celebrates its Centennial with a year-long series of events. **1999** The Center for Environmental Science's new Appalachian Laboratory building opens. **2000** FSU was the first-ever recipient of the Corporation for National Service's Higher Education Award for Leadership in National Service. **2001** Groundbreaking for Allegany Business Center at FSU. FSU moves from Tier 3 to Tier 2 in U.S. News and World Report's ranking of colleges and universities. **2002** Gunter Hall renovated and reopens. **2003** Compton Science Center and Edgewood Commons apartment complex open. **2005** FSU offers programs at the new University System of Maryland at Hagerstown. **2006** Dr. Jonathan C. Gibraltar becomes the 14th president of Frostburg State University.

## The campus

Our classroom buildings include Compton, Dunkle, Fine Arts, Framptom, Gunter, Lowndes, Old Main, Pullen, Tawes and the Guild Human Resources Center. Students also attend classes in the Performing Arts Center and the Cordts Physical Education Center.

Thirty-four percent of our students live on campus in eleven residence halls: Allen, Annapolis, Cambridge, Cumberland, Diehl, Frederick, Frost, Gray, Simpson, Sowers, and Westminster. Edgewood Commons, a privately owned apartment-style complex on campus opened in fall 2003.

Executive offices are located in the Hitchins Administration Building. Pullen and Sand Spring Halls house most student services offices. In Pullen, you will find Admissions and Financial Aid, the Registrar, University and Student Billing, Graduate Admissions and Services, Programs for Academic Support and Studies (P.A.S.S.), Disability Support Services and Student Support Services. Sand Spring Hall is home to Counseling and Psychological Services, Career Services, the Career Resource Center, Veterans' Affairs, Upward Bound and the Regional Math/Science Center.

## **Introduction**

Frostburg State University has been offering business programs since the 1970s. The College of Business (FSUBusiness) was created as a separate organizational unit in 1987 when FSU attained university status. FSUBusiness offers three majors at the baccalaureate level, as well as a Master of Business Administration at the graduate level. The college contains four departments: Accounting, Economics, Finance & Marketing, and Management. The undergraduate majors offered include Accounting, Business Administration, and Economics.

During the 2006-07 academic year, FSUBusiness has approximately 658 undergraduate students and 126 graduate students. The college also had 43 full-time faculty, 2 full-time administrators, 6.5 full-time staff members, 24 student workers, and 8 graduate assistants. Most of the undergraduates are full-time students; most of the MBA students attend on a part-time basis in evening classes.

The College has had very stable leadership with Dr. Steven Wilkinson serving as Dean from 1987 - 2001. Ms Connie Groer served as Interim Dean from 2001 – 2003. Our current Dean, Dr. Danny Arnold, arrived in 2003, and is a Deltsig alum.

The programs FSUBusiness offers are accredited by AACSB International, the premier accrediting agency for business schools. This accreditation affirms that FSUBusiness demonstrates a distinguished level of performance in its graduate and undergraduate programs.
