



To whom it may concern,

I am writing with enthusiasm to support the establishment of a Delta Sigma Pi chapter at Stony Brook University. I have served as faculty advisor of the Stony Brook colony for a total of two semesters, including the current semester. During this time I have seen tremendous growth and progress from this colony and they are petitioning to transition from colony to chapter with vigor and enthusiasm. The Stony Brook colony has strong, motivated leadership, a large group of dedicated pledges, and the support of the College of Business. This is a group of students who will represent the College of Business, Stony Brook University, and Delta Sigma Pi in an exemplary fashion.

There are three areas in particular in which the Stony Brook colony has excelled and in which their achievements have been notable enough to warrant my recommendation for this petition. These areas are leadership, recruitment, and sustaining success.

First, in terms of leadership, the Stony Brook colony is being represented now by the strongest leaders that I have witnessed during my involvement. Granted, I have only been personally involved with the Stony Brook colony for two semesters, so my experience is limited. But the Stony Brook colony has been present on campus for longer than my affiliation and they have not to this point been able to petition for a chapter. Thus, simply getting to this point is testament to the strength of the current leaders. Their leadership skills are evident in their abilities to organize and run weekly meetings, to communicate consistently with me, each other, and with the general body, and to take directive action to implement their ideas. For example, this semester alone the board has organized attendance to multiple National Fraternity events, including the Empire Region Back to School picnic in New York City and the upcoming LEAD conference in Syracuse, New York. In prior semesters these kinds of events would have been acknowledged as good ideas and intentions would have been made to attend. But plans would inevitably slip through the cracks. This semester things have been different; the leaders are actually following through and putting their money where their mouth is. Compared to previous semesters' leaders, this board talks the talk and walks the walk and they deserve recognition for their leadership skills.

Second, in terms of recruitment, the Stony Brook colony has seen tremendous growth this semester. In prior semesters, finding at least 25 interested brothers was the perennial setback. This semester, whether it be because of strong leadership, increased energy among the colony members, or increased buzz around campus, the current colony has been able to recruit 25 members plus some. At last count, I believe their roster was up to around 40 students. And during recruitment events the colony was



entertaining the interests of close to 60 or 70 students. Their success at recruiting has been simply remarkable.


Finally, the current colony has prioritized preparing for transitions and ensuring continued success. By this I mean that the current colony intends for a chapter at Stony Brook University to sustain prolonged success and stamina which requires, among other things, transmitting acquired wisdom and materials from current leaders to incoming leaders. The onus is on the current leaders to pass down their lessons to future colony or chapter members so as to maintain an active campus presence and a successful, mutually beneficial relationship with the National Fraternity. The Stony Brook colony has struggled with this in the past but the current crop of brothers is committed to preventing these setbacks in the future. For example, this semester alone we have had to deal with difficulties accessing bank accounts, membership records from previous semesters, and meeting notes. In retrieving this information, often at great expense, the current leaders have thought carefully about how to plan for the future. Mechanisms are being put in place now to ensure that this chapter maintains a successful organization throughout difficult transitions. It is clear the current crop of leaders does not intend to build a chapter only to see it fail in the future and if their petition is approved, I have no doubt that these brothers will continue to succeed at Stony Brook for years to come.

I hope that it is evident from my comments that the petition submitted by the Stony Brook colony deserves careful consideration. They have created an exciting, compelling, and visible colony on campus and their petition for a nationally recognized chapter is strong. I give my wholehearted recommendation, and I am proud to serve as faculty advisor.

The History of Stony Brook University

Stony Brook University is one of America's most dynamic public universities, a center of academic excellence and an internationally recognized research institution that is changing the world. After less than 60 years of existence, it's ranked among the top 100 universities in the nation.

Stony Brook University was established in 1957 as a college for the preparation of secondary school teachers of mathematics and science. The first campus was located in Oyster Bay, Long Island, on the grounds of a former Gold Coast estate. In 1962, a new campus was built near the historic village of Stony Brook on land donated by local philanthropist Ward Melville. Part of the State University of New York system, the University has grown tremendously and is now recognized as one of the nation's important centers of learning and scholarship — carrying out the mandate given by the State Board of Regents in 1960 to become a university that would "stand with the finest in the country." The University campus lies about 60 miles east of Manhattan and 60 miles west of Montauk Point. It is only a short distance to the Atlantic beaches of the south shore and the vineyards of the East End. Situated on 1,039 acres on the north shore of Long Island, Stony Brook University is a four-season climate, tempered by proximity to the Atlantic Ocean and Long Island Sound.

Stony Brook University currently enrolls 15,858 full-time undergraduates, 1,168 part-time undergraduates, 5,419 full-time graduate students and 3,289 part-time graduate students (2015-2016). About 47% of the students enrolled at Stony Brook university are drawn from the Suffolk and Nassau counties in Long Island; 22% from New York City.

The History of the College of Business

As a business school at a flagship public research university, we offer our students, faculty, and members of the business community interdisciplinary resources. The College's research and teaching draws upon the sciences, mathematics, engineering, medicine, liberal arts, and fine arts to stimulate opportunities for technological innovation and economic development.

In just 10 years, the Stony Brook University College of Business has enjoyed enormous growth in faculty, research, and academic programs. Our faculty is now made up of 47 full time professors and affiliates, including 39 College of Business faculty and 8 members with joint or affiliate appointments, from such departments as Applied Mathematics, Economics, and Political Science. Our faculty falls within the research areas of Accounting, Finance, Management (Organizational Behavior and Operations Research/Decision Analytics), and Marketing & Strategy.

Our faculty involves both undergraduate and graduate students in their research, as well as provides students with experiential learning opportunities, including case studies, client projects and internships, with the ultimate goal of preparing students as leaders in their field of choice. Dr. Barragato currently serves as an outside reviewer for Voluntas, and also provides commentary on tax and accounting issues to *The Journal of Taxation, The Wall Street Journal, The Long Island Business News, The Trusted Professional* and *TheStreet.com.* He was awarded the NYSSCPA's coveted "Dr. Emanuel Saxe Outstanding CPA in Education Award" and LIU-Post "David Newton Award" for excellence in teaching.

SANDRO BRUSCO


Professor, Economics 1993, PhD, Economic Analysis and Policy, Stanford University 1986, Discipline Economiche e Sociali, Università Bocconi

He is a referee for dozens of economic journals and received the Excellence in Refereeing Award, American Economic Review, 2007—2008. He is a reviewer for the National Science Foundation (USA), the Agencia Nacional de Evaluación de Proyectos (Spain) and the Social Sciences and Humanities Research Council (Canada). He has most recently been published in Bulletin of Economic Research, Social Choice and Welfare, and Games and Economic Behavior.

Visiting Professor, Finance PhD, 2009, Mathematical Finance, University of Karlsruhe 1972, Telecomunications IENGF, National





Dr. Focardi is a co-founder if CINEF, a multidisciplinary research center in Econophysics at the University of Genoa, and of the consulting firm The Intertek Group (Paris). His research interests include the study of factor models of equity prices, explaining and predicting market trends, trend reversals and market crashes, economic models with multiple inflation rates, and financial economics with artificial markets. The underlying theme of his research agenda is economics as a complex system with multiple interacting agents. An engineer by training, Sergio started his career in scientific computing, where he most recently held the position of Managing Director of the Italian subsidiary of the supercomputer firm Control Data.

ROBERT J. FREY

Research Professor, Finance PhD, 1986, Applied Mathematics and Statistics, Stony Brook University



Dr. Frey worked in an array of operations research related managerial positions before earning his PhD as a part-time student in 1986. He then became involved in designing mathematically based financial trading systems, first at Morgan Stanley, then at Kepler Associates, and finally at Renaissance Technologies, from which he retired at the rank of Managing Director in 2004. Among his many current activities, he chairs the advisory committee of the University of Chicago Financial Mathematics program (the country's top ranked quantitative finance program), is co-owner of a small investment bank in London, and heads a construction company. Frey just launched his own hedge fund, Frey Quantitative Strategies, with initial capital of \$365 million.

DMYTRO HOLOD

Associate Dean; Associate Professor, Finance PhD, 2005, Economics, University of Kentucky MA, 2000, Economics, National University of Kyiv-Mohyla Academy



Dr. Holod received his PhD from the University of Kentucky in 2005. His research interests include corporate finance, financial intermediation, and economic growth. Dr. Holod has presented his research at numerous academic and practitioner conferences, and his work has been published in finance and economics journals, including the *Journal of Money, Credit and Banking, the Journal of Banking and Finance*, and *Financial Management*. Dr. Holod also holds the position of Associate Dean in the College of Business.

Assistant Professor, Finance PhD, 2005, Mathematics, Sogang University



Colony is planning on actively recruiting second semester freshmen during the Spring 2017 semester.




Delta Sigma Pi Stony Brook Colony Membership Statistics

Peter Caprariello, PhD


