



GRAND CHAPTER ACTIONS

The Grand Chapter adopted the following legislative amendments during the 56th Grand Chapter Congress. Updated bylaws are available online at dsp.org/bylaws.

- Article III, Section 6 was added to create language within Bylaws regarding a resolution of the Grand Chapter.
- Article V, Section 3 was amended to remove the reference of the Vice President-Finance as the Chief Finance Officer of the Fraternity.
- Article IV, Section 3 was amended to extend full rights of a Director to the immediate Past Grand President (PGP), specifically allowing them to vote on all motions.
- Article II, Section 10 and Article IV, Sections 2, 4 and 5
 were amended to change
 the Executive Director
 from a non-voting Board
 member to a required invited guest participant of
 each Board Meeting.
- Article V, Section 2 and Article VI were amended to reorganize the national committee structure to allow for better oversight, clearer expectation, and greater efficiency.
- Article XVIII, Section 2 and 3 were amended to create a path for the Grand Chapter to take a stance, through mail vote or Grand Chapter Congress, on policy legislation adopted by a Provincial Council.

Additional bylaws amendments were not adopted:

- Preventing Regional Vice Presidents and Board Members from serving as any chapter's delegate or alternate at Grand Chapter or Provincial Council meetings
- Extending the Collegian of the Year term length to three years
- Removing Board responsibilities from the Provincial Vice President role and creating a new Provincial Director role to instead serve on the Board of Directors
- Creating a Grand President Elect role on the Board of Directors
- Improving clarity of role for District Directors to meet the current usage and limiting an individual to serve as District Director for a maximum of two chapters at a time
- Revising the process for granting charters so the Board will vote to authorize a charter on a campus prior to executing the startup group process. The traditional startup group and petitioning process remains but taking place following the Board vote

Ritual proposals adding additional pauses and phonetic instructions to the Initiation Ritual, adding roles to assist the Head Master execute the Pledging Ceremony, adding language as to how the room should be set up for every ceremony, adding instructional wording for chapters to arrange their pledges by alphabetical order, and updating Ritual to place and clasp the badge before describing it were also not adopted by the Grand Chapter.





- Onsite community service activities helped support the local community and our national initiative, literacy. Participation led to the donation of:
 - Nearly 400 Grace 2 Go Bags to the Coachella Valley Rescue Mission for those experiencing housing issues
 - 300 bookmarks to Anythink Libraries in Colorado to get children excited about reading
- The National Community Service
 Committee also promoted literacy
 through a Book Swap where participants
 were able to swap books with attendees
 from across the country.
- The Grand Chapter Congress Banquet, a formal affair emceed by Nichelle Dawkins, *Drake (IA)*. The event included a Golden Helmet presentation to Laurie Gail Senko, *Arizona State*, the first female to receive this recognition (see page 42), and the 2025 Lifetime Achievement award to John Watton, *Florida Atlantic*. The banquet ended with the tradition of singing the "Rose of Deltasig" led by Chet Andrews, *Louisiana State*, and the rest of the night was one party of music and dancing!

Much business was also conducted during this meeting of the Grand Chapter. PGP Bill Kinsella served as Chancellor,

The heartbeat of Delta Sigma Pi Fraternity and Leadership Foundation is a commitment to developing principled leaders. This past year, we made great strides in achieving this commitment through increased engagement, education efforts, chapter support, infrastructure developments, leadership development, financial efforts and more.

Your generosity turned commitment into action — making 2024-25 an impactful year for both the Fraternity and Leadership Foundation. The Leadership Foundation received more than 1.2 million dollars in contributions this year, and these funds supported three vital areas: Fraternity grants (see page 14), **Chapter Leadership Funds (see** page 16), and scholarships (see page 15). Also in 2024-25, more than 27,000 alumni members (see page 18) engaged with Delta Sigma Pi in some way—and over half were for the first time ever. Another first was the introduction of LEAD Summits (see page 14),

which helped bring leadership development closer to members with more targeted and affordable educational initiatives.

Thanks to support from the Deltasig Fund, we delivered excellent leadership programming to more than 2,000 members (see page 20), upgraded chapter resources, and more. To round out the year, Delta Sigma Pi then won the 2025 Outstanding Organizational Impact Award (see page 16) from the Professional Fraternity Association for updating current programs to be more effective and make a meaningful





Collaborating to Develop Stronger Leaders

Delta Sigma Pi and the Leadership Foundation work hand in hand to deliver on one promise: to make membership more valuable at every stage of life. Through the Leadership Foundation's financial support, Delta Sigma Pi can provide programs that help members become stronger leaders, more effective professionals, and more engaged citizens. Every time a member learns, leads, or earns support through one of our programs, it's in part because of the generosity of our donors.

Your Impact at Work

In the 2024–2025 fiscal year, the Leadership Foundation granted \$245,000 directly to the Fraternity—funds that powered our most impactful educational experiences, including LEAD, Presidents' Academy, and Leadership Academy. These programs aren't just events; they are launchpads for our members' success—helping them build confidence, communication, and leadership skills that carry into their careers and communities.

Leadership Academy: Building Tomorrow's Leaders Today

The first-ever **Leadership Academy** in August 2024 focused on preparing the next generation of Deltasig volunteer leaders—those most likely to guide our chapters and the Fraternity forward. By investing in these

future leaders now (using grants to fully pay for registration fees and lodging during the event), donors are ensuring that chapters continue to thrive under strong, principled guidance for years to come. The event was a resounding success with ninety-one percent of attendees agreeing that the event developed their leadership skills. Other notable stats include:



Building Stronger Leaders, Together

Delta Sigma Pi Fraternity attracts a diverse community of students, alumni, and leaders by offering leadership training, education, networking, and support to members. The Leadership Foundation fuels this growth by providing financial grants to the Fraternity and chapters to make these programs possible—turning donor generosity into improved leadership development, chapter health, and member success.

Making Leadership Experiences Accessible In 2024–25, donors contributed over \$190,000 to Chapter Leadership Funds (CLFs), supporting grants to chapters in excess of \$188,000. These gifts offset travel, lodging, and registration costs, allowing hundreds of students to attend LEAD events and Grand Chapter Congress, as well as professional programming on and off campus.

Strengthening Member Education and Retention

Supported by past Leadership Foundation grants, Delta Sigma Pi was able to provide training, materials, and staff time to update the Pledge Education Program and Individual Discipline Policy in 2019, creating a more inclusive, engaging member experience. These changes helped the Fraternity continue to retain over 95% of pledges through initiation since 2020—earning the

Helping Chapters Thrive

Leadership Foundation grants (\$60,000 worth) also help fund the Educational and Leadership Consultant program, which gives chapters tailored support to reach their goals. The operating and leadership support lead to recognition of 106 chapters in 2024–25—a sign of stronger, healthier operations nationwide.

The updated Chapter
Management Program with new
Chapter Health Indicator launched
in August to better assist chapters
in knowing and playing into their
strengths. This updated model replaced a traditional checklist system
with a real-time "health indicator"
approach—offering a clearer picture

of chapter operations and allows the Fraternity to provide targeted help when it's most impactful.



The Fraternity and Leadership Foundation work together to keep members connected for life. Through Leadership Foundation grants and donor support, we're creating meaningful ways for members to engage at every stage—whether through alumni chapters, professional development, or digital communities. Each gift ensures Delta Sigma Pi remains a source of connection, leadership, and pride long after graduation.

Strengthening the Deltasig Network

Lifelong member engagement means more than staying in touch—it's about fostering ongoing relationships, shared purpose, and personal growth. With support from the Leadership Foundation, Delta Sigma Pi expanded programs and communication strategies to better understand what motivates members to participate and how to align activities with their evolving interests.



In 2024–25, more than **27,000 alumni members** engaged with Delta Sigma Pi—over **half for the first time**. Foundation-supported outreach initiatives helped us welcome these members back into the Deltasig community and remind them that the bond of brotherhood extends well beyond college.

At the recent Grand Chapter Congress, Delta Sigma Pi also restructured the national **committee structure** to provide more accessible and meaningful ways for members to contribute their expertise and passion. This new structure opens the door for alumni and collegiate members alike to serve on work groups, advisory panels, and task forces that shape the Fraternity's direction, strengthen operations, and expand our impact. Whether offering professional insight, adding value to the Deltasig experience, or helping guide strategic initiatives, volunteers are playing a growing role in advancing the Deltasig mission.

Building Alumni Connections

Through the Leadership Foundation's ongoing investment, the Fraternity continues to expand opportunities for alumni to connect locally and nationally. In 2025, we proudly recognized **54 franchised alumni chapters**, including new additions in Achieve More Corporate,

Today's members connect in many ways—on campus, in the workplace, and online—and our reach and impact continue to grow. In 2024–25, Delta Sigma Pi's enhanced digital engagement strategy resulted in:

- **3.6 million impressions** (a 66% increase from 2023–24)
- A reach of nearly 5 million
- 6,700 new followers (an 18% increase)
- Over **3.3 million emails sent** with a more than **64% open rate**, outperforming industry averages for business, nonprofit, and education organizations by more than 10%.

These efforts keep members informed, inspired, and connected to the mission of Delta Sigma Pi.

Leading with Vision

Organizational excellence begins with strong leadership. This year, both the Fraternity and Leadership Foundation Boards invested in **joint leadership development** to ensure alignment and strategic focus at the highest levels. Combined Board training, held in September, strengthened collaboration, improved governance practices, and created a shared vision for advancing the Fraternity and Foundation together. These investments in leadership directly enhance decision-making and stewardship—ensuring donor dollars and member fees are used more efficiently and effectively.

Strengthening Financial Foundations

To sustain our Purpose, we continue to grow diverse sources of support beyond dues and fees. This year, we welcomed **four** new companies to our list of corpo-



rate partners, funding leadership education, professional

development, and networking events for members across the country. Additional event sponsorships and merchandising partnerships are being explored to further expand this vital support.

The Deltasig Fund: Fueling Growth and Flexibility

The **Deltasig Fund**, for unrestricted annual giving, ensures the Foundation can respond to emerging needs and sustain vital programs. Unrestricted giving helped fund educational grants, technology enhancements, and training that directly benefit members and chapters.

Impact: Support from the Deltasig Fund made it possible to deliver leadership programming to more than 2,000 members, upgrade chapter officer resources, and launch tools that help members lead with confidence. Every donor to the Deltasig Fund keeps Delta Sigma Pi strong, adaptable, and ready to meet the evolving needs of our brotherhood.

Investing in Technology for the Future

A major milestone this year was the launch of the updated version of the Fraternity database—the Hub—introduced to collegiate chapters and national officers in August. The Hub is transforming how members interact with the Fraternity.

Chapter officers now spend less time on administrative reporting and more time creating value for their members. The mobile-friendly system centralizes essential resources, streamlines communication, and provides a modern platform for future innovations that will serve generations of Deltasigs.

The BASE Fund: Powering Foundation Operations

Behind every successful program is a strong operational backbone. The BASE Fund helps offset the Foundation's operating costs so more resources can go directly to grants and scholarships supporting leadership education and membership support. This year, more than \$50,000 was allocated from the BASE Fund to strengthen core operations—ensuring the Foundation can continue expanding programs and grants. The BASE Fund now stands at more than \$1 million, a remarkable milestone achieved through the generosity of members who believe in the Foundation's mission. Gifts of all sizes are appreciated in support of the BASE Fund with nearly 50 donors supporting the BASE Fund since its 2019 inception. Donors making more significant BASE Fund contributions are recognized through the BASE society.



Yesterday's Decisions Support Today's Impact

In 2025, Delta Sigma Pi Fraternity celebrates 118 years of being a meaningful part of the leadership development experience. While there have been years of prosperity and years of struggle, the cumulative strong financial base in which the Fraternity operates today creates opportunities and perpetuates future stability. In the 2025 fiscal year, the Fraternity benefited from more than \$400,000 in revenue from investment returns, similarly, nearly \$44,000 of the Leadership Foundation's Fraternity grant, and the more than \$175,000 in academic scholarships and chapter grants (non-CLF) awarded dollars were paid through endowments that create additional benefits in perpetuity. These funds, left to us by forward-thinking Deltasigs, help fund today, and create tomorrow's dreams.

The 50 Year Initiation Anniversary of Women:

Where Tt All Began

(with references from previous The Deltasig magazines) When Delta Sigma Pi was founded in 1907, the idea of a woman in college—let alone a business fraternity—was nearly unheard of. And yet, from the very beginning, women were there. They may not have been official members (yet), but they were part of the story.

ives and girlfriends attended social events, wore their husbands' pins, and traveled to Grand Chapter Congress. Some chapters held social dances and voted for their "Rose," a favorite female guest of the chapter. Some had "Little Sister" socials and professional programs for women. In 1949, Alice Wright (wife of Past Grand President and then Executive Director Gig Wright) suggested these women attending GCC create their own group called the "Pink Poodles" for the wives attending the conference with their husbands. For each GCC they met and planned their own group activities, social programming, and a meeting with elections.

But times were changing. By the 1940s, women made up a growing portion of the U.S. workforce. By the 1960s, they were entering business programs in record numbers—and they wanted the same professional opportunities and recognition that Delta Sigma Pi provided. The country was facing a tidal wave of changing values with the Equal Pay Act of 1963 (which prohibited wage discrimination based on sex) and the Civil Rights Act of 1964 (outlawed discrimination based on race, religion, sex, or national origin in various settings). During this time, student organizations, such as fraternities, were facing criticism of inequality and conformity. These changes would set the stage what came in the 1970s.

By the start of the 1970s, the Vietnam War was throwing college





campuses into turmoil, and membership levels began to decline, with only nine new chapters installed during that time. In addition, looming ahead was the controversial issue of inclusive membership, brought to the forefront by Title IX of the Federal

Higher Education Act. Title IX was adopted in 1972 and denied federal funding support to institutions that allowed organizations with restricted membership to operate on campuses. At the 29th Grand Chapter Congress in 1973, a constitutional amendment to open Delta Sigma Pi membership to women was overwhelmingly defeated by a vote of 21 in favor, 79 opposed.



To remain eligible for federal funding, some colleges restricted access to campus facilities and resources for all-male organizations unless they admitted women, and a few chapters reported the impact of these Title IX-related changes on their campuses in the May 1974 issue of *The Deltasig* magazine. "[We face] potential closure by the university following a Student Senate ruling requiring the chapter to admit women as members or risk losing its campus recognition."

At the 30th Congress in 1975, Gamma Iota Chapter at New Mexico, which had closed the prior spring for alleged sex discrimination in admission practice, presented a resolution to the Grand Chapter directing the Board to take immediate action. Though that motion failed, it sparked something.

During that Congress, the Board of Directors met and decided to send a mail vote to question eliminating the word "male" in the Constitution, Bylaws, and Ritual. After the announcement by then-Grand President Harold Cannon, a straw vote indicated there would not be a sufficient majority to suspend the Constitution to consider sex discrimination on the floor of the convention. However, there were enough votes to pass a resolution to request the Board to invoke emergency powers and temporarily suspend the Constitution and Bylaws for the chapters threatened by closure until the mail vote occurred.

In the fall, a mail vote on this issue narrowly failed to pass. Then-Grand President Bill Tatum (who was elected at the 1975 GCC) convened a conference call on November 7, 1975, and the Board of Directors unanimously voted to open membership of Delta Sigma Pi to women. Initiations of women started soon after. As any decision made with emergency powers, it was only temporary, until the 31st Grand Chapter Congress in Toronto

Bill Tatum sums up this time by writing, "Few are willing to brave the disapproval of their brothers. Moral courage is a rarer commodity than bravery in battle, yet it is the one essential, vital, quality for those

who seek change in the fraternal system that yields most painfully to change...we will be remembered as the generation that had cast upon it the greatest burden of responsibility to date and dealt with it effectively" in January 1976.

At the 1977 Congress, the action was ratified, and co-educational membership was final. After GCC, only a few chapters refused to initiate women (often with pressure from their alumni), and they would hold out for many years. Eventually, they were told to open membership to women, or their charters would be revoked.

Amid this decision in Deltasig history, members became questioning the limitations of the honored term of "brother" bestowed on all initiated members of the Fraternity. Historically, using the word brother when referring to someone within a Fraternity comes from the Latin word "frater," meaning "brother." A Fraternity is a brotherhood, and therefore all members are considered brothers to each other. This term caused some discourse with the introduction of women initiates into Delta Sigma Pi.

At the 1977 Congress, Gamma Omega Chapter Delegate Jan Garland Kasun (first female president of Gamma Omega Chapter) and Laurie Gail Senko, also Arizona State, (see page 42 to read more about Laurie, the first woman to receive her Golden Helmet) paved the way with how women would be referred to in the organization. They created a straw vote and surveyed all the female attendees at Congress on what they preferred to be called (brothers, members, etc.); then Jan addressed the delegates to report their findings and make a passing motion that all members remain brothers. "It was amazing to be there and participate in history being made... Most of us early female brothers did NOT want to change the traditions and Ritual.... To me, the meanings of words are socialized and who is to say that the word 'brother' must denote a gender? To me, it means a brotherhood and common familial bond," said Laurie.

On November 7, 1975, Delta Sigma Pi was forever and monumentally changed, and 50 years later we honor this anniversary. As we celebrate 50 years since women have been initiated in the Fraternity, it is important to remember where we started... and how far we've come.
