### Dues –

Per term (fall and spring) Dues are required for any member (initiated or affiliated) enrolled in a qualified program. Whether a student is full-time or part-time, dues are required. The number of credit hours is not a factor.

**Semester** schools are billed dues at the beginning of the fall and spring semesters. **Quarter** schools are billed dues at the beginning of the fall and spring quarters only (not the winter quarter).

<b>Presidents' Academy Registration Fee –</b>	Per Year – <i>invoiced in two equal installments of \$200.00 each on September 15 and February 1. Chapters will owe registration regardless of sending a representative to the conference.</i>	\$400.00
<b>Chapter Liability Insurance &amp; Member Accident Protection Program</b>	<i>charged twice annually (fall and spring) based on an estimate of the total cost of insurance, including administration anticipated for the year</i>

<b>Interest –</b>	On balances over 30 days old	12% annually

<b>Alumni Chapter Franchise Fee –</b>	<i>must be paid as part of franchising requirements between April 1 and June 30 each year for the upcoming fiscal year</i>	\$33.00
<b>Alumni Chapter Charter Renewal Fee</b>	<i>must be paid if franchising for an alumni chapter has lapsed</i>	\$33.00
<b>Alumni Chapter Insurance Premium–</b>	<i>all alumni chapters (except for approved foreign alumni chapters) receive an invoice for liability insurance upon annual franchise renewal.</i>	\$70.00
